# Biden, Trump set up election rematch after clinching nominations

AP, WASHINGTON: President Joe Biden and former President Donald Trump clinched their parties' presidential nominations Tuesday with decisive victories in a slate of low-profile primaries, setting up a general election rematch that many voters do not want.

The outcome of contests across Georgia, Mississippi and Washington State was never in doubt. Neither Biden, a Democrat, nor Trump, a Republican, faced major opposition. But the magnitude of their wins gave each man the delegate majority he needed to claim his party's nomination at the summertime national conventions.

halfway Not even through the presidential primary calendar, Tuesday marked a crystalising moment for a nation uneasy with its choices in 2024.

There is no longer any doubt that the fall elec-



tion will feature a rematch between two flawed and unpopular presidents. At 81, Biden is already the oldest president in U.S. history, while the 77-yearold Trump is facing decades in prison as a defendant in four criminal cases. Their rematch — the first featuring two U.S. presidents since 1912 — will almost certainly deepen the nation's searing political and cultural divides over the eight-month grind that lies ahead.

In a statement, Biden celebrated the nomination while

casting Trump as a serious threat to democracy.

Trump, Biden said, "is running a campaign of resentment, revenge, and retribution that threatens the very idea of America."

He continued, "I am honoured that the broad coalition of voters representing the rich diversity of the Democratic Party across the country have put their faith in me once again to lead our party — and our country — in a moment when the threat Trump poses is greater than ever."

State Bank of India (SBI) on Wednesday told the Supreme Court that a total of 22,217 electoral bonds were purchased by donors between April 1, 2019 and February 15 this year, out of which 22,030 were redeemed by political parties.

In a compliance affidavit filed in the apex court, the SBI said as per the court's direction, it has made available the details of electoral bonds to the Election Commission of India before the close of business hours on March 12. It said details, includ-

ing date of purchase of each electoral bonds, names of the purchaser and the denomination of the bonds purchased

The affidavit, filed by SBI's chairman Dinesh Kumar Khara, said the bank has also furnished to the EC details like date of encashment of the electoral bonds, the names of political parties which received the contributions and the denominations of the bonds.

"A total number of 22,217 bonds were purchased during the period April 1, 2019 till February 15, 2024. At the time of collating the information for the ECI, the details were segregated as below," it said.

The affidavit said between April 1, 2019 to April 11, 2019 a total of 3,346 electoral bonds were purchased and 1,609 redeemed.
