Sources have revealed that a meeting to discuss and formulate a plan to address the issue of migrants and beggars occupying footpaths has not been convened for several months. This delay is concerning, especially since all relevant authorities are expected to contribute to resolving this pressing issue.

Further compounding the issue is the lack of shelter homes, due to which there are no options for the rehabilitation of beggars and vagrants occupying footpaths.

# Unemployment drives 23-yr-old Xeldem local to end life

QUEPEM: The body of Prakalp Gawas Desai, the youth from Xeldem who was reported missing since early Thursday morning, was found floating near the banks of the Zuari River on Friday morning, following a 24-hour search operation. Praklap was 23 years old and is believed to have committed suicide because he was unemployed.

Prakalp had sent a message to his father in the early hours of Thursday, stating his intention to commit suicide, after which the police were informed, and began searching for him. Curchorem PI Vaibhav Naik said that Prakalp was stressed about his future and suffering from depression because he had completed his diploma a few years ago, but had not been able to find a job.

On Thursday morning, his scooter



and mobile phone were found abandoned on the Sanvordem bridge, leading authorities to believe he had jumped into the Zuari River.

Marine police and fire services conducted search operations until midnight, and his body was discovered on Friday, near the ACM jetty.

The body has been sent to the South Goa District Hospital in Margao for a post-mortem examination. PI Vaibhav Naik confirmed that the cause of death was drowning.

🚽 Ponda man hospitalised after assault with wooden planks, two arrested

PONDA: Devendra Chepo Gaonkar, 30, from Davkon, Dharbandora, was attacked by two men who trespassed into his home in the early hours of June 5, causing serious injuries. Collem Police reported that the incident stemmed from a monetary dispute. Police arrested the alleged attackers, Kanta Bethkikar, 41, from Kankire - Guleli, and Mahadev Gaude, 36, from Nanus-Usgao. Both were produced before the Saguem JMFC and remanded to five days in police custody. The injured Devendra Gaonkar, who was beaten with wooden planks, was shifted to Ponda Sub-District Hospital with fractures on his hand and injuries to his legs. According to Collem PSI Vibhavari Gaonkar, the victim and the accused were business associates. Gaonkar had loaned money to the accused and was attacked when he demanded repayment.

The attackers also allegedly stole Gaonkar's gold chain, mobile phone, and Rs 20,000 in cash. Locals suspect the incident may be related to gambling activities in the area and have called for increased police vigilance. The police have booked the offenders under Sections 452, 324, 380, and 504 read with 34 of the IPC.

# **2**Locals rescue accident victims, **2**firemen tackle oil spill at Dramapur

MARGAO: Locals rescued three people trapped in a car following an accident at Dramapur before Fire Services personnel arrived. Margao Station Fire Officer Gil Souza reported that a fire tender was dispatched upon receiving the call. The car sustained minimal damage. In another incident, Margao firefighters cleared an oil spill at Dramapur junction.

### **Z** Mapusa attack: Three more suspects Jarrested, one remains at large

MAPUSA: Three additional suspects have been apprehended by Mapusa police in connection with the brutal assault on two individuals from the Housing Board area. The arrested individuals have been identified as Sharanbasu Gaikawad, 27, Nagraj Pujari, 19, and Viresh Pujari, 38. They had been on the run since the attack occurred on May 30. Following the incident, three other individuals - Shridhar Killedar, Abhishek Pujari, and Manthan Chari were arrested in connection with the crime. However, one suspect, Ramkrishna Bhalekar alias RK,

remains at large.

Vagullem on Mugalli road in Curtorim has prompted citizens to demand immediate action from authorities. This situation has not only resulted in an environmental hazard but also created significant health risks for residents. The issue is further exacerbated by stray cattle and dogs consuming the garbage, leaving it scattered in the locality.

Local resident Peter Fernandes expressed his dismay, stating that the prevailing conditions have tarnished the once-pristine image of the village. "We have been raising this issue on several occasions for the last several years, but concerned authorities failed to

Group of Velim residents booked for trespass, assault of local woman

MARGAO: Cuncolim police have booked four individuals following a complaint from Anita Fernandes, a resident of Combiabhat, Velim, alleging abuse, assault, and threats.

Fernandes reported that the group trespassed onto her property in Velim while she was plucking cashews. She claimed they assaulted her with a stick and slapped her, used abusive language, and threatened her with dire consequences.

Police have registered a case under Sections 447, 324, 504, and 506(ii), read with 34 of the IPC, against Girgolia Fernandes, Max Fernandes, and Joy Fernandes, all residents of Khursabhat, Velim, and Assucena Rebello, a resident of Combiabhat, Velim.

The complainant alleged that Assucena Rebello instigated the others to abuse her. The case is being investigated by PSI Suhas Velip.

The victims, Ahmed Devadi and Sandesh Salkar were assaulted with an iron rod allegedly by a group of four individuals late at night on May 30.

# Colva Traffic Cell cracks down on drunken driving, books 82 offenders in four months

A total of Rs 24,16,500 was collected in fines for Motor Vehicle Act violations in the Colva police jurisdiction from January to April this year

MARGAO: In response to a surge in fatal accidents largely attributed to drunken driving, the Traffic Cell of Colva has booked 82 individuals for driving under the influence in the first four months of this year.

Traffic police reported that the breath analysers provided to them have been instrumental in determining intoxication levels during traffic stops. Salcete has received 10 new breath analysers, enhancing the effectiveness of alcohol concentration tests. Number of Drunken Driving Cases Booked as of April 24: Additionally, during the same period, 318 cases of riding two-wheelers without wearing a helmet were booked. Moreover, 3,785 cases of wrong parking, over speeding,
