

TERRIBLE TUESDAY: Motorcycle pilot crushed under crane at Ponda

A speeding crane ran over Chodankar after its driver lost control; he was dragged along with his bike for 7.5 metres; his head was crushed and was found in a pool of blood

PONDA: In a tragic incident, a motorcycle pilot named Prakash Chodankar (58), resident of Kavalem, operating from KTC Bus stand, was crushed to death as a result of rash and negligent driving by a crane driver on Tuesday morning.

The deceased, a resident of Kavalem-Ponda and native of Kauthani-Sawantwadi, Maharashtra, was sitting on his stationary motorcycle and reading a newspaper when a speeding crane ran over Chodankar after its driver lost control. He was dragged along with bike and dragged for almost seven meters. His head was crushed and was found in a pool of blood.

The horrific incident shocked hundreds of passengers at the KTC Bus

Stand. Following the incident, Ponda police personnel rushed to the site. Shocked locals alleged negligence by the contractor involved in widening on the national highway (NH) work, which was responsible for the pilot's death. Local social workers Vi-

raj Sapre and John Mascarenhas said the NH widening work being undertaken on the highway stretch near KTC Bus stand in a very casual manner, with no proper sign boards regarding the road widening work, nor proper supervision by the contractor.

The accused crane driver Ranjeet Kumar (20), a resident of Bihar, has been arrested by the police and a case has been registered under Section 279, 304-A of IPC.

According to Ponda PI Tushar Lotlikar, the crane driver drove the crane in a rash and negligent

manner, while proceeding from Farmagudi-Ponda towards KTC Bus stand Ponda, without taking proper care and caution, endangering human life.

He dashed against the stationary taxi motorcycle pilot and further dragged him up to 7.5 mts along with his motorcycle and also hit a mini bus in the process. The victim sustained grievous injuries, and succumbed to his injuries.

CM directs SEIAA to expedite environmental clearances for 9 auctioned mining blocks

Directs the auction lease holder of Shirgao to exclude the area of Shri Lairai Temple and habitation in and around the area

PANJIM: Chief Minister Pramod Sawant on Tuesday took status of all the nine auctioned mining blocks to ensure speedy clearances and resumption of mining activities and also directed the State Environment Impact Assessment Authority (SEIAA) to complete the process of granting environmental clearances (ECs) expeditiously.

The directions were given at the Goa State Geological Programming Board Meeting 2024, chaired by the Chief Minister.

All the nine auction holders and the officers of Goa State Pollution Control Board (GSPCB), Environment Department, Forest Department among others, were present at the meeting. Also, other officials

have been directed to grant the permissions as soon as possible.

Based on the review, it was concluded that around 3-4 mines will be operational by September-October 2024. Sawant also directed the auction lease holder of Shirgao to exclude the area of Shri Lairai Temple and habitation in and around the area.

The agenda of the meeting included discussions on several crucial topics including exploration of mining leases to be funded through the National Mineral Exploration Trust (NMET).

The Board deliberated on the empanelment of agencies under the Directorate of Mines and Geology (DMG). Another key point of discussion was the strengthening of the DMG

office by establishing a laboratory for mineral analysis. The laboratory will be equipped with advanced instruments procured through NMET funds.

The meeting discussions also entailed that the profile of existing dumps will be studied by DMG-empanelled agencies utilizing NMET funds. The Geological Survey of India (GSI) will extend its support to the DMG, Goa, in preparing proposals to tap NMET funds. Additionally, the GSI will assist in the preparation of geological reports for mineral blocks slated for upcoming auctions.

At the meeting, the chief minister, unveiled the geological and mineral map of Goa, along with the District Resource Maps for both the districts.

Ponda civic body seals bike showroom for operating sans trade licence

PONDA: The Ponda Municipal Council (PMC) sealed a showroom located on Bethora Road for operating without obtaining a trade licence from PMC. The action followed a final order issued by the Chief Officer after a series of hearings on the matter.

Municipal Engineer Vishant Naik stated that the showroom owner had failed to secure a trade licence and a house number for the premises, despite being directed to do so by the PMC. The issue came to light following a complaint filed by a citizen, which was pursued by John Mascarenhas on behalf of the complainant.

Mascarenhas reported that the construction of the building commenced in 2022, during which a complaint was initially filed. The PMC had granted temporary permission on the condition that no business activities would take place. However, when the showroom started operating recently without proper documentation, a new complaint was filed against the ground plus one building where the bike show-

room was operating.

The Chief Officer's final hearing concluded that the business had been operating without obtaining the necessary permissions or licences, violating Section 265 of the Goa Municipalities Act, 1968, and the Trade and Licensing Bye-Laws, 1989. The permission for the structure expired on June 6, 2024, and the owner failed to pro-

duce any relevant documents or permissions for both the business and the structure. "Despite being given seven working days to produce the necessary permissions and having 11 months' time, the applicant failed to provide the required documents. The business was operating in blatant violation of all municipal laws, said the CO's order.

The Municipal Inspectors of the Council were directed to enforce the sealing, under the supervision of the Municipal Engineer.

CCP mulling over food, entertainment zone in Panjim

PANJIM RESIDENTS WANT CCP TO FIX THE CITY FIRST

PANJIM: Corporation of the City of Panaji (CCP) Mayor, Rohit Monserrate on Tuesday said that the Corporation will propose to have entertainment and food zones in the city.

Speaking to reporters, he said, "We want to set up entertainment and food zones in the city. Nothing happens in Panjim in the night. Everyone has to go outside for any sort of entertainment. We are hoping to get a zone in Patta where we will have vendors and entertainment and people of the city will benefit from it. The area can cater to a lot of people from the city."

He said the CCP has discussed some of the areas and places like the National Theatre and Joggers Park which can be notified as a zone.

"Names of different areas have been suggested. These names will be sent to the District Collector for notifying them. Even if we notify the area we will have to see how many

of them can be accommodated. Efforts will be made to spread them out evenly so that there is no traffic jam in the city," Monserrate said.

He said the number of zones will depend on the number of people who are to be accommodated.

"Depending on the people we have, we will try and accommodate them," he said.

He said there are 92 vendors who are on the priority list who need to be accommodated. However, he suggested that the number may increase. "We want to bring them under

"The priority of the CCP should be to complete the ongoing Smart City works. They are just trying to promote the business interests of some other people. It is not in the interest of the people. They should concentrate on the welfare of the people," he said. Former councillor Menino Da Cruz said, "The most important thing is that whatever work they have taken up, has only disrupted lives as they are not coming to a logical end. Now for what purpose they are proposing to have these zones? For whom? Is it a new scam?"

"The government announced that all Smart City works would be completed by May 31. Has it been finished? No. They may start it, but it is not going to see a logical end. Now again for this purpose a consultant will be appointed and a huge amount of money will be paid. We should give us the necessary amenities like good roads, electricity, water, sewerage amongst others."

a standard set of rules so that safety and cleanliness are not an issue. It should not cause any chaos in the area," he said.

He said the carts to be put in the zone will be redesigned as they are very old. Speaking about the entertainment zone, the Mayor said, "It

will provide the city dwellers to spend some time together. If it comes up in Patta then it will be easier to maintain it. Advantage in Patta is that there are no residential complexes there. Right now we have to notify the area. It can be from Sesa Goa to the Spaces building."

Konkan Railway to open bids for rent-a-bike service despite opposition

MARGAO: Despite Chief Minister Pramod Sawant's apparent reservations about the rent-a-bike service, Konkan Railway Corporation Limited (KRCL) is proceeding with the opening of bids received for operating the initiative at railway stations. Even though the State government's permission is required for the service to commence in Goa, KRCL will still evaluate the tender proposals.

However, the service cannot be started in Goa if the State government does not grant permission, as conveyed by Santosh Kumar Jha, Chairman and Managing Director (CMD) of Konkan Railway Corporation Ltd (KRCL), to Chief Minister Pramod Sawant, Jha, who has recently taken over office, paid a courtesy visit to CM Pramod-

Sawant on Monday.

Sawant on Tuesday stated that Jha informed him that the Konkan Railways' decision regarding the rent-a-bike service will be communicated to the State government within the next two days. According to the tender floated by KRCL, the rent-a-bike services are to be operated at seven railway stations - five in Goa and two in Karnataka - through a single contract encompassing all seven stations.

It is to be noted that this move by KRCL faced significant opposition from local taxi and rickshaw drivers stationed at the Konkan Railway stations in Goa, as well as from Opposition MLAs.

The primary concern raised was the potential impact on their livelihoods due to the introduction of the rent-a-bike service.

In an unrelated development,

several trains on the Konkan Railway route faced delays due to ongoing double-tracking work in Goa. Baban Ghatge, the Deputy General Manager of KRCL, addressed the issue on Tuesday morning, stating, "The delays were caused by the double-tracking work being carried out in Goa. He also gave an assurance that the regular train schedule was expected to resume by Tuesday evening."

Traffic violations drop, yet road accidents unabated in Goa

MARGAO: In the first four months of 2024, police in Goa issued 31,729 challans to riders violating the Motor Vehicle (MV) Act, a decrease from the 51,816 issued during the same period last year. Notably, in April 2024 alone, 9,800 cases of traffic violations were booked across the State. Police said the traffic violations recorded included not wearing helmets, not using seat belts, tinted glass usage, over-speeding, red-light jumping, and driving without a licence.

Kashinath Naik, a resident of Margao, acknowledged the visible impact of the traffic drive, noting that more people now use seat belts while driving cars and wear helmets while riding scooters.

Additionally, compliance with driving licences, speed limits, and other regulations has improved. However, Naik expressed concern that despite these efforts and the issuance of MV cases, road accidents have not decreased.

From January to April this year, Verna recorded the highest number of accidents at 84, with six fatalities, while Cuncolim and Maina-Curtorim reported seven fatalities each. The Collem police booked the highest number of traffic violations at 2,883 in four months. (see box)

Despite the numerous traffic violations booked and preventive measures implemented, the data reflects that road accidents and fatalities continue to be a concern in South Goa.

Traffic Cell book 150 violations of drunken driving during special drive

"In continuation with the action against drunken driving, a special drive was held from June 7, 2024, to June 8, 2024, between 8 pm to 11 pm and total of 150 violations of drunken driving were booked during the special drive," a statement from Superintendent of Police, Traffic, Rahul Gupta said.

He said that so far 2,318 drunken driving cases have been booked from January 1, 2024, to June 9, as compared to 535 cases booked during the same period last year.
