### ANJUNA COPS ALLOW BULLDOZERS TO RAZE HOME OF GOAN FAMILY; REMAIN MUTE AS THE AILING MAN OF THE HOUSE AND HIS SON ARE KIDNAPPED AND THROWN OUT OF CAR AND THEIR STATEMENTS NOT RECORDED

# **GOAN OCCUPANTS BULLDOZED OUT OF THEIR ASSAGAO HOME, TORTURED & DUMPED IN ANJUNA**

Law & order has gone for a toss, says Siolim's BJP MLA Delilah Lobo; Anjuna police station doesn't send cops on time, as 'staff had gone for lunch'; water and electricity till today are in the name of the occupants who are now homeless

ASSAGAO: With no demolition orders to show, or any legal documents, bulldozers were used to muscle out a Goan occupant family, Agarwadekars, demolish their home, torture and kidnap the ailing man of the house and his son, all under the benign gaze and watch of the Anjuna Police.

The Anjuna Police had a ring side view of this orchestra of torture and did not even dare to name the people who sent the bulldozers, in the FIR lodged reluctantly and after the intervention of Siolim MLA Delilah Lobo, and too against 'unknown persons' even though photographs were provided.

While their house was getting demolished, PSI Sanket Tokre told the victim family that 'the staff had gone for lunch'.

The owner on paper Chrys Pinto had sold the house to the non-Goan builder, even as the Agarwadekars lived in that house as occupants for decades.

The law was bulldozed and stripped naked in the following manner.

The incident occurred on Saturday afternoon when about 15 bouncers, both men and women, descended at the residence of Pradeep Agarwadekar at Bairo Alto in Assagao, and

In an optional retest held for 1,563 students whose grace marks were scrapped after the matter reached the Supreme Court, only 813 appeared on Sunday.

The CBI filed the FIR in connection with alleged irregularities in NEET-UG under IPC sections 120-B (criminal conspiracy) and 420 (cheating) among others.

#### POLICE SAY FOUR GUNMEN KILLED

AFP, MOSCOW: Police have 'eliminated' four gunmen who killed at least eight people during attacks on religious buildings and the security forces, interior ministry officials in Russia's North Caucasus region of Dagestan said on Sunday.

"According to information at this moment in Makhachkala, law enforcement offices have eliminated four fighters," the interior ministry's spokeswoman wrote on Telegram. Attacks have been ongoing in Dagestan since early evening, killing six police, a member of the national guard and a priest.

A 66-year-old priest was killed in Derbent, the press secretary of Dagestan's interior ministry, Gariyeva told

the agency. Dagestan's RGVK broadcaster named the priest as Nikolai Kotelnikov, saying he had served more than 40 years in Derbent.

"The synagogue in Derbent is on fire," the chairman of the public council of Russia's leave the burning synagogue group in Syria.

Federation of Jewish Communities, Boruch Gorin wrote on Telegram.

"It has not been possible to extinguish the fire. Two are killed: a policeman and a secu-

rity guard." He added: "The synagogue in Makhachkala has also been set on fire and burnt down."

Gorin wrote that in Derbent, firefighters had been told to

because of the risk that 'terrorists remained inside'.

He added: "There is shooting in the streets around the synagogue."

The leader of Dagestan, Sergei Melikov, wrote on Telegram: "This evening in Derbent and Makhachkala unknown (attackers) made attempts to destabilise the situation in society. They were confronted by Dagestani police officers."

Russia's FSB security service in April said it had arrested four people in Dagestan on suspicion of plotting a deadly attack on Moscow's Crocus City Hall concert venue in March, which was claimed by Islamic State.

Militants from Dagestan are known to have travelled to join the Islamic State
