CURCHOREM YOUTH ARRESTED FOR ALLEGEDLY RAPING SCHOOL GIRL

MARGAO: A minor girl, studying in Class X, has allegedly been raped by a youth from Curchorem. The Sanguem Police Station has registered the offence under Sections 363 and 376(3) of the IPC, Section 4 of the Protection of Children from Sexual Offences (POCSO) Act, 2012, and Section 8(ii) of the Goa Children's Act, 2003. According to the police, the complaint was filed on July 29 by the minor girl (name withheld) at the Sanguem

Police Station. The complaint was recorded by the LPSI of Quepem Police Station in the presence of an NGO representative from the One Stop Centre, Margao.

The complaint alleges that in June 2024, the accused, Mayur, currently residing at Pontemol, Curchorem, kidnapped the victim and had sexual intercourse with her on multiple occasions, resulting in the victim becoming pregnant. The police stated that during the investigation, the accused was arrested and remanded to four days in police custody. Further investigation is being conducted by PI Pravin Gawas of Sanguem Police Station.

Both the victim and the alleged accused have been sent to the Goa Medical College (GMC), Bambolim, for medical examination.

THIEVES BREAK INTO PARKED CAR, DECAMP WITH AUDIO EQUIPMENT WORTH RS 1.8 LAKH

MARGAO: In a brazen theft in the heart of Margao town, unidentified individuals tampered with the window glass of a car, opened its door, and stole electronics

worth Rs 1,80,000 from an open area. The stolen items include two speakers, a sound mixer, two metallic speaker stands, one metallic laptop stand, two cordless microphones, two stereo cordless microphones, and a bag containing wires and other accessories.

Margao police have registered an offence under section 303 (2) of the Bharatiya Nyaya Sanhita – 2023 based on the complaint lodged by Bhiku Naik, a 40-year-old businessman residing in Margao.

According to the police, the theft occurred between 11 pm on July 14 and 10 pm on July 22, near Kanekar Radio House, behind Clube Harmonia in Margao. Investigations are ongoing to identify and apprehend the culprits.

COLVA COPS ARREST TWO FOR MURDER ATTEMPT NEAR BENAULIM'S DANDO GROUND

MARGAO: The Colva police have arrested two individuals in connection with a case of attempted murder. The accused are identified as Tyson alias Naser Bin Ahmed Masood, 22, a resident of Benaulim and native of Hyderabad, and Shankar Shillikythar Gangappa, 20, a resident of Colva, but originally from Belgavi, Karnataka.

LPSI Varshada Naik Dessai of the Colva Police Station registered the offence under sections 109, 351 (3), 352 read with 3(5) of the Bharatiya Nyaya Sanhita (BNS) against them. The accused were produced before the Judicial Magistrate First Class (JMFC) in Margao, and an eight-day remand was granted.

According to the complaint filed by Maichall Siddi, 36, the accused, Tyson alias Naser Masood, along with eight others, reportedly abused the complainant and Sayed Ali with filthy language and threatened them with dire consequences.

The police report states that Tyson instigated the other accused to assault the complainant and Sayed Ali. Following this instigation, the accused allegedly assaulted Sayed Ali with a wooden danda, rod, and knife, targeting his head and other body parts. Tyson allegedly kicked Sayed Ali, attempting to kill him.

The Colva police registered the offence and arrested the two accused late last night after interrogation. Police are likely to recover the weapons used in the assault. More arrects are anticinated as the investigation progresses The case is being investigated by LPSI Varshada Naik Dessai under the supervision of Cuncolim PI Diogo Gracias, who is holding charge of Colva Police Station.

MARGAO POLICE HOST AWARENESS **EVENT ON HUMAN TRAFFICKING**

MARGAO: The observance of World Day Against Trafficking in Persons was marked by a series of awareness activities in Margao to promote the fight against human trafficking. The event was held at the police conference hall, where a diverse group of participants, including hotel owners, students, advocates, NGOs, and self-help groups, gathered to engage in discussions and learn about combating human trafficking.

Superintendent of Police (SP) South Goa Sunita Sawant and Margao Sub-Divisional Police Officer (SDPO) Santosh Dessai presided over the event. In a parallel effort, the Konkan Railway Police Margao, in collaboration with Good Shepherd Convent, Velim, organised an awareness program at the Margao Railway Station. The programme, led by police inspector Sunil Gudlar, included a signature campaign where passengers at the station actively participated, adding their support to the cause.

The residents were concerned that the project, which also included a 12 MLD water treatment plant at Savoiverem for Priol Constituency, would exacerbate flooding in an area already prone to seasonal inundation. On October 27, 2023,

eleven locals, including five from Murdi and six from Usgao, filed a petition with the NGT against the Goa Government, the Water Resources Department (WRD), the Goa Coastal Zone Management Authority (GCZMA), and the Tribal

Welfare Department. The petitioners argued that the proposed barrage would obstruct the natural flow of the river during floods, leading to increased flooding in the region, which had previously experienced severe flooding in 1982 and 2021.

The locals contended that

despite the government's claims of addressing water needs for Priol Constituency, there was already a 15 MLD water supply in place and only a shortfall of 1 MLD. They questioned the necessity of an additional 12 MLD treatment plant at the expense of their livelihoods,

which would be affected by the project's impacts on fishing, agriculture, and local biodiversity.

The project faced significant resistance, including public protests and the imposition of Section 144 during an August 17, 2023, demonstration. Residents also highlighted concerns about CRZ violations and the lack of proper environmental and social impact studies.

Panchayat member Abhijeet Gaude expressed relief and gratitude, stating that the news of the project's abandonment was a major victory for the locals. He, along with other supporters, thanked social activist

Abhijeet Prabudesai and others who advocated for their cause.

Abhijeet Prabhudessai confirmed that following the WRD's response in the NGT court, which indicated that the project had been abandoned and that directions were issued to stop work, the court observed that the case was nearing resolution. Prabhudessai emphasised that the challenge addressed several issues, including the clearance provided by GCZMA, the impact on flood-prone areas, and the lack of comprehensive impact studies on human populations, the environ-

DRDA wants govt to release 34 months arrears of 7th Pay

PANJIM: The employees of the Department of Rural Development Agency (DRDA) both in service and retired have appealed to the State government to pay 34 months pending arrears of the Central Seventh Pay Commission.

They said that the government implemented the Seventh Pay for them from November 1, 2018 and not from January 1, 2016. As many as 60 employees especially 21 who retired prior to November 1, 2018 were deprived of the benefits of the Pay Commission and there was also no pensionery benefits to the staff who retired from the department.

According to them, the government had earlier

agreed to give them the arrears and the total liability was also worked out to over Rs 1.48 crore. The DRDA was entirely different from other autonomous bodies, which were revenue generation whereas DRDA was scheme implementing agency functioning entirely on the grants received from the Central and the State government grants

on the basis of 60:40 ratio. They stated that the Chief Minister had also assured one of the employees retired prior to November 1, 2018 to look into the matter. The government had recently agreed to implement the Seventh Pay Commission to the Kadamba Transport Corporation (KTC) employees, they further pointed out.

In 6 months, South Goa police collect Rs 4.4 lakh in fines for public smoking, spitting

Despite booking cases and challaning offenders, police report rise in tobacco use-related violations

MARGAO: Despite strict enforcement of laws prohibiting smoking and spitting in public places, incidents of these activities continue to rise. Both government and privately-owned commercial buildings across South Goa are marred with paan and gutka stains in the stairwells, bathrooms and

even in the elevators. Salcete, in particular, has witnessed a significant number of cases booked over the past two years, and the crackdown on violators has intensified recently. Superintendent of Police for South Goa, Sunita Sawant, reported that from January 1 to July 21 this year, police stations in the district booked

ed Rs 4,40,200 in fines. The Margao Town Police Station, which serves the highest population, recorded 358 cases, followed by Maina-Curtorim Police Station with 273 cases. Other notable figures include Colva Police Station with 313 cases, Cuncolim with 291, Fatorda with 171, Quepem with 81, Curchorem with 106, Sanguem with 206, Canacona with 500, Vasco Police Station with 223, Verna with 14, Mormugao with 13, Vasco Railway Station with 457, Cases registered in previous years (Jan to December) 2023 - 6002

2022 - 6625

Dabolim with 147, and Ponda with the highest number at 730. Mardol and Collem Police Stations recorded 118 and 339 cases, respectively. Efforts to curb these violations are ongoing, said police sources.

Most violations occurred at hospital buildings, health institutions. amusement centres, restaurants, hotel lounges, public offices, bus stands, ferry boats, and beaches. In 2022, South Goa police stations recorded a total of 6,625 cases of smoking violations by December 10.
