# Car plunges into river at St Estevam after 'terrifying chase', **Gujarat youth feared drowned**

Twenty-two-year-old Bashudev Bhandari still missing; his female companion, a native of Unjha and student of GIM, Sankhali, swims to safety; cops probing whether the car was genuinely being chased or if the GPS 'error' led to the incident

PANJIM: In a shocking incident, a youth from Bharuch, Gujarat, was feared drowned in a river at St Estevam, in the early hours of Saturday, after a 'highspeed chase', which resulted in the rent-a-car plunging into the water.

Twenty-two-year-old Bashudev Bhandari has been reported missing since then, while his female companion, a native of Unjha, Gujarat, studying in the Goa Institute of Management (GIM), Sankhali, managed to swim to safety.

According to the Old Goa Police, the incident occurred at around 12.45 am, when the duo, who had hired a rent-a-car for a weekend outing, was involved in a minor accident with another vehicle at Marcela.

In a desperate attempt to flee the scene, the pair sped away, only to be chased by an unidentified vehi-

PTI, PARIS: India's Preethi Pal created history as she became the first-ever Indian woman track and field athlete to win two medals at the Paralympics while clinching the bronze in the 200m T35 category with a personal best time of 30.01

The bronze won by the 23-year-old Preethi was also India's second para-athletics medal in the Paris Games.

T35 classification is meant for athletes who have coordination impairments such as hypertonia, ataxia and athetosis.

On Friday, she had clinched India's first athletics medal in a Paralympics track event, winning a bronze in the women's T35 100m competition with a personal best time of 14.21 seconds.

With the Bombay High Court at Goa monitoring the levels of noise pollution within the jurisdiction of Anjuna Panchavat most units playing EDM music switched to the high - low volume mode as the night wore on, with the elderly and children being made to beg for their right to sleep.

MARGAO: Insisting that any development should not come at the cost of destroying their unique heritage, a group of farmers from Loutolim, led by the Carbot, Mascasana & Bebdo Tenants Association, has appealed to the Union Agriculture Minister, Shivraj Singh Chauhan, to protect the khazan lands of their village from the proposed construction of a new high-level Borim bridge across the Zuari River.

At a recent meeting held at Ravindra Bhavan, Margao, the farmers submitted a memorandum to the minister, expressing their concerns about the impact of the bridge on their agricultural

lands and their livelihood. The farmers, represented by association chairman Albert Pinheiro, emphasised that the khazan lands are a unique agricultural heritage, essential for the preservation of their traditional

#### THE MEMORANDUM STATES

>> The Zuari River and its surrounding khazan lands have sustained local agricultural and fishing practices for over 4,000 years

>> These lands comprise saline wetlands, fertile paddy fields, and intricate water management

>> The proposed construction of the Borim bridge would significantly disrupt this delicate ecosystem

>> The construction of the bridge

farming practices and the environment. These lands, which are located along the Zuari River, are not only crucial for agriculture, but also for maintaining the ecological balance in the region. Pinheiro stated that while the schemes outlined by the Union Minister and the government are welcome as they could boost agriculture, the government must protect the khazan lands

on stilts would require the building of approach roads through the khazan fields to cart materials, causing irreversible damage to the soil and water systems

>> Once the mud is put in the fields, it cannot be removed or desilted, and in due course, it spreads to other fields as the khazan paddy fields are made of alluvial soil (chikol)

>> The bridge would impact the khazan lands' delicate structure

by finding an alternative plan for the new Borim Bridge that would not destroy the fertile khazan paddy fields.
