

Citing violation of par-

ty discipline, the state BJP has issued a showcause notice to Munirathna and asked him to clarify the allegations before a disciplinary committee within five days. BJP leaders, including Union minister Prahlad

Joshi and Leader of Opposition in the Karnataka Assembly R Ashoka, while maintaining that action should be taken against Munirathna if he had committed any wrong, termed his "hurried arrest" vendetta politics and preplanned. The contractor alleged that Munirathna had initially demanded




