

SC pulls up Bengal govt for 'tardiness' in installing CCTVs, building resting rooms

A three-judge bench, led by Chief Justice of India D Y Chandrachud, questioned the West Bengal government's delay in fulfilling safety requirements at hospitals in the State

PTI, NEW DELHI: The Supreme Court on Monday expressed concern over the slow pace of installing CCTV cameras and ensuring other security measures at West Bengal's State-run hospitals, including RG Kar Medical College and Hospital, as part of efforts to safeguard doctors.

Why Rajesh Naik, Chief Town Planner Goa, needs to go



Today, large numbers of ordinary Goan citizens, young and old, will be attending the event scheduled for this evening at 3 pm at the Town and Country Planning office at Dempo Towers, Patto, Panaji, to collectively ask Rajesh Naik, Goa's Chief Town Planner (Planning) who is on unwarranted extension since April 2024, to retire/resign from the office of the CTP, because of the tremendous damage he has caused to the ecology of the State by his various approvals of projects under the infamous sections 16B and now 17(2) and 39A of the TCP Act.

'One script policy' discriminating against the four other scripts of Konkani: GKF

KBM president Ratnamala Divkar said Devanagari lobby is not against Romi Konkani; GKF says the statement made by Divkar is "false and misleading"

MARGAO: Global Konkani Forum (GKF) rejected the statement by Konkani Bhasha Mandal (KBM) President Ratnamala Divkar on Sunday that the Devanagari lobby is not against Romi Konkani and Roman script Konkani is getting equal treatment from KBM and the government.

Jose Salvador Fernandes, Secretary, GKF said that as per the statement made by KBM President, Romi Konkani cannot be given equal status along with Devanagari as official script of Konkani under the Official Language Act, because of Sahitya Akademi follows "one language, one script policy." "GKF would like to state that first of all, this policy of the Sahitya Akademi totally goes against the Constitu-

tion of India, especially Article 14, which guarantees equality before the law. GKF would like to know what criteria was used by the Konkani Advisory Board of Sahitya Akademi in 1981, when they unanimously passed the resolution to give recognition to only Devanagari script as the sole official script of Konkani language?" He further said that this 'one script policy', is therefore discriminating against the four other scripts of Konkani, and needs to be challenged in the court of law. The nation's mantra is unity in diversity. "KBM President says there is no different treatment given to Romi Script by KBM. The representation of Roman Script members on the KBM executive committee speaks for itself.

GKF would like to know what criteria was used by the Konkani Advisory Board of Sahitya Akademi in 1981, when they unanimously passed the resolution to give recognition to only Devanagari script as the sole official script of Konkani language?" - Jose Salvador Fernandes, secretary, GKF

Moreover, discrimination towards Roman script is also seen at government level, where the Dalgado Konkani Akademi is not given grants on par with Goa Konkani Akademi," said Fernandes. He alleged that the KBM President, and other protagonists of Devanagari are definitely against Romi Script. "Otherwise I challenge her to say that she or KBM

does not have any objections to Konkani in Roman script being introduced in the schools. This will prove that she or KBM is not against Romi Konkani, because the Sahitya Akademi and the Official Language Act have no objections with Romi getting introduced in schools," he said. He said even the National Education Policy does not impose any language or script on any school. Then why KBM and Devanagari proponents like Uday Bhembre, Damodar Mauzo are against introducing Roman Script in schools? "The Devanagari protagonists want to choke the script to a slow death," he said. KBM President further said that GKF is trying to create a religious divide, which is totally false, and is made with a malafide intention to polarise

two communities. "In fact, the day the clause 'Konkani means Konkani written in Devanagari script' was inserted in OLA 1987, that very day the seeds of religious divide was sowed, betraying the 95 percent Romi script protagonists, who participated in the language agitation," she had said on Sunday at a programme of KBM held at Margao. Protesting against the comments, GKF Secretary Fernandes said that it was insane and baseless on the part of KBM President to accuse Roman script protagonists as communal. "We are only asking for our rights as religious and linguistic minorities, as it is our fundamental right as per article 29 (1)," Fernandes said.

Supreme Court asks IIT to grant admission to youth who missed fee submission deadline

The top court used its extraordinary powers under Article 142 of the Constitution in asking IIT Dhanbad to admit Atul Kumar into its Electrical Engineering B Tech course

PTI, NEW DELHI: The Supreme Court on Monday came to the rescue of a Dalit youth, who had lost his seat in IIT Dhanbad after missing the deadline to deposit a fee, by asking the institute to admit him to the B.Tech course. "We cannot allow such a young talented boy to go away. He cannot be left in lurch," a bench comprising Chief Justice D Y Chandrachud and Justices JB Pardiwala and Manoj Misra said. The top court used its extraordinary powers under Ar-

Article 142 of the Constitution in asking the IIT Dhanbad to admit Atul Kumar into its Electrical Engineering B.Tech course. "We are of the view that a talented student like the petitioner who belongs to a marginalised group who did all to secure admission should not be left out... we direct that candidate is granted admission to IIT Dhanbad and let him be in the same batch to which he would have been granted admission if the fees would have been paid," the bench said in the order.

pass any order in the interest of justice.

The parents of Atul Kumar, 18, failed to deposit Rs 17,500 as the acceptance fee by June 24, the deadline for depositing the requisite fees for blocking the seat. The parents of the youth also approached the National Commission for Scheduled Castes, Jharkhand Legal Services Authority and the Madras High Court to save the hard-earned seat. Kumar, the son of a daily wagger, hails from a below poverty line (BPL) family living at Titora village in

Muzaffarnagar district of Uttar Pradesh. The National Commission for Scheduled Castes also expressed its inability to help him. As he had taken JEE at a centre in Jharkhand, the youth had also moved the Jharkhand State Legal Services Authority which suggested him to approach the Madras High Court as it was IIT Madras that had conducted the exam. The high court had asked him to approach the top court.
