Yellow alert issued for Oct 9, 10: IMD warns of thunderstorms, gusty winds

PANJIM: The India Meteorological Department (IMD), Goa, has issued a yellow alert for October 9 and 10, warning of thunderstorms accompanied by lightning and gusty winds in isolated areas across North and South Goa.

The IMD predicts that thunderstorms with gusty winds reaching speeds of 30-40 km/hour are likely in both districts during this period.

In the meantime, rainfall associated with the retreating monsoon caught many Goans off guard, as rain lashed the State on Monday evening. This pattern continued into Tuesday, leading to thunderstorms and causing disruptions to normal life. Traffic in the capital city of Panjim was severely affected, with waterlogging reported on the Atal Setu and

Lightning strike damages Holy Spirit Church, Margao reels from storm

three people were injured when the walls of a house near the Margao flyover collapsed due to the incessant rain. The three occupants were rushed to hospital in an ambulance. Firemen responded to multiple instances of falling tree branches, one which damaged a car at Khareband.

Waterlogging plagued several areas of Margao, with the vicinity of the Municipal building and garden experiencing particularly severe flooding. The corridor surrounding the MMC building was submerged, disrupt-

goods dry. Vehicles driving through the flooded streets sent waves of water into the MMC corridor, leaving homeless people who typically sleep outside the building without a dry spot to rest for the night.

stated that fire personnel responded to 13 calls related to trees falling on roads and houses. Fire teams were dispatched to clear the debris, ensuring the reopening of roads to allow vehicular movement. The fire department remained on high alert throughout the evening as they worked to address the various incidents caused by the storm.

Team Herald PONDA: Panic gripped passengers on a ferry boat traveling from Cortalim to the Marcaim ramp after the vessel drifted off course and became stuck in the mud midway due to gusty winds and heavy rain. The incident occurred at around 6.30 pm, leaving passengers stranded on the ferry,

exposed to the downpour for over three hours. The ferry, packed with people and vehicles, was finally freed from the muck around 10 pm during high tide and floated its way to the Marcaim ramp. Ponda Fire personnel arrived on the scene to assist.

The ferry route, spanning around 1.5 kilometres, is commonly used by passengers, including factory workers and government employees traveling to the Verna Industrial Estate and Ponda. Many passengers expressed concern over the safety of this water route, which they feel is risky, especially during harsh weather conditions.

Marcaim Sarpanch Shailendra Panjikar acknowledged that such incidents are common during heavy winds, particularly given the length of the ferry route, which he noted as the longest in Goa. He suggested relocating the Cortalim ferry ramp to Agasaim, directly opposite the Marcaim ramp, which would significantly shorten the route and provide a safer journey. Panjikar added that the bandhara (embankment) at Agasaim has already been widened, making it suitable for light vehicles if a new ramp is constructed on that side.

PANJIM: Farmers in Taleigao are reeling from losses caused by the sudden heavy rains that lashed the State on Monday and Tuesday. The unexpected downpour destroyed or severely damaged their paddy crops, leaving many farmers struggling to salvage their hard work. Farmers who had already harvested their crops faced difficulties drying the grains, while those yet to harvest found their crops bent or flattened by the rains.

Luciano emphasised the need for community farming to streamline the harvesting process, though some farmers prefer their independence. "Some farmers grow Jyoti and some grow Jaya, so the harvesting time differs. A few of us have started growing the same variety to harvest at one time, but even this season, we suffered badly," he lamented. He also raised concerns about the financial strain caused by transportation and processing costs, which outweigh the benefits of government compensation.

MARGAO: Margao's iconic MMC building is set to undergo a full renovation, with a consultant engaged to submit plans by Diwali, including the installation of a lift and enhanced lighting. Minor repairs, such as painting, will be done in the interim.

He added that the consultant had carried out the inspection of the building, taken the measurements, and made suggestions, including installing a lift and illuminating the building. MMC has also decided to grant the Goa State Pollution Control Board (GSPCB) an NOC to set up an Ambient Air Quality Monitoring Station, while it was also decided to prepare a heatwave plan for the town.

Shirodkar added that proposals regarding sorting out technical issues about the traffic signal near the housing board, an NOC for a pumping station in Fatorda for the sewerage corporation, among others, had also been cleared. It



was also decided to study the road in Old Market near the Municipal Garbage area as there are demands to widen the road so that the use of the municipal property there is maximized.

MMC also passed a resolution to construct a concrete road with a gutter, rainwater harvesting tank, ramp, etc., on the eastern side of the Municipal Solid Waste Shed at Sonsoddo. Shirodkar stated that this would be beneficial in the long run as the quality of the road would improve and last for a longer period. A resolution

was also passed to supply packing strips of 12mm rolls for baling plastic waste within the jurisdiction of the MMC through the 14th Finance Commission Grants.

A decision was also taken regarding the construction of a shed on the existing MMC market building. It was also decided to renovate the Ganapati Pujan Hall in the municipal garden and the workers' room in the garden. A proposal was also made for opening a coffee shop in the garden, but it was decided to seek legal opinion first.

MARGAO: Addressing allegations of misappropriation of funds during the Margao feast fair held in May this year, MMC Chairperson Damodar Shirodkar said legal counsel has been sought to resolve the matter. Shirodkar revealed that police are actively searching for the accused MMC clerk, whose services were terminated, while efforts to recover the embezzled funds are ongoing. modar Shirodkar accused each other of negligence in clearing the 30-month pending bills. Questions were raised about the amount MMC has to pay and the need to verify these payment claims first, given that the total figure is substantially high.

Another flashpoint occurred regarding payments for a Shivaji Jayanti programme. Opposition councillors accused the administration of financial mismanagement, but Shirodkar firmly denied the claims, insisting that all financial records are transparent.

CCTV cameras to combat rising crime

MARGAO: The Margao Municipal Council (MMC) has finally approved the installation of CCTV cameras at 38 locations within its jurisdiction in the first phase. The project, funded through the MPLAD scheme, addresses growing concerns among residents over rising thefts.

A resolution was passed at the MMC meeting held on Tuesday, marking a step forward after years of delay. Chairperson Damodar Shirodkar emphasised the need for better surveillance as a response to public demand.

FRESH FISH, NO FOUL PLAY: Export units in Cuncolim deflect pollution blame to sole fish meal plant

MARGAO: The Seafood Exporters Association of India (SEAI) has firmly refuted allegations of environmental pollution linked to fish processing units, following criticism from political leaders over the operations of fish meal plants. In a statement, SEAI clarified that there is only one fish meal plant in the Cuncolim Industrial Estate, while the other six facilities are fresh fish exporters. The association believes that authorities and political leaders are unfairly targeting the entire sector, despite the fact that the pollution concerns stem solely from the fish meal unit.
