PANJIM: The six-lane elevated corridor project at Porvorim has forced the people staying along the road to face dust pollution and prepare for respiratory

Residents are questioning who will be responsible for the respiratory diseases that will be caused due to the pollution or who will take care of those who are already suffering from diseases like Asthma.

It has been barely a few months since the work started, but it has thrown the lives of the people haywire. A thick layer of dust has gathered on the walls of the buildings and the vehicles parked there, giving enough indication of how much people are suffering due to the work. To protect themselves from the polluted air filled with minute dust particles, people have covered some parts of their houses with plastic and steel sheets.

The residents of the area questioned why there is no standard operating procedure (SOP) during the execution of the project and why the different departments of the government cannot work in coordination, so that people are not inconvenienced?

near Sanjay School. It has become dangerous for two wheelers. In the traffic congestion the two wheelers are affected as there are no dedicated lanes for two wheelers. All the vehicles are trying to avoid rough patches. Nothing has been discussed with the locals."

"When the work was started all the departments must have got together and decided what they were going to do. Why should a citizen go to high court and then you tell the high court what you are going to do to mitigate the problem. This should be part of the stand-

ard operating procedure. Without people having to ask it should have been incorporated," he said.

D'Souza asked why the citizens should suffer after electing a government and paying their hard earned money in form of taxes.

"It is ridiculous that you

do not do anything and every time citizens have to knock on the door of the court to make you move," he said.

Manoj Pawaskar, a daily commuter to the city, said that life has become horrible for those who come to Panjim for work.

"I come to Panjim daily for work. Driving a two-wheeler has become very risky. Most of the time there is traffic congestion in the morning and evening. But what to do? We just have to bear it," he said.

Meanwhile, the village panchayat of Socorro has ssued a public notice informing villagers that a detailed presentation of the construction of a six lane elevated corridor is fixed on December 11, 2024 at the panchayat office at 11 am.

An Aldona resident has meanwhile filed an application seeking to intervene in the bail hearing of the accused in the sextortion case.

Ticlo said that the claim of Ferreira of having filed the complaint one year back is false and that the accused was immediately arrested after the complaint was filed recently.

"Where are the Congress members and their partners now? They have been pinpointing against the Chief Minister of Goa while their own MLA has been exposed," he said.

Ticlo has demanded his immediate resignation. "Why is the MLA silent? If you are not wrong why did you pay money? People of Aldona and Goa want to know," he asked.

ED probes cash-for-jobs scam in Goa

PANJIM: The Panjim zonal office of the Enforcement Directorate (ED) has now started investigations into the cash-for-jobs scam in the State under the provisions of the Prevention of Money Laundering Act (PMLA), 2002.

The ED has registered an enforcement case information report to probe the alleged cash-for-jobs scam reported in the State.

Though the senior police officers remained tight-lipped, it is learnt that the ED had already sought information from the police in connection with the cases registered at different police station.

Over 30 cases related to cash-for-jobs scam have been registered and about 35 persons have been arrested by the police for cheating gullible job aspirants to the tune of crores of rupees.

Among the arrested accused, the notable were two queen pins Pooja Naik of Old Goa and Deepashree Mhato e Sawant of Amona, Sankhali, who are involved in maximum cheating cases.

AAP Youth Wing mimics BJP stall selling government jobs

Archaeology Dept yet to receive report into burial of body at British cemetery

PANJIM: The Department of Archaeology is yet to receive investigation report from the North Goa Collector and the Goa Police regarding the burial of a person at the British Cemetery, Dona Paula, a protected monument, in May last year.

The incident had come to light after Corporation of the City of Panaji (CCP) Councillor Nelson Cabral complained to the Commissioner Clen Madeira seeking investigation into the burial of a person on May 27, 2023, at the British Cemeterv, Dona Paula, a protected monument as per the Goa Ancient Monuments and Archaeological Sites and Remains Act 1978 and Rules 1980.

Following a complaint, the

CCP Commissioner wrote a letter to the Department of Archaeology to look into the matter.

In the past, the Department of Archaeology had submitted several complaints regarding unauthorised locking of gates by unknown persons at the British Cemetery and also about illegal structure erected inside the cemetery.

Accordingly, Director of Archaeology Dr Nilesh B Fal Dessai wrote to the North Goa Collector and the Superintendent of Police (SP), North, requesting them to investigate the matter and to lodge a complaint as per provisions of the 'Indian Penal Code' and Section 295 and section 441 and 'The Goa Ancient Monuments and Archaeological Sites and Remains Act of 1978 and Rules 1980' and to take
