Sarpanch abducted, killed in Maharashtra's Beed; 2 held

CHHATRAPATI SAMBAJINAGAR: A village head was allegedly abducted and murdered by a group of persons following an enmity in Maharashtra's Beed district, police said on Tuesday. Two persons have been arrested in connection with the incident which took place in Kej area on Monday, they said. Massajog village sarpanch Santosh Deshmukh was abducted from a toll plaza located near Dongaon Fata village in Beed at around 3 pm on Monday. While the sarpanch was crossing the toll plaza in a car along with his cousin Shivraj Deshmukh in the driver's seat, a black four-wheeler with six persons arrived there, as per the FIR. One of the six persons then vandalised the driver's side glass window of the sarpanch's car.

Arunachal: 2 suspected drug peddlers arrested, cannabis worth Rs 2 lakh seized

ITANAGAR: Two suspected drug peddlers were arrested with cannabis worth Rs 2 lakh from Arunachal Pradesh's Naharlagun, police said on Tuesday. One of them was arrested on Monday from the Papunallah area and 6.5 kg of cannabis was seized from him, Superintendent of Police Mihin Gambo said. The accused, identified as Rage Kena (35), was arrested on the basis of a tip-off, he said. A case was registered under the Narcotic Drugs and Psychotropic Substances (NDPS) Act, he added. In another operation on Sunday, an inter-state drug peddler was arrested following a raid at his rented house in Lower Model village on the basis of intelligence inputs.

2 killed as truck falls into ditch in

Jharkhand's Chutupalu valley RAMGARH: A trucker and a handyman were killed after their vehicle fell into a 20-foot deep ditch in Jharkhand's Ramgarh district on Tuesday, police said. The incident happened in the accident-prone Chutupalu valley on the Ranchi-Ramgarh highway, they said. Dense fog is suspected to be the cause of the accident, they added. The Punjab-registered trailer was heading towards Ramgarh from Ranchi with TMT bars when the accident happened, police said. After coming to know about the accident, police immediately reached the spot and took out the bodies from the ditch, said Krishna Kumar, the officer-in-charge of the Ramgarh police station.

Elderly man stabbed to death at his Dehradun home

DEHRADUN: An elderly man was allegedly stabbed to death at his house in Basant Vihar area here by unidentified miscreants, police said on Tuesday. Neighbours informed police after they heard loud cries 75-year-old Ashok Kumar Garg's house. Garg was found lying in a pool of his blood in the washroom of his Álaknanda Enclave home when the police reached the spot on Monday night, Senior Superintendent of Police Ajai Singh said. He had been repeatedly stabbed in the stomach and was rushed to Mahant Indresh Hospital where doctors declared him dead, he said. Garg had retired from ONGC and was living alone in the house since his wife's death. He has two married daughters who live outside Dehradun.

3 killed, 15 injured as bus falls into

gorge in Himachal's Kullu SHIMLA: A private bus with over 30 passengers on board fell into a gorge in Himachal Pradesh's Kullu district on Tuesday, killing three people and injuring 15 others, police said. The bus driver among three died when the bus, on its way to Kullu's Anni from Karsog, fell into a gorge near Shakdler village, they said. The police and locals immediately reached the spot and started the rescue operations. Of the 15 injured, 10 in critical condition were rushed to IGMC Shimla while the others were sent to Rampur hospital, according to officials. The bus was torn into pieces due to the accident and its parts were scattered everywhere. Further details are awaited.

Two killed as bike rams into tractor-trolley in UP's Mirzapur

MIRZAPUR (UP): A 65-year-old man among two people died after their motorcycle rammed into a tractor-trolley parked on a road near Garbarda Bridge here, police said. Dharmaraj and Prashant Mishra (20) were going to Haliya market on a motorcycle. When they approached Garbarda Bridge, the bike rammed into the tractor-trolley, killing them on the spot, Haliya SHO Virendra Singh said. The bodies have been taken into custody. Further investigations are underway, he said.

Oppn's no-confidence motion against VP Dhankhar

PTI, NEW DELHI: In a first, parties of the INDIA opposition bloc on Tuesday submitted a notice to bring a motion in Rajya Sabha for the removal of Vice President Jagdeep Dhankhar, accusing him of "partisan" conduct as the chairman of the Upper House.

If the motion is moved, these parties need a simple majority to get it passed, but they do not have the requisite numbers in the 243-member House. Opposition members, however, insisted that it was a "strong message to fight for

parliamentary democracy". On behalf of the opposition, Congress leaders Jairam Ramesh and Naseer Hussain submitted the notice signed by 60 opposition MPs -- including from the Congress, RJD, TMC, CPI, CPI-M, JMM, AAP, DMK, Samajwadi Party -- to Rajya Sabha Secretary General P

This is the first time that a notice for bringing a motion to remove the Vice President has been moved in the Rajya Sabha. A 14-day notice has to be given and it should be approved by the Deputy Chairman before the motion is taken up.

Notably, Congress President Mallikarjun Kharge, Parliamentary Party Chairperson Sonia Gandhi and the floor leaders of various opposition parties are not among the signatories to the notice, the sources said.

Similar notices for removal of the Speaker of Lok

Sabha have been submitted in the past, but none against the Vice President and Rajya Sabha Chairman.

Three motions have come in the past against Lok Sabha Speakers - against G V Mavalankar on December 18, 1954, against Hukam Singh on November 24, 1966 and against Balram Jakhar on April 15, 1987.

While the motions against Mavalankar and Jahar were negatived, that against Hukam Singh was rejected as less than 50 members rose in the chair to take up the motion.

The present move, spearheaded by the Congress, comes in the wake of verbal clashes between opposition parties and the Rajya Sabha chairman.

The opposition has been upset with Dhankhar over multiple issues. The latest trigger was allowing BJP members to raise the allegations of links between Congress leaders and organisations backed by billionaire investor George Soros which the ruling party claims are involved in "an-

ti-India activities".

Congress General Secretary (In-charge, Communications) Jairam Ramesh said they were pained to move such a notice against the Chairman, but were "forced" to do so after he "crossed all limits" on Monday by allowing several members of the treasury benches to speak against top Congress leadership in the House.

"All parties belonging to the INDIA group have had no option but to formally..submit..a..no-confidence... motion against the learned Hon'ble Chairman of the Rajya Sabha for the extremely partisan manner in which he has been conduct-

Council of States.

"It has been a very painful decision for the INDIA parties to take, but in the interests of parliamentary democracy they have had to take this step," Ramesh posted on X.

He said all opposition parties belonging to the INDIA group have "unitedly, unanimously" endorsed no-confidence motion against the Chairman of the Rajya Sabha.

The honourable Chairman, the very learned Chairman, very erudite Chairman, well-known constitutional lawyer, Governor, a very senior man whom we respect... and with whom I enjoy .the.best.of.the.personal equation, but we were forced to submit this no-confidence motion for the first time in the 72year history of the Rajya ing the proceedings of the Sabha," he told PTI.

54 ILLEGAL STRUCTURES IN OLD GOA HERITAGE ZONE

Save Old Goa Action Committee member Glen Cabral said, "The State government has passed a notification regulated any development within the prohibited area and extending up to 200 metres of the prohibited area as notified under the Ancient Monuments and Archaeological Sites and Remains Act, 1958. Thus, an NOC from the Archaeological Survey of India is mandatory under the Ancient Monuments and Archaeological Sites and Remains (Amendment and Validation) Act, 2010."

The Mamlatdar's report noted that some of the structures are used for commercial activities and that the Se Old Goa village panchayat was yet to act against them. However, the Se Old Goa panchayat secretary Subodh Prabhu clarified to O Heraldo that that the village panchayat had already issued show causenotices to the encroachers and ordered them to stop all commercial activities. The panchayat will file its affidavit-in-reply in the High Court during the next hearing onDecember 17.

The Old Goa Talathi and the field surveyor could notidentify eight illegal structures while conducting the survey. The Mamlatdar has written to the Conservation-Assistant Archaeological Survey of India (ASI), Old Goa, to verify the details of these eight structures, but there was no response from the ASI authorities, the Mamlatdar stated in his affidavit-in-reply.

S M KRISHNA PASSES AWAY

The Karnataka government has announced state mourning for three days as a mark of respect to the veteran leader. His last rites will be performed with full State honours

at his native in Mandya district on Wednesday. The three-day state mourning is from December 10 to

12, official notification said.

Born in Somanahalli in Mandya district on May 1, 1932, Somanahalli Mallaiah Krishna began his career in electoral politics in 1962 by winning the Maddur assembly seat as an independent.

He was then associated with the Praja Socialist Party before joining the Congress.

Later, he joined the BJP in March 2017, ending his nearly 50-year-long association with the Congress.

In January last year, Krishna announced his retirement from active politics, citing his age as the reason. He was the 16th Chief Minister of Karnataka from Octo-

ber 11, 1999, to May 28, 2004, (from Congress). He also served as the Governor of Maharashtra and was the External Affairs Minister during the Manmohan Sin-

gh-led UPA government from 2009 to 2012. A law graduate, Krishna studied in the US. He graduated from the Southern Methodist University in Dallas, Texas, and The George Washington University Law School in

Washington DC, where he was a Fulbright Scholar. Krishna served as the Speaker of the Karnataka Legislative Assembly from December 1989 to January 1993. He was also a member of Lok Sabha and Rajya Sabha several times between 1971 and 2014.

Krishna is credited by many for putting Bengaluru on the global map as a fillip given to the IT sector during his tenure resulting in the city growing as India's Silicon Val-

Prime Minister Narendra Modi condoled the passing of Krishna and said he was a remarkable leader admired by people from all walks of life.

"Shri SM Krishna Ji was a remarkable leader, admired by eonle from all walks of life. He always worked tireless to improve the lives of others," he said in a post on X. Recalling that he has had many opportunities to inter-

act with Krishna over the years, Modi said he will always cherish those interactions. Congress chief Mallikarjun Kharge hailed the former Karnataka Chief Minister as a true champion of develop-

ment who made significant contributions to the state and the nation. "Extremely saddened by the passing away of Former Chief Minister of Karnataka and Former Union Minister, S M Krishna. A true champion of development, he made significant contributions to the state and the nation," Kharge

said in a post on X. "His vision, dedication and exceptional public service played a pivotal role in Karnataka's progress, while his approach to balance welfare with development placed a global stamp on Bengaluru's transformative paradigm. My deepest condolences to his family, friends and fol-lowers," he said.

External Affairs Minister S Jaishankar expressed sorrow over the death of Krishna and said his contributions to the development of Karnataka and EAM will be vividly remembered.

In a post on 'X', he said, "Deeply saddened by the passing away of former EAM S M Krishna."

Posting a photo of him with Krishna, Jaishankar fondly recalled his many interactions with him during his term as EAM.
