Four-lane stretch will be part of the larger Mumbai-Kanyakumari corridor, which will facilitate intra-State traffic from Karnataka and Maharashtra; reduce traffic bottlenecks in Salcete

MARGAO: Union Transport Minister Nitin Gadkari has announced the approval of Rs 747 crore for the four-laning of a 7.24 km stretch of NH-66, from the end of the Margao Bypass to Cun-

The project includes constructing a 4.45 km six-lane flyover to reduce traffic congestion in urban areas and will be executed under the Hybrid Annuity Model (HAM). Part of the broader Mumbai-Kanyakumari 4/6 lane corridor, this development aims to enhance connectivity between Margao and Cuncolim, while facilitating smoother intra-state travel for commuters from Karnataka and Maharashtra. Critical points on the route, including Navelim, Dramapur, Sirlim, Chinchinim, and Panzarconi, will see improvements that address traffic bottlenecks and enhance safety. The project is expected to significantly cut travel time and improve road safety by addressing accident-prone zones

Bhoma NH widening will not affect homes, temples: Union Min Gadkari

MARGAO: In another matter, Union Minister Nitin Gadkari addressed concerns about the National Highway 748 widening project near Bhoma, in the Lok Sahba, while responding to queries from South Goa Congress MP Viriato Fernandes. Gadkari stated that the highway expansion will be carried out along the existing alignment to minimize impact on local structures. "It has been aligned in such a way that there is bare minimum impact on the existing structures/water bodies. No religious structures are affected and the elevated structure in the built-up area has been proposed within available

Right of Way (RoW) for smooth and incident-free movement of traffic," he said.

The minister clarified that the project requires acquiring 4.53 hectares of land and has been based on a proposal submitted by the state government after local consultations. The Central government has sanctioned Rs 557 crore for constructing the 9.6-kilometer stretch from Ponda to Bhoma. Responding to Fernandes' specific queries about preserving religious structures, houses, and temple ponds, Gadkari assured that the alignment would protect local community interests while proceeding with the highway expansion.

'Extend Verna IDC elevated corridor to congested Pirnim Jn'

MARGAO: Concerns over traffic congestion at the Pirnim junction on the Margao-Panjim route have led to a demand for extending the proposed elevated corridor at Verna Industrial Estate to include this intersection prone to traffic snarls. Environment Minister Aleixo Sequeira, who is also the Nuvem MLA, called for the extension, along with the construction of underpasses at junctions leading to Cansaulim and Majorda villages. Sequeira emphasised that these measures are essential for ensuring smooth traffic flow on National Highway 66. The demand comes amid criticism of the current design, which stakeholders argue fails to address the choke point at Pirnim junction.

The Public Works Department (PWD) recently completed the Margao Western Bypass at a cost of Rs 482 crore, and the tender for the elevated corridor at Verna IDC has been awarded at an estimated cost of Rs 300 crore.

The issue has been a recurring topic of discussion, with members of the South Goa District Road Safety Committee recently voicing concerns over the flyover design. Ending on a slope near a petrol pump, the current design leaves the critical junction uncovered, which consumer rights activists and officials warn could exacerbate traffic snarls rather than mitigate them. The farmers' plight worsened after the Salcete Mamlatdar's recent inspection of Bhogti Tollem was abruptly cancelled due to the absence of Goa State Pollution Control Board (GSPCB) officials. This sparked protests, with Vales blaming Environment Minister Aleixo Sequeira for the delay. However, Sequeira denied any involvement, stating, "I was unaware of the inspection and its cancellation. It seems political motives are behind this blame.

Sequeira said the government is monitoring sewage treatment plants in Margao and likened the situation to the clean-up of the Ganga, suggesting that rejuvenation of the River Sal, the lifeline of Salcete, is possible. Despite these assurances, the farmers remain sceptical, particularly as symbolic initiatives, such as collecting River Sal water for Republic Day celebrations in Delhi, contrast sharply with the dire realities of unchecked pollution in local water bodies.

Push for road infrastructure gains steam in Majorda, Utorda

MARGAO: Efforts are ramping up to address long-standinfrastructure challenges in Seraulim and nearby villages with plans for new flyovers and bridges aimed at improving connectivity and mitigating recurring issues like monsoon flooding and traffic congestion. Environment Minister Aleixo Sequeira is spearheading these initiatives in collaboration with Railways officials. During a recent meeting at the South Goa District Collectorate, he underscored the urgency of the Seraulim flyover. While land for the project was acquired by the Public Works Department (PWD) in the 1990s, Sequeira revealed that encroachments have taken over nearly half the acquired proper-

Key projects include a flyover at Seraulim to resolve the seasonal closure of the railway underpass during heavy rains, a flyover at Majorda to ease vehicular movement across the railway crossing, and a pedestriancum-two-wheeler bridge at Utorda to provide safe access for school students whose playground lies across the railway tracks

ty. The PWD has been instructed to conduct a detailed survey to identify encroachments and determine the project's feasibility. "The Seraulim flyover is essential not only for easing traffic but also for addressing the underpass flooding that disrupts life every an-cum-two-wheeler bridge, par-

Pollution watchdog seals scrapyard in Benaulim

MARGAO: The Goa State Pollution Control Board (GSPCB) has issued a sealing notice to a scrapyard located in Pulwaddo, Benaulim, following serious environmental violations discovered during an official inspection. The scrapyard, which has been a longstanding source of concern for local residents, was found to be operating without valid environmental clearances and posing significant risks to the nearby River

During an inspection conducted on Thursday GSPCB officials, accompanied by the complainant, documented multiple environmental infractions. The inspection revealed that the scrapyard was situated merely three meters from the River Sal and was disposing of solid waste and ceramic waste directly into the river. The unit had constructed a toilet with a septic tank very close to the riverbank, with bathroom water being discharged directly into the river through a pipe.

The scrapyard, which collects cardboard, paper, and PET bottles from commercial establishments, operates two bailing ma-

The scrapvard, which collects cardboard. paper, and PET bottles from commercial establishments, operates two baling machines with capacities of 800 kg and 1200 kg. The facility employs seven to eight workers and was found to be enclosed with temporary tin sheets, lacking proper environmental safeguards.

Based on these findings, the GSPCB has issued a directive under Section 31(A) of the Air (Prevention and Control of Pollution) Act, 1981, ordering the immediate closure of the scrapyard. The notice emphasizes that the unit has failed to obtain the mandatory consent to establish or operate from GPSCB.

The order has been communicated to the district collector and the Benaulim panchayat, with instructions to ensure the unit's operations are stopped and sealed with immediate effect. The GSPCB has warned that failure to comply with the no-

"This small yet significant victory demonstrates the power of collective action and the will of the people to protect their heritage," Alemao added, emphasizing that this was just the beginning of their efforts to protect the river.

No power, water supply in South Goa today

MARGAO: The Electricity Department has announced a power shutdown on Sunday, December 15, from 7 am to 5 pm, to carry out critical maintenance work on the 220 KV Ponda-Xeldem line.

The shutdown will impact the 220 KV circuits feeding the Xeldem substation and other substations in South Goa, disrupting electricity supply to areas including Canacona, Sanguem, Quepem, and parts of Salcete, Dharbandora, and Ponda. This includes key locations such as Cuncolim, Velim, Balli, Fatorpa, and Verna Industrial Estate, among others. As a result, the Se-

laulim water works in Sanguem has announced that there will be no water supply to the South district on Sunday, and restricted water supply to these parts on Monday. Residents and businesses are advised to make alternate arrangements. The maintenance

work, aimed at iminterstate proving and intrastate extra-high lines, will focus on the 220 KV and 110 KV EHV substations at Xeldem and Cuncolim
