Santa Cruz vows to protect Bondvol Lake as real estate threat looms

SANTA CRUZ: Villagers of Santa Cruz and petitioner Arturo D'Souza have issued a stern warning to real estate developers, urging them to withdraw their attempts to concretise the periphery of Bondvol Lake or face a significant public outcry. The 110-year-old lake, declared a wetland and biodiversity hotspot in October 2022, continues to be at the centre of controversy for years.

Residents were shocked when dense tree cover on the hillside surrounding the lake was recently cleared, allegedly by real estate companies that have purchased plots in the area. These companies have approached the High Court to request a reduction in the lake's buffer zone from 200 metres to 50 metres.

Petitioner Arturo D'Souza, who has been spearheading the battle against the encroachment, cited a 2016 High Court directive by Justice Gautam Patel that mandated the maintenance of a 200-metre buffer zone around the lake. "The High Court order still stands. The real estate companies are assuming they will win, but we will not allow this," he said.

PANJIM: Serpentine queues were observed at the OPD registration counters of Goa Medical College and Hospital (GMC), Bambolim, on Friday morning due to a server failure that disrupted online systems.

Patients and their relatives, including many who had travelled long distances and waited days for doctor appointments, were forced to stand in line for hours. The disruption created significant delays, with queues lasting until the afternoon. An estimated 1,500 patients

visit the hospital's OPD daily. Despite the setback, hospital staff resorted to offline registration to ensure services continued.

Commenting on the issue, Health Minister Vishwajit Rane clarified that the server failure was not due to any error by GMC staff.

"Such an issue has never occurred at GMC before. It is not the fault of the staff," he stated.

He added that GMC's upcoming Health Management Information System (HMIS) would enhance patient management and reduce paperwork once implemented.

Panchayat Secretary suspended for allegedly outraging modesty of woman

Usgao-Ganjem PANJIM: Panchayat Secretary Honaji Morajkar was suspended with immediate effect following a complaint of outraging of modesty filed against him by a 22-yearold woman from Valpoi.

An order to this effect was issued by Panchayat Director Siddhi Halarnkar on Friday. The woman had filed

a complaint with Ponda police against 55-yearold Honaji from Sakhali and the Ponda police had booked him under sections 78 (2), 75(2), 75(3) and 79 of BNS 2023.

In an order, the Panchayat Director said, " It is further directed that during the period of his suspension in force, the Village Panchayat Secretary Honaji Anil Morajkar of Village Panchayat Usgao Ganjem, Ponda, Block, shall report to the office of Block Development Office, Ponda, and will not leave the headquarters without obtaining the permission of this authority."

However, the Panchayat Secretary shall be enti-

tled to subsistence allowances as admissible, the order said.

Earlier, Panchavat Minister Mauvin Godinho said that file has been moved to suspend the Panchayat Secretary.

Providers Association of Goa (CNSPAG) has filed an application before the High corporate offices, and ca-Court of Bombay at Goa, ble TV channels operating requesting a directive for on Internet Protocol (IP) the Electricity Department to halt its operations of cutting and clearing wires attached to electricity and streetlight poles. This application was submitted as the power department began pulling down internet cables in South Goa.

Department staff commenced the removal of internet wires from electricity poles in South Goa. with linesmen, assisted by Executive Engineer Kashinath Shetye, initiating the action in the Aquem areas on Friday. Department officials have stated that only the wire bunches, which were installed haphazardly and were making the poles unstable, were removed. The Department also reminded that despite multiple notifications, the operators failed to remove the wires.

The operators have been given a new deadline of January 31, to either remove their wires from the poles or pay the Department for the necessary costs to cut or disconnect them.

Meanwhile, after the Department of Information and Technology, the CNSPAG has also raised concerns. The parent association has now filed an application before the High Court, seeking relief to ensure uninterrupted internet and cable TV connectivity until the pending hearing and
