DUO BOOKED FOR ASSAULT CASE AT BIRLA CROSS, VERNA

MARGAO: Two individuals, Bijay Mal and Kina Mal, both natives of West Bengal residing in Birla Cross, Verna, have been accused of assaulting Shubankar Ghatowal, a resident of Purulia, West Bengal. The assault, which took place in Birla Cross, Cortalim, Verna, involved the use of a glass bottle and a tree branch, causing injuries to Ghatowal's face, head, and a serious injury to his left eye. In addition to Ghatowal, the accused also allegedly assaulted his roommates—Abhijit Pal, Sushant Mahato, Pawan Rajwar, and Ramesh Rajwar-all residents of Birla Cross, Verna, and natives of West Bengal. These individuals were injured while attempting to intervene and rescue Ghatowal.

Verna Police have registered an offence under sections 118(2), 115(2), and 3(5) BNS. Further investigation is ongoing.

POINGUINIM RESIDENT BOOKED FOR **RASH DRIVING AND INJURING DUO**

MARGAO: Ulhas Parwar, a resident of Khalwade, Canacona, has filed a complaint with the Canacona police regarding a road accident involving a scooter. The accused rider, Jose Barreto, from Poinguinim, Canacona, is said to have driven the scooter in a reckless and negligent manner, without due care for oncoming traffic. The incident occurred near the Chicken Centre in Khalwade while Barreto was heading from Chaudi towards Shristhal, Canacona. He allegedly collided with a motorcycle ridden by Ulhas Parwar, causing him to fall onto the road and sustain grievous injuries to his face and body. The pillion rider, Sanjay Ulhas Parwar, sustained minor injuries

Canacona Police have registered an offence under sections 281, 125(b), and 125(a) of BNS 2023. The investigation is continuing.

LABOURERS AT AGONDA BEACH SHACK ACCUSED OF SAND THEFT

MARGAO: Rajesh Naik, Range Forest Officer for South Goa Marine Range in Galgibag, Canacona, has filed a complaint against several labourers working at the Shore Shack in Agonda. The accused are said to have illegally removed sand, a minor mineral, from Agonda Beach, allegedly to use it for tiling the shore shack. Additionally, the accused are accused of setting fire to coconut leaves on the beach, resulting in the destruction of the Turtle Nesting site. The incident has prompted a police investigation, and an offence has been registered under sections 303(2) and 326(f) of BNS 2023.

PONDA: A sudden midnight fire at an illegal scrapvard recently sealed by the Ponda Municipal Council (PMC) caused panic among residents of Warkhandem, Ponda. PMC recovers Rs 1.5 crore in rent arrears, seals defaulters' shops

PONDA: The Ponda Municipal Council (PMC) has recovered Rs 1.5 crore, including postdated cheques amounting to Rs 21 lakh, from shop owners at the Ponda Market Complex who had defaulted on rent payments since 2016.

The decisive action to seal shops yielded positive results, enabling PMC to recover over Rs 1.5 crore. Ninety-five per cent of the shop owners have now started making payments

Some shop owners owed amounts as high as Rs 9 lakh to Rs 12 lakh; traders managing businesses themselves were given the option to pay 50% of their dues immediately, with the balance payable

within six months

After repeated warnings and notices failed to prompt the defaulters to clear their arrears, PMC officials, including the Chief Officer, Municipal Engineer, supervisors, and other staff, sealed 24 shops for rent arrears totalling over Rs 2 crore. These arrears accumulated over had eight years.

PMC Chairperson Anand Naik commended the council staff for their efforts in recovering the dues. "The decisive action to seal shops yielded positive results, enabling PMC to recover over Rs 1.5 crore. Ninety-five per cent of the

shop owners have now started making payments," Naik said. He urged all shop owners to clear dues promptly to avoid penalties and interest charges on overdue rent. The defaulters included ten shop owners who had

> subleased their premises at high rents while failing to pay PMC. These individuals were asked to clear their arrears in full immediately, without any extension. Shop owners managing businesses themselves were given the option to pay 50% of their dues immediately, with the balance payable within six months. Some shop owners owed

BODY FOUND OUTSIDE VASCO RAILWAY STATION

VASCO: The Vasco police on Friday recovered an unidentified male body found lying outside the Vasco Railway Station. According to the police, the deceased was aged between 40-45 years and was found unresponsive at the railway station. The Vasco Railway Police informed the Vasco Police, who rushed to the spot and conducted the inquest panchanama. The body was later sent to the Hospicio-South Goa District Hospital, Margao for preservation and medico-legal formalities and for identification. Preliminary investigations revealed no signs of foul play and the case has been registered as an unnatural death under Section 194 of the BNS Act, the police informed.

12-YEAR-OLD GIRL MISSING, **KIDNAPPING CASE REGISTERED**

PONDA: A 12-year-old girl has gone missing from the Matruchhaya Ashram, an NGO-operated orphanage in Dhavalim, prompting the Ponda Police to register a case of kidnapping against an unknown person. According to police, the girl was brought to the ashram from Apna Ghar on January 10. She was reported missing on the morning of January 16, with the incident believed to have occurred around 11.30 am. Ashwini Patil, the in-charge of Matruchhaya, informed the police about the disappearance. Following this, police registered an offence against an unidentified individual under Section 137(b) of the BNS and Section 8 of the Goa Children's Act. The accused is alleged to have taken the girl away from lawful guardianship without consent and concealed her whereabouts.
