Stalled plans, derailed progress: South Goa's 2025-26 Development Plan in limbo

MARGAO: The uncertainty surrounding South Goa's District Development Plan (DDP) has deepened as officials remain hesitant to initiate the process for 2025-26. The silence over the 2024-25 proposals, which included over 3,100 developmental projects and an estimated budget of Rs 229.42 crore, has cast a long shadow on the region's developmental aspirations.

With the new financial year approaching, the usual flurry of activity at the South Goa District Planning Committee (DPC) is conspicuously absent. Local officials, reluctant to seek fresh proposals from panchayats and municipal bodies, have voiced

implementation of the previous plans, which were compiled and forwarded to the government in January 2024.

The delay is particularly glaring given that the 2024-25 draft was the first comprehensive DDP prepared by South Goa's DPC in its 23-year history. The achievement, however, now feels hollow as none of the proposed projects have been sanctioned or funded.

A senior South Goa Zilla Panchayat (SGZP) official admitted that without progress on last year's plan, initiating new proposals feels futile. "How can we approach local bodies for fresh development plans when their efforts last year yielded no results?"

concerns about the lack of the official remarked. The apprehension among officials stems from the risk of backlash from panchavats. many of which had invested significant time and effort in submitting detailed proposals.

The 2024-25 plan had generated optimism when it was finalised in January 2024. Following a rare meeting of the DPC in December 2023—its first in three years-the committee had consolidated 3,400 proposals from local bodies, including 3,119 from panchayats and 346 from SGZP. The proposals represented a wide array of developmental goals, from infrastructure upgrades to community projects, covering 53 of South Goa's 89 panchayats.

However, progress stalled after an April 2024 communiqué from the government, which initially indicated that the plan had been forwarded to the Finance Department for funding allo-

cation. By September, hopes were dashed when a letter from the Panchayat Director flagged numerous concerns raised by "higher authorities." These concerns questioned the feasibility and background of the plan. despite its compliance with Article 243G of the Constitution, which mandates comprehensive district development planning.

Efforts by SGZP to address these concerns, including referencing a High Court directive emphasising the importance of district planning, have not yielded any updates since September. This prolonged silence has left officials and local bodies in a state of limbo, with no clarity on whether the 2024-25 proposals will move forward.

The lack of communication has also affected morale among panchayat leaders, many of whom feel disillusioned by the process. A panchayat official, speaking on condition

of anonymity, expressed frustration over the lack of transparency. "Our communities rely on these projects to address critical infrastructure gaps. When nothing materializes, it undermines trust in the system," the official said.

Meanwhile, as 2025 has begun, the prospects of initiating a new DDP for 2025-26 appear increasingly bleak given that 2024 passed without finalising the previous 2024-25 DDP. The usual deadlines for compiling proposals from local bodies have already passed without any movement, raising questions about whether South Goa's DPC will even convene to dis-

cuss a plan this year. This delay has broader implications for the region's development. Without a functioning district plan, South Goa risks missing out on funding opportunities and falling further behind in addressing critical needs. Local governance experts have warned that the ongoing stalemate could weaken the district's ability to advocate for its development priorities at the state and

national levels. For now, the future of South Goa's development planning hangs in the balance. As local bodies await clarity on the 2024-25 proposals, the absence of decisive action threatens to derail another year of potential progress, leaving communities without the infrastructure and resources they urgently need.

Minister takes stock of repairs and upgrades on govt buildings

knowledging the challenges faced over the years and celebrating the project's completion as a long-overdue accomplishment.

During the review, several ongoing and upcoming projects were also discussed. The Minister shared updates on the Margao Urban Health Centre (UHC) building, noting discussions with PWD officials about commencing necessary work soon. Additionally, a meeting was held with representatives of the Cavelossim village panchayat to address issues related to the construction of a retaining wall and repairs to a bund along River Sal. Sequeira urged the panchayat to submit essential documentation, citing complications arising from a case currently

under the National Green Tribunal (NGT), which has delayed the process.

The South Goa Planning and Development Authority (SGPDA) areas also came under scrutiny during the review meeting, which assessed the progress of sewage line installations in the region. Officials confirmed that work on these critical infrastructure projects would commence shortly, aiming to address long-pending demands for improved san-

itation facilities. In a bid to streamline public services, the South Goa Collectorate announced a one-day sesacross sion deputy collector offic-

es to address pending applications for regularizing unauthorized structures built before the January 2024 cut-off. This initiative aims to resolve long-standing grievances of residents seeking regularization and provide clarity on compliance procedures.

Moreover, the Goa State Pollution Control Board (GSPCB) will host a session on Ianuary 24 at the South Goa Collectorate to assist various businesses in applying for online consent to operate their establishments by the January 21 deadline. Sequeira emphasized the importance of such initiatives in ensuring transparency, improving public access to essential services, and addressing environmental concerns effectively.

Tourism sector needs visionary leadership, not optics: Vijai

MARGAO: Goa Forward Party (GFP) has criticized the recent Tourism Board meeting chaired by Chief Minister Pramod Sawant, calling it poorly timed and ineffective. The meeting, which was held as the tourism season nears its end, represents a reactive approach to governance,

according to GFP President Vijai Sardesai. He claimed that no Tourism Board meeting had been convened since 2023, and the recent meeting was only called after he demanded the minutes under Legislative Assembly Questions. The Fatorda MLA questioned the timing of discussions on infrastructure improvements, transport regulations, and

tourism season began. Sardesai also raised concerns about the lack of data backing the policv proposals discussed in the meeting. According to Sardesai, the proposals, including infrastructure development at cruise

terminals, regulated taxi fares, and cultural tourism initiatives, were already outlined in the KPMG Tourism Policy but remain unimplemented. "Recycling old announcements does not constitute governance-it is a betrayal of Goa's tourism industry and its stakeholders," he stated.

"Goa's tourism sector is in dire need of visionary leadership, but the government has chosen to be more focused on optics than on delivering results," the GFP President added. He characterized the meeting as a hasty response to criticism rather than a genuine attempt at governance, adding that the lack of a coherent, data-driven, and timely approach was pushing the

state's tourism industry into further decline.

GFP asserted that tourism is the lifeline of Goa's economy, and called for an end to what Sardesai termed the government's "Goa for sale" policy.

Sardesai accused the current administration of prioritizing commissions and vested interests over the welfare of local residents, arguing that tourism should instead empower locals and create

Electricity Department's cable removal leaves parts of **Margao without internet**

MARGAO: Margao residents are voicing frustration as unexpected internet outages have disrupted daily routines, following the Electricity Department's ongoing drive to remove overhead cables from

electric poles. "I work from home and suddenly found myself without internet. No warning, nothing. How are we supposed to manage our work commitments? The power department could have handled this better by giving proper notice," said Maya Naik. Like many others, she pays for an annual internet subscription but is now unable to access the service she paid for.

Rohan Fernandes echoed similar concerns. "The authorities should have at least given us time to make alternative arrangements so we were aware of the disruption. We're not ques-

tioning their authority to remove unauthorised cables, but they could have coordinated with service providers to ensure minimal disruption to end users. I need high-speed internet and not just from the phone," he said.

Executive Engineer (EE) Kashinath Shetye recently spearheaded the Electricity Department's operation to remove unauthorised cables from utility poles in Margao. Leading a team equipped with industrial cutters and a crane, Shetye personally supervised the removal of cable bundles in the Aquem area.

Explaining the necessity of the action, Shetye said, "These cable bundles are compromising the structural integrity of our electric poles. We've observed significant strain on poles wherever these cables are attached, creating a safety hazard for both vehicles and pedestrians."
