

# Coastal police keep a hawk's eye on watersports operators in Calangute

**CALANGUTE:** Panjim coastal police station staff on Monday conducted random checking of documents of watersports operators at Calangute-Baga beach for effective and smooth functioning. The action comes in the wake of the Christmas Day watersports tragedy when an overloaded boat overturned at the Calangute beach, causing the death of one tourist from Khed, Ratnagiri, Maharashtra. Coastal PI Ajit Umarye said they have launched a drive to create awareness about

the safety of tourists. The owners of watersports boats operating from the Bardez coastal belt including Coco Beach in Nerul, Sinquerim, Candolim and Calangute- Baga beach

have been cautioned about the safety measures to be taken for tourist visitors, police said. More than 20 tourists were rescued by lifesavers when the overloaded tour-

ist boat capsized in the waters on Christmas Day. The Captain of Ports has suspended the operating NOC of the boat involved in the accident, GOA-824-WS, registered in the

name of Meena Coutinho with the police registering an offence against Coutinho. Two crew members of the watersports boat were also arrested by the coastal police. It was the second incident of a boat capsizing in Calangute since the start of the new tourist season. On October 10, alert lifeguards averted a major tragedy when a boat carrying a group of 12 tourists from Telangana and Andhra Pradesh for a joyride at Baga beach, overturned throwing them into the sea. Two of the tourists were admitted in hospitals. However, there were no deaths.

## Swiss Foundation begins 2nd hand surgery camp at GMC, 50 patients to benefit

**PANJIM:** Swiss Foundation Groupe Internationale Chirurgiens Amis de la Main (GICAM), has begun its second hand surgery and rehabilitation camp at Goa Medical College (GMC) Hospital, Bambolim.

The initiative aims to enhance advanced hand surgery, rehabilitation, and prosthetic care in the state. The camp, following GICAM's visit in July and August last year, provides hands-on experience to GMC doctors and is expected to benefit nearly 50 patients. On the first day, four complex surgeries were successfully performed.

Addressing a press conference, Goa Medical College and Hospital (GMC) Dean Dr Shivanand M Bandekar said four hand surgeries were conducted at the Goa Medical College, Super Specialty Block, on Monday, January 20. Dr Bandekar said, "This is our second surgery camp with the Goa Medical College as the host hospital along with GICAM. This time we have a bigger team of experts who include five surgeons. We have selected almost 50 to 60 patients. These are the rare cases of hand problems in our state of Goa." "There are certain diseases like congenital hand deformities and Rheumatoid arthritis (RA) where

people are not able to use their hands. There are many patients having suffered burns and require plastic surgery. There are nerve injuries which require expertise. Today we started the camp and operated on four patients," Dr Bandekar said and added that patients who had undergone surgeries during the previous camp are doing very well. Dr Marco Lanzetta Bertani, an internationally renowned Hand Surgeon and Head of the Mission, "We have selected very interesting and challenging candidates. Our idea is to create a centre of excellence in Goa for hand problems. This is what we do at GICAM."

## First curved cable-stayed bridge to be inaugurated at Mormugao today

**VASCO:** Union Minister for Road Transport and Highways, Nitin Gadkari, will inaugurate India's first curved cable-stayed bridge in Mormugao at 6 pm on Tuesday. Ahead of the opening, local MLA Sankalp Amonkar, accompanied by PWD engineers, conducted a joint inspection of the bridge. The Union Minister will also inaugurate Loop 2 of Port Connectivity on National Highway 566. The event will be attended by Union Minister for Ports and Shipping Sarbananda Sonowal, Chief Minister Pramod Sawant, Union Minister of State for Power Shripad Naik, and other dignitaries. According to Amonkar, the Mormugao loop flyover bridge is a landmark project. "Heavy cargo traffic will now use this bridge, thereby reducing dust pollution on internal roads by almost 60 per cent," he stated. "This bridge is a game-changer for the state and especially for Mormugao Taluka. It will significantly reduce the

dust pollution faced by residents of Sada and surrounding areas due to heavy cargo transportation. These vehicles will now use the bridge, bringing much-needed relief to the community.

## 19 tourists rescued over weekend

**Calangute:** Nineteen people, including five foreigners, were rescued from drowning by Drishti life-savers off Goa's beaches over the weekend as strong rip tides and currents swept through the waters. Multiple rescues at Calangute beach saved tourists from Maharashtra, Andhra Pradesh, Tamil Nadu and Telangana.

A 14-year-old from Tamil Nadu caught in a rip current was rescued by life-savers Rakesh Kumar and Sanjay Yadav. In a freak incident, five persons from Maharashtra and Andhra Pradesh were saved after one person from the group started drowning.

At Candolim, two Kashmiri men in their mid-30s were rescued from a rip current by lifesavers using a rescue board and rescue tubes to safely bring the duo back to shore.

At Baga, a 13-year-old Russian girl caught in a rip current off the beach was rescued by a lifesaver with a rescue board.

Two Kazakhstani couples, who were swept 50 metres into the sea, were brought safely ashore at Arambol.

A middle-aged Russian couple, was rescued after being dragged 40 metres into the sea at Morjim by a sudden flash rip current

which suddenly forms in the sea endangering swimmers. A 27-year-old tourist from Jaipur was rescued at Mandrem.

At Palolem river, a 28-year-old from Ponda was rescued by a friend after nearly drowning while a 32-year-old woman and an 11-year-old boy, both from Goa, who were stung by a jellyfish off Agonda beach were administered first aid.

## Police driver arrested in cheque bounce case

**VASCO:** The Vasco police arrested Prasanna Akhadkar (32), a driver posted on a robot vehicle at the Maina-Curtorim police station following a non-bailable warrant issued by the Additional Sessions Court, Margao, for dishonouring of a cheque.

Akhadkar, a resident of Navta, Cortalim, was convicted in a criminal case under Section 138 of the Negotiable Instruments Act. The Court had asked him to pay compensation of Rs 3.20 lakh in a cheque bounce case. Since he failed to pay the compensation amount, he was sentenced to undergo one-year simple imprisonment.

Akhadkar further failed to appear in the criminal appeal proceedings related to his conviction after which the Court issued a non-bailable warrant (NBW) against him. The Court had asked the Vasco Police Inspector to apprehend the accused

## Man falls to death at Grand Island

**VASCO:** In a tragic incident Sachin Dhananjay Naik (37), a resident of Taribhat, died after he fell from a height of 15 metres at Grand Island.

The tragedy occurred when Naik along with his friends was exploring the rocky terrain of Mottar/Grand Island on Sunday evening. All wanted to watch the sunset

The incident occurred when Naik's left leg slipped on the rocks, and he fell

on a rocky cave and sustained multiple injuries. He was rushed to the Primary Health Centre, Cansaulim, where he was declared brought dead by the doctor on duty. The Harbour Coastal Security Police have registered a case of unnatural death under Section 194 of BNSS and after conducting inquest panchanama have preserved the body in the Hospicio South Goa District Hospital morgue, Margao, for further procedures.
