# H-1B Visa: Trump backs 'competent people'

Favours visa for applicants at all levels, not just engineers

PTI, WASHINGTON: US President Donald Trump has said he likes both sides of the argument on the H-1B foreign guest workers' visa, noting that the country needs 'very competent' and 'great' people which is possible through this visa programme.

The latest statement comes in the backdrop of his radical executive order issued on the first day of his second term, titled 'Protecting the Meaning and Value of American Citizenship, Trump stripped away birth right citizenship in the country. This decision will affect all those with temporary visa status in the US — including those who have an H1-B visa.

# R G Kar case: CBI seeks death sentence for Sanjay Roy in HC

HC to hear the CBI, victim's family, convict on January 27

PTI, NEW DELHI: The CBI filed an appeal on Wednesday before the Calcutta High Court, seeking death sentence for Sanjay Roy, who was sentenced to "life imprisonment until death" by a Sealdah court in the rape-cum-murder case of an on-duty doctor at RG Kar Medical College and Hospi-

tal, officials said. The agency made the legal advice that the brutal rape and murder of the 31-year-old trainee doctor comes under the "rarest of rare" category deserving capital punishment, they said.

Highly placed officials said the CBI was unanimous that the case deserves nothing but death penalty, seeing the manner in which the doctor was killed in her medical college.

The CBI's plea seeking death penalty for Roy was turned down by the trial court, where Additional District and Sessions Judge Anirban Das said the crime

The threat of illegal hill-cutting that is laying to waste Goa's verdant but fragile ecosystems has raised its head in Nerul, with Jeanette Fernandes. a senior citizen from the area, filing a writ petition in the High Court of Bombay at Goa to stop the illegal activity.

Based on this, the High Court on Wednesday ordered the Town and Country Planning (TCP) Department to investigate the allegations of illegal hill cutting and commercial activities in the No Development Slope (NDS) area.

trict 10 years ago. Additional District and Session Judge Court-2 of Cumilla Afroza Jesmin passed the order as there was no evidence against 79-year-old Zia, who is now undergoing treatment in London, the state-run BSS news agency reported.

The court observed that the case was filed on political grounds and harassment, the agency said.

The case was filed against 32 people, including Zia, in the Special Powers Act, 1974, at Chouddagram Police Station in Cumilla.

### Many jump off train after false fire alarm. 12 killed by another

PTI, JALGAON: At least 12 passengers were killed on Wednesday evening when they jumped from their Mumbai-bound train in panic due to a false fire alarm, only to be tragically run over by another train on the adjacent tracks here, officials said.

#### **JALGAON ACCIDENT**

The tragedy unfolded when passengers onboard the 12533 Lucknow-Mumbai Pushpak Express, fearing a blaze, hastily jumped onto the adjacent tracks and were run over by the oncoming Karnataka Express heading from Bengaluru to Delhi, they said.

As many as 15 other passengers were injured in the accident, which took place between Maheji and Pardhade stations near Pachora town in North Maharash-

tra's Jalgaon district, when Pushpak Express halted after someone pulled the chain around 4.45 pm, Central Railway officials said.

Dilip Kumar, Executive Director, Information and Publicity, Railway Board, however, denied that any spark or fire inside the coach caused passengers to pull the alarm.

Based on the information that we have received no spark or any fire was noticed in the coach." Kumar told PTI in New Delhi.
