PTI, KOLKATA: The CBI on Friday urged the Calcutta High Court to schedule an early hearing on its appeal seeking death penalty for R G Kar Hospital rape-murder case convict Sanjay Roy. The investigating agency moved the court after the trial court rejected its demand earlier for death penalty to Roy, who was found guilty of the rape and murder of an on-duty doctor at R G Medical College and Hospital on August 9, 2024. A division bench presided by Justice Debangsu Basak, before which the matter was mentioned by deputy solicitor general (DSG) Rajdeep Majumdar seeking an early hearing of the CBI's plea, said it will hear the appeal on January 27 along with a prayer by the West Bengal government over admission of its appeal with a similar plea.
