# **Paragliding only temporarily** suspended, not banned: Min

PANJIM: Tourism Minister Rohan Khaunte clarified that paragliding activities in Goa have been temporarily suspended, not banned. Speaking to reporters, Khaunte explained that organisers must submit the required documents for verification. If no irregularities are found, the department will grant permission for operations to resume.

"There is a clear difference between a ban and a suspension. We have only suspended paragliding activities for the time being," he said.

"Paragliding is an adventurous, extreme sport. Even with all the precautions in place, accidents can still occur. However, we are firm in our commitment to ensuring that proper regulations



are in place. We have stated that anyone engaged in paragliding activities must present the necessary permissions. If their documentation is in order, they will be allowed to continue operations as usual," Khaunte added.

"We are very clear: we want to ensure that all activities are safe and secure for the people of Goa," he concluded. The suspension followed

the tragic deaths of two individuals, including a female tourist from Maharashtra. The victims were identified as Shivani Dabale and Suman Nepali, a paragliding pilot. In response, the tourism department ordered the suspension of all paragliding activities across Goa until further notice.

The clarification comes after Calangute MLA Michael Lobo opposed an outright ban on paragliding in Goa, instead calling for more stringent safety regulations to be enforced. Meanwhile, Shekhar

Raizada, the owner of Hike 'n' Fly, the company running the paragliding activity, has been sent to 14 days of judicial custody. The body of Suman Nepali has been handed over to his family for final rites.

# Dando-Mollo road at Velsao in need of urgent repairs

his is in reference to my letter published in O Heraldo on 27th February 2023, highlighting the deplorable condition of the road at Velsao, Dando-Mollo, in the Cortalim Constituency. The 400-metre stretch from the Mathany Saldanha Bridge to the dead end, which passes through housing areas, is in a dire state and requires immediate attention.

The road surface is severely damaged, with the top layer of hot-mix completely worn out, exposing the second layer. Loose asphalt from the eroded surface has scat-

tered along the CITIZEN SATURNINO PEREIRA entire stretch, making Velsao road slippery

and posing a grave danger to all vehicles. The cracks and uneven texture amplify the risk of accidents, particularly during the monsoons, when the absence of proper drainage leads to further deterioration.

Rainwater flowing from nearby hills inundates the residential areas, soaking into the road surface and accelerating its decay. Proper gutters along residential areas are essential to channel this water and prevent inconvenience to local residents. Unfortunately, despite repeated efforts to draw the attention of the Velsao-Pale-Issorcim Village Panchavat, the issue remains unaddressed.



While the Panchayat has reportedly forwarded this matter to the Zilla Parishad (ZP) and the Public Works Department (PWD), there has been no tangible progress. The road urgently needs a fresh layer of hot-mix and proper drainage to prevent further damage.

On behalf of the residents of Velsao, I earnestly appeal to the Cortalim MLA and the Sarpanch to prioritise this matter and expedite the necessary repairs. Failure to address the issue before the monsoon will likely result in the complete collapse of the road, exacerbating the hardships faced by the community. Immediate action is not just a request, but a necessity.
