S Korean prosecutors indict impeached President Yoon over his martial law

an prosecutors on Sunday indicted the impeached President Yoon Suk Yeol over his imposition of martial law last month, news reports said.

Yonhap news agency reported that the Seoul Central District Prosecutors' Office indicted Yoon over rebellion in connection with his December 3 decree that plunged the country into massive political turmoil. Other South Korean media outlets have carried similar reports.

Sri Lanka Navy arrests 34 Indian fishermen

PTI, COLOMBO: The Sri Lankan Navy arrested at least 34 Indian fishermen and seized three trawlers for illegal fishing in two separate incidents, the authorities said on Sunday.

The fishermen have been arrested for illegal fishing in two separate incidents on January 25 and 26, the Navy said.

Both arrests came off the coast of the northeastern Mannar district in the Navy's continued regular patrols in the Sri Lankan waters to curb illegal fishing, the Navy said.

The arrested fishermen have been handed over to the relevant officials for further action.

N Korea says it tested cruise missile system, vows toughest response to US

70 people killed in attack on hospital in Sudan, says WHO

PTI, DUBAI: Some 70 people were killed in an attack on the only functional hospital in the besieged city of El Fasher in Sudan, the chief of the World Health Organisation said Sunday, part of a series of attacks coming as the African nation's civil war escalated in recent days.

The attack on the Saudi Teaching Maternal Hospital, which local officials blamed on the rebel Rapid Support Forces, came as the group has seen apparent battlefield losses to the Sudanese military and allied forces under the command of army chief Gen Abdel-Fattah Burhan. That includes Burhan appearing near a burning oil refinery north of Khartoum on Saturday that his forces said they seized from the RSF.

International mediation attempts and pressure tactics, including a US assessment that the RSF and its proxies are committing genocide and sanctions targeting Burhan, have not

halted the fighting. Reported attack follows RSF warning In the Saudi hospital attack in El Fasher. WHO Director-General Tedros Adhanom Ghebreyesus offered the death toll in a

post on the social platform X. Officials and others in the capital of North Darfur province had cited a similar figure Saturday, but Ghebrevesus is the first international source to provide a casualty number. Reporting on Sudan is incredibly difficult given communication challenges and exaggerations by both the RSF and the Sudanese military.

The appalling attack on Saudi Hospital in El Fasher, Sudan, led to 19 injuries and 70 deaths among patients and companions. Ghebreyesus wrote. At the time of the attack, the hospital was packed with patients receiving care.

Another health facility in Al Malha also was attacked Saturday, he added.

We continue to call for a cessation of all attacks on health care in Sudan, and to allow full access for the swift restoration of the facilities that have been damaged, he wrote. Above all, Sudan's people need peace. The best medicine is peace.

Ghebreyesus did not identify who launched the attack. though local officials had blamed the RSF for the assault. United Nations official Clementine Nkweta-Salami, who coordinates efforts for the world body in Sudan, warned Thursday that the RSF earlier had given a 48hour ultimatum to forces allied to the Sudanese Armed Forces to vacate the city and indicated a forthcoming offensive.

B'desh's first army chief KM Shafiullah dies

PTI, DHAKA: Bangladesh's first Army chief and sector commander of the 1971 Liberation War against Pakistan Maj Gen (retd.) K M Shafiullah died on Sunday. He was 90.

"He breathed his last while undergoing treatment at the Combined Military Hospital (CMH) in Dhaka," the army said in a statement. He was admitted to the hospital on January 2, the army said.

He was suffering from multiple health complications like diabetes, hypertension, thyroid issues, fatty liver, and dementia.

government's Interim Chief Adviser Muhammad Yunus expressed deep shock at the death of Mai Gen (retd.) Shafiullah, saying he played an important role as a sector commander during the 1971 Liberation War. "We remember with grat-

itude his contribution to the country and its people. People from all walks of life in Bangladesh will remember his heroic works forever with respect," he said.

Shafiullah was the second-in-command of the Pakistani Army infantry's Second East Bengal Regiment stationed in Joydebpur on the outskirts of Dhaka in 1971.

He led the "S" Force during the Liberation War and received the title of "Bir Uttam". After the country achieved independence, he was appointed the first army chief.

From 1976 to 1991, he served as Bangladesh's ambassador to various countries, including Malaysia, Canada, Sweden and England.

Foreign investors withdraw ₹64k cr from Indian equities in Jan

Rupee depreciation, rising US bond yields, lackluster earning season hurting sentiment

AGENCY, NEW DELHI: Foreign portfolio investors (FPIs) have withdrawn Rs 64,156 crore from the Indian equities market so far in January 2025, in an unabated exodus amid Rupee depreciation, rise in United States bond yields and expectations of an overall tepid earnings season, according to a report.

FOREIGN FUND OUTFLOW

The selling shows a reversal in investor sentiments since December 2024, when investors poured in Rs 15,446 cr in Indian equities throughout the month, as per data with the

depositories, the report added. "The continued depreciation in Indian rupee is exerting significant pressure on foreign investors leading them to pull the money out of the Indian equity markets," Himanshu Srivastava, Associate Director -Manager Research, at Morningstar

Investment Advisers India told PTI. In addition to that, higher valuation of Indian equities, despite recent corrections, expectation of a rather tepid earning season and

macroeconomic headwinds are making investors wary, he said.

Moreover, the unpredictable nature of Donald Trump's policies has also prompted investors to tread cautiously and made them stay away from riskier investment ave-

nues, he added. According to the data, FPIs offloaded shares worth Rs 64,156 crore from Indian equities so far this month (till January 24). FPIs have been sellers on all days this month except January 2.

"The sustained strengthening of the dollar and rise in the US bond yields have been the principal factors driving the FII selling. So long as the dollar index remains above 108 and the 10-year US bond yield

remains above 4.5%, the selling is likely to continue," V K Vijayakumar. Chief Investment Strategist, Geojit Financial Services, said.

In terms of sectors, the financial segment has been bearing the brunt of FPI selling as the bulk of their assets under management is in this sector, on the other hand, IT witnessed some buying in the wake of improved prospects for the sector and the positive management commentary.

Since US bond yields are attractive. FPIs have been sellers in the debt market, too. They withdrew Rs 4,399 crore from debt general limit and Rs 5,124 crore debt voluntary retention route. The overall trend indicates a cautious approach by foreign investors, who scaled back investments in Indian equities significantly in 2024, with net inflows of just Rs 427 crore.

This contrasts sharply with the extraordinary Rs 1.71 lakh crore net inflows in 2023, driven by optimism over India's strong economic fundamentals. In comparison, 2022 saw a net outflow of Rs 1.21 lakh crore amid aggressive rate hikes by global central banks.

JK Cement to buy 60% stake in **Saifco Cements**

PTI, NEW DELHI: JK Cement, one of the leading cement producers, has said it will acquire a 60 per cent stake of Saifco Cements in a deal through which it will enter into the Jammu & Kashmir market.

The JK Group firm will acquire a 60 per cent stake in Saifco Cements, which has an integrated manufacturing unit at Khunmoh in Srinagar, at a valuation of Rs 174 crore, according to a joint statement.

Saifco's integrated manufacturing unit in Srinagar is spread across 54 acres of land and has a clinker capacity of 0.26 MTPA and grinding capacity of 0.42 MTPA.

Besides, it has captive limestone reserves 144.25 spread over hectares with a total minable reserve of 129 million tonnes.

"The acquisition will help the company expand its footprint into the state of Jammu and Kashmir Region," it said.
