The 40-year-old man, a native of Solapur, had come to Pune, where he is suspected to have contracted the disease, according to officials.

BICHOLIM: A day after Mulgao villagers along with panchayat members marched to the Bicholim mining block-I and stopped the extraction of iron ore as it was causing sound pollution in the village, their meeting with the Vedanta Limited remained inconclusive on Monday, with the locals claiming that the company officials gave
