Waqf panel accepts ruling alliance's amendments in 14 clauses, rejects Oppn-sponsored changes

PTI, NEW DELHI: The parliamentary committee scrutinising the Waqf bill is set to propose that existing "Waqf by user" properties will remain so if not in dispute or are government facilities but they must be registered before the new law takes effect, providing little relief to Waqf bodies in their unverified title claims.

Opposition MPs on Monday proposed amendments in all 44 clauses of the Waqf (Amendment) Bill, seeking to mostly restore the provisions of the current Act, and claimed that the law proposed by the committee in its report would maintain the Bill's "draconian" character and the bid to interfere in the religious affairs of Muslims.

While the accepted amendments make some concessions to Muslim bodies criticising the Bill, including leaving it to Waqf boards to decide on welfare measures for widows and orphans, among others, instead of mandating it by law, a few of them may

further irk the critics. The meeting of the joint parliamentary committee headed by BJP MP Jagdambika Pal was again marked by noisy protests by opposition members, who accused him of "subverting" democratic process.

The panel is set to adopt its report on Wednesday with MPs of opposition parties such as the Congress, TMC, DMK and the

AIMIM expected to give their dissent, sources said. The committee will now meet for one last time, likely on Wednesday, the timing for which was notified on Monday.

All 32 amendments proposed by BJP MPs and their allies from the TDP and the JD(U) were accepted. Opposition MPs put forward more than 500 amendments at Monday's meeting. With Parliament's Budget Session

set to begin on January 31, the ruling BJP-led National Democratic Alliance can get the Bill passed in the first half of the session as it enjoys a majority in both the Lok Sabha and the Rajya Sabha, they added.

Among the amendments that may draw further objection from Muslim groups and opposition parties is that a Waqf board can now have even four non-Muslim members instead of two.

One of the changes proposed by the panel said "two of total members of the Board appointed under this sub-section, excluding ex-officio members, shall be non-Muslim", the sources said.

The phrase "excluding ex-officio members" did not feature in the Bill.

While the Bill states that only a person practising Islam for at least five years may declare a Waqf, which refers to properties dedicated exclusively for religious or charitable purposes under Islamic law, an approved amendment adds that such a per-

son should be showing or demonstrating that he or she is practising the religion for five years, according to the sources.

Unnao case convict Kuldeep Sengar surrendered in Tihar, Delhi HC told

PTI, NEW DELHI: Unnao rape case convict Kuldeep Singh Sengar, granted interim bail on medical grounds, is back to Tihar as the doctor was unavailable, his counsel told the Delhi High Court on Monday.
A bench of Justices Yashwant Varma and Harish Vaidyanathan Shankar learnt from the counsel that Sengar returned to the jail on January 24 as an AIIMS surgeon, supposed to perform his eye

surgery, was not available till January 30.
He said Sengar, serving a life term in the case, would move court again either on January 28 or 29, to seek medical bail for his cataract surgery.
The court asked the counsel to start arguments on Sengar's appeal in the case under the Protection of Children against Sexual Offences Act which would be heard in February.

Manipur Cong files petitions seeking disqualification of 4 NPP MLAs

PTI, IMPHAL: Opposition Congress in Manipur on Monday filed disqualification petitions against four National People's Party (NPP) MLAs for extending support to the BJP-led government, despite the party officially severing ties with the ruling front two months ago.
Manipur Congress vice-president Hareshwar Goshwami filed four different petitions against the MLAs at the Speaker's Tribunal of the state assembly,

the petitioner's advocate N Bupenda Meitei told PTI. "My client has filed the petitions against four NPP legislators for extending support to the BJP-led government in the state. They had joined a meeting convened for the ruling MLAs by the chief minister," he said.
Meitei said the NPP MLAs attended the meeting, although the NPP national president had already withdrawn support to the BJP-led govt in Manipur.

Concern over hundreds of dead Olive Ridley turtles washed ashore in Chennai

PTI, CHENNAI: The Tamil Nadu government on Monday said it has stepped up measures to conserve the Olive Ridley turtles, amidst reports of several hundreds of sea turtles getting washed ashore dead along Chennai's coastline for the past few days, causing concern to environmentalists.
The Olive Ridley turtle nesting in the coastal areas will be monitored and protected, the government said, and warned fishermen of stringent action if they were found using trawl nets within five nautical miles (9.26 km) in the coastal areas of Chennai, Chengalpattu, Cuddalore, Villupuram, Nagapattinam,

Ramanathapuram, Thothukudi, and Kanyakumari districts.
Fishing with trawl nets has already been banned within five nautical miles from the coast and during

the nesting season trawl nets should not be used without the installation of a Turtle Expulsion Device (TED), an official release here said.
"Strict action will be tak-

ing under the Tamil Nadu Marine Fisheries Regulation Act, 1983, against any violation. Fishermen have been advised not to switch off GPS devices at some locations while fishing or operating at sea," the release warned.
A special task force has been formed with representatives from the Indian Coast Guard, Fisheries and Forest Departments, Marine Fisheries Regulatory Division, and the Tamil Nadu Coast Guard under the Principal Chief Conservator of Forests to exchange information on sea turtle movement/ breeding and ensure conducive atmosphere for the sea turtles to breed.
