### Political firestorm over South Goa SP's transfer

PANIIM: Activists and Opposition politicians have slammed the unceremonious transfer of senior IPS officer Sunita Sawant from her post as South Goa SP even as theories abound as to what could have led to the axe falling on her.

In fact, Sawant had received the Special Recognition Award on Republic Day for her planning skills and for ensuring the peaceful conduct of the 2024 Lok Sabha elections in Goa. Two days later, on the night of January 28, when she was removed from her post, via wireless message issued by Goa Police top brass, the decision was met with mixed reactions of anger, confusion and speculation.

The wireless message sent from the police control room in the wee hours of Tuesday, asked her to vacate the office and report to the police headquarters, Panjim, immediately - going against court guidelines that recommend a minimum three-year posting for SPs.

A few hours before her transfer was effected, SP Sawant had issued a private message to all police stations in her jurisdiction, directing inspectors to gather information on the movements of senior functionaries of the Bajrang Dal.

### Site of fatal brawl, Arambol shack to be pulled down

Shack licence owner slapped with Rs 25 lakh fine; minister admits difficulty in monitoring shacks

**PANJIM:** Days after a brawl at his shack led to the death of a local villager in Arambol, the Department of Tourism has cancelled the shack license issued to Manuel Espritosanto Fernandes and imposed a hefty penalty of Rs 25 lakh. Fernandes is accused of subletting his shack at Arambol beach to a third party, whose workers were involved in an assault that led to the death of Amar Bandekar, the villager.

The Tourism Department has ordered Fernandes to demolish the shack within seven days, warning that failure to comply will result in the demolition being carried out at his own expense, with costs recovered as arrears of land revenue. Additionally, Fernandes has been permanently black-


The department's action follows a report submitted by the Mandrem Police Inspector on January 27, 2025, which confirmed Tourism Minister Rothat Fernandes had violathan Khaunten expressed

ed Clause 20 of the Tourism Shack Policy by subletting the shack. As part of the penalty, the security deposit paid by Fernandes has been forfeited to the government treasury.

On Wednesday, Pernem SDPO Ashish Shirodkar along with Mandrem PI Sherif Jacques held a meeting with shack owners from Arambol, Mandrem, Morjim and Keri areas and sternly warned them not to take law in their hand. The shack owners were also instructed to shut their shacks by 11 pm.

This is not the first case of subletting. In September 2023, the Department of Tourism imposed Rs 10 lakh as fine on Raymond Zeno Fernandes from Calangute for subletting his shack. His security deposit was also forfeited.

#### **Marriage of two** Hindus can't be dissolved within a year: Allahabad HC

PTI, PRAYAGRAJ (UP): The Allahabad High Court has observed that marriage between two Hindus is sacrosanct and it cannot be dissolved within one year of marriage unless there is exception al hardship or depravity as provided under the Hindu Marriage Act.

The order was passed by a twojudge bench of Justices Ashwani Kumar Mishra and Donadi Ramesh. The couple - Nishant Bharadwaj and Rishika Gautam - had filed for mutual dissolution of marriage under Section 13-B of the Hindu Marriage Act. 1955. However, it was rejected by the Family Court in Saharanpur on the ground that the minimum period for moving the application as provided under Section 14 of the Act had not elapsed.

In its January 15 judgment, the division bench dismissed the first appeal filed by Bharadwaj challenging the Family Court order, leaving it open for the two parties to move a fresh application after the expiry of one year. It was observed that except for mutual incompatibility, no exceptional circumstance was shown to exist to allow the parties to file for divorce within one year of marriage.

# Panjim's meat vendors fought hard, and now they can smile again

Meat traders hail SC directive to CCP giving them space for stalls in market

PANJIM: It's a battle for livelihood that was fought right up to the Supreme Court, and now that they have finally got a favourable ruling, the meat vendors of Panjim are cautiously optimistic about their future.

The Supreme Court on Tuesday had directed the Corporation of the City of Panjim (CCP) to allocate fixed spots to the meat vendors in a temporary shed being constructed for the rehabilitation of fish vendors at the old fish



market complex.

All Goa Beef Vendors Association president, Mannasab Bepari, hailed the verdict, stating, "We are satisfied with the Supreme Court order. The judge heard our grievances and acknowledged that rehabilitation. We are now

we need to be rehabilitated. Our lawyers, former Additional Solicitor General Atmaram Nadkarni and Advocate Rohit Bras De Sa, also presented our case and convinced the court of the need for our

expressed relief, saying, "We are extremely happy that we have received justice. We were the rightful occupants of the fish market building until it was demolished. In October 2024, the High Court had instructed CCP to frame a scheme for the meat vendors within six months. but the Corporation challenged the order in Supreme Court. Our livelihoods were impacted over the last six months as we were unable to conduct

CCP Market Committee Chairman and Councillor Bento Lorena confirmed that the Corporation would comply with the court's ruling. "We will follow the Supreme Court's instructions and provide six spots to the meat vendors in the fish market. Additionally, we will make provisions for them to store refrigerators. Vendors will be required to pay sopo (tax) to the CCP, and they will be allowed to occupy these spots until the new building is completed," Lorena said.
