# Margao municipality truck caught dumping waste in open area

Vigilant residents of Peda- Margao compel sanitation workers to re-load the waste and clean up the site; demand police action against civic body

MARGAO: In a shocking embarrassment to local governance, the Margao Municipal Council (MMC), which has repeatedly claimed to have an efficient waste management system, was caught violating its own waste disposal norms, triggering outrage among residents.

On Wednesday, locals spotted an MMC truck unloading waste in an open space in the Peda-Margao area, an act that not only contradicts the civic body's stance on waste management but also raises serious concerns about the effectiveness of the system. Furious with what they witnessed, residents called for the police to take strict action against the Municipality, including penalties for creating a public nuisance in their locality.

Savio Coutinho, a Mar-

gao resident and activist, expressed his frustration with the repeated lapses in Margao's waste management practices. He emphasised that if individuals and private establishments face fines and penalties for improper waste disposal, the Municipality should also be held accountable.

"This is how the civic body is handling waste within its jurisdiction? It is completely unacceptable to simply shift waste from one site and dump it in another public space," Coutinho said, pointing out the sheer negligence on the part of the authorities.

He further questioned the use of taxpayer money on what he described as a "failing waste management model." He noted that this was not an isolated incident, alleging that MMC trucks had been spotted on multiple

occasions dumping garbage in open spaces rather than following proper disposal procedures at the Sonsoddo waste treatment facility.

In response to the incident, a group of residents in Peda-Margao took matters into their own hands. They confronted the municipal workers on-site and forced them to reload the waste and clear the area.

Repeated attempts to reach MMC Chairperson Damodar Shirodkar for his comments on the incident were futile, as he remained unavailable.

Meanwhile, another resident, Rupesh Naik, raised concerns over additional waste disposal violations by MMC staff. He claimed that several residents had witnessed municipal workers burning garbage early in the morning, an act that not only creates environmental pollution but also poses a serious health hazard to the community.

The Municipal Council is quick to penalise residents and commercial establishments for littering or illegal dumping, yet here they are, committing the very same offence without consequence. This only highlights the deeprooted flaws in the waste management system - Savio Coutinho, former MMC Chairperson

The incident has sparked widespread criticism, with locals questioning whether the civic body will take responsibility for its mismanagement or if such violations will persist without consequence. Residents are now urging higher authorities to intervene and ensure that waste management regulations are enforced uniformly, regardless of whether the violator is a citizen or the Municipality itself.

was necessary. "Let the people be involved. The committee will work alongside the government," he said.

A fresh controversy arose over missing CCTV footage. Costa Frias pointed out that Anjuna Police had failed to provide footage requested by the court on January 15. In its affidavit, police claimed that footage from 21 establishments had been overwritten due to DVR storage limits. Expressing dissatisfaction, Justice Karnik ordered authorities to submit footage of post-10 PM music violations before the next hearing on February 4. "You need to provide the CCTV footage," said Justice Karnik. "We will finalise the Noise Monitoring Committee during the next hearing on February 4 after which, we will file a comprehensive order," he concluded.

Siolim resident Aaron Fernandes, present at the proceedings, criticised the State's inaction. "It's clear the noise pollution offenders want the ball back in the government's court. If needed, I'll file another PIL," he said, recalling an incident where he was denied beach access in Anjuna due to a private party.

#### Traffic reforms planned to ease congestion in Fatorda

Sardesai vows action against encroachments, rent-a-car vehicles parked on the streets

MARGAO: Over the next 10 days, traffic police and other agencies will focus on raising public awareness about road discipline and proper parking in an effort to alleviate traffic congestion in the Fatorda area.

On Wednesday, Fatorda MLA Vijai Sardesai, along with his councillors, Goa Forward Party workers, supporters, traffic police, and Margao Municipal Council (MMC) officials, conducted an inspection from St. Joaquim Circle to Jackson Bar in Borda to assess and discuss potential solutions to improve traffic flow.

During the inspection, Sardesai raised concerns over the presence of unsightly overhead TV and internet cables, emphasising that Fatorda already has underground cabling infrastructure in place. "Overhead cables are an eyesore and should be removed immediately," he said, advocating for a cleaner and more organized urban environment.

The team discussed various strategies to improve traffic conditions for both residents and commuters. These included the construction of slip roads, the potential relocation of a chapel in Borda, and the establishment of designated parking lanes for cars and bikes in front of the Multipurpose College.

Sardesai also highlighted the issue of rent-a-car businesses occupying roadside spaces along Borda Road.

"I will write to the RTO urging strict action against rent-a-car owners who misuse widened roads as parking lots. Roads are meant for traffic movement, not private businesses to park their vehicles," he stated.

Sardesai also announced that traffic police and other relevant agencies would focus on public awareness regarding road discipline and proper parking over the next 10 days. During this period, road markings will be drawn, and slip roads will be constructed. After this awareness phase, stricter enforcement measures, including fines and challans, will be implemented. "Without discipline, our constituency cannot progress," he added.

The MLA raised serious concern with regard to improper parking, lack of civic sense, and corruption within local bodies—allowing businesses to encroach on public roads—have been major contributors to the growing traffic problem.

# South Goa police intensify action against tobacco violations, book 5,224 cases in 2024

MARGAO: Police in South Goa ramped up enforcement of the Cigarettes and Other Tobacco Products Act (COTPA), booking 5,224 cases in 2024, a sharp rise from the 3,924 cases registered in 2023.

Despite the law restricting the sale of tobacco within 100 yards of educational institutions, Margao resident Sandeep Pednekar noted that enforcement gaps remain. "Sale of cigarettes and vapes continue. Display boards prohibiting tobacco sales to minors are required at points of sale and outside educational institutions, but it appears that very few have complied," he said.

va (240). Other police stations during the same period in 2022. registering violations included Maina-Curtorim (176), Cuncolim (251), Fatorda (164), By December 2022, a total of 3,401 cases had been recorded. Among the top enforcers in Quepem (88), Curchorem 2022 were Dabolim Police (516

(169), Sanguem (203), Canacona (182), and Verna (133). COTPA, 2003, prohibits smoking in public places such as theatres, hospitals, transport hubs, restaurants, bars, offices, markets, and educational institutions, with designated smoking zones allowed only in specified locations.

Advocate Vinay stressed the importance of enforcing Section 6(a) of the Act, which prohibits the sale of tobacco to minors. "Vendors must verify a buyer's age, but this rarely happens. Smoking among underage youth remains rampant," he said.

Section  $\hat{6}(b)$  restricts the sale of tobacco within 100 yards of educational institutions, yet activists say violations persist. Social workers have urged stricter implementation, particularly ensuring required display boards are installed at sales points and schools.
