## खनिज डंप लिलाव रद्द करण्याची गोवा फाऊंडेशनची मागणी

कायदेशीर तरतुदींचे उल्लंघन करणाऱ्या आणि सार्वजनिक हिताशी तडजोड करणाऱ्या कोणत्याही लिलावाला आव्हान देण्यास ते वचनबद्ध आहेत. परिणामी, गोवा फाऊंडेशनने आगामी लिलाव तात्काळ रद्द करण्याची मागणी केली आहे आणि योग्य खाण भाडेपट्टे मंजूर झाल्यानंतर आणि सर्व आवश्यक मान्यता मिळाल्यानंतर, डंपवरील तज्ज्ञ समिती आणि एमएमडीआर कायदाच्या तरतुदीच्या शिफारशीनुसार, नवीन प्रक्रिया राबवण्याची मागणी केली आहे.

## हिंस रॉटवेलरने घेतला युवकाचा चावा

पोलिस स्थानकात येऊन तक्रार दाखल केली. यापूर्वी ऑगस्ट २०२४ मध्ये अशाच एका रॉटवेलर कुत्र्याने हल्ला करून एका लहान मुलाचा जीव घेतला होता. हल्ल्यामध्येच ही घटना घडली होती. या घटनेमुळे या जातीच्या कुत्र्यांच्या पाळणुकीवर पशुवैद्यकीय विभागाचे बंदी आणली होती. मात्र, असे असतानाही रॉटवेलर जातीचे हिंस कुत्रे कसे काय पाळले जातात ? आणि जर पाळले जात असतील तर त्यांची पशुवैद्यकीय विभागात नोंदणी करण्यात येते का ? असा प्रश्न साक्षात्कार यांनी उपस्थित केला आहे. बंदी असलेल्या रॉटवेलर आणि अन्य हिंस जातीच्या कुत्र्यांची पाळणूक होत असले आणि ती इतरांना धोकादायक ठरत असेल तर त्याविरोधात तातडीने कडक कारवाई झाली पाहिजे, अशी मागणी साक्षात्कार यांनी केली आहे.

## महाकुंभमेळ्यात पुन्हा अग्नीतांडव

परवानगीशिवाय उभारण्यात आल्याचे समोर आले असून ही माहिती जवळच्या पोलीस ठाण्यात कळवण्यात आली आहे. याआधी २० जानेवारीलाही महाकुंभा मेळ्यादरम्यान भीषण आग लागल्याची घटना घडली होती. यामध्ये गीता प्रेसच्या छावणीसह मोठ्या प्रमाणात तंबू जळून खाक झाले होते. त्यानंतर काही जण जखमी झाल्याचीही माहिती समोर आली आहे. तर काल गेवाचेंगरीची घटना घडल्याने देखील लोकांमध्ये खळबळ उडाली होती.

## बजेट २०२५ : भारताला मंदीतून बाहेर काढण्याचे आव्हान

काही अर्थातज्ज्ञांच्या मते देशात आधीच आर्थिक मंदी सुरू आहे. आता त्याची धग मध्यमवर्गापर्यंत पोहोचत आहे आणि काढवित त्यामुळेच आयकर सवलत वाढवण्याची मागणी जोर धरू लागली आहे पण ही परिस्थिती कोविडच्या आधीही होती आणि विशेषतः नोटबंदीनंतर आणि जीएसटी लागू झाल्यानंतर, अर्थव्यवस्थेत मंदी सुरू झाली होती. कोविडमुळे बिघडलेली परिस्थिती अद्यापही पूर्णपणे सुधारली नसल्याचे तज्ज्ञांचे मत आहे. दुसरीकडे, रोजगार देखील वाढत नाही, विशेषतः योग्य उत्पन्न असलेल्या नोकऱ्या. त्यामुळे मागणीवरही त्याचा परिणाम झाला आहे. या दोन्ही गोष्टी एकमेकांशी संबंधित असल्याचे तज्ज्ञांनी म्हटले आहे, या परिस्थितीचा विचार करता सरकारने काही पावले उचलली पाहिजेत, ज्यामुळे मागणीच्या कमतरतेच्या समस्यांवर मात करण्याचा प्रयत्न होईल, अशी अनेकांनी या बजेटमधून अपेक्षा व्यक्त केली आहे.

## पोलिस कारभारात

### राजकीय हस्तक्षेप अटळ : जाँज

हवे असता तेव्हा ते चुन्या वापर करतात आणि जेव्हा त्यांना नको तेव्हा तुऱ्हाला काढून टाकतात, असे ते म्हणाले. पोलिस व्यवस्थेतील राजकीय हस्तक्षेप कधीही कमी होणार नाही. तो फक्त वाढतच जाईल. त्यांनी अधिकाऱ्यांना तटस्थता राखण्याचा सल्ला दिला, असे सुचवले की बदल्यांद्वारे अपमान टाळण्याचा एकमेव मार्ग म्हणजे राजकीय वर्गापासून समतोल राहणे. दुसऱ्या काळी वरिष्ठ पोलिस अधिकाऱ्याने असे सुचवले की सावंत यांची बदली राजकीय वर्गाशी असलेल्या तिथ्या जवळकतेचा परिणाम असू शकते. राजकारण्यांच्या खुप जवळ असल्याने त्याचे फायदे होतातच, तसेच त्याचे प्रतिकूल परिणामही होतात, असे त्या अधिकाऱ्याने नमूद केले. त्या अधिकाऱ्याने पुढे म्हटले की, ज्या अधिकाऱ्याचा सेवा रेकॉर्ड उत्तम आहे त्याला नोकरी गमावण्याची भीती बाळगण्याची गरज नाही. जास्तीत जास्त, त्यांची बदली होऊ शकते, परंतु चांगल्या सेवेचा रेकॉर्ड अधिकाऱ्याला वाईट परिणामांपासून वाचवेल, असे वरिष्ठ अधिकाऱ्याने निष्कर्ष काढला.
