Modi, Yogi must take responsibility for stampede at Kumbh and quit: Cong

PTI, MUMBAI: Maharashtra Congress head Nana Patole on Thursday said Prime Minister Narendra Modi and Uttar Pradesh Chief Minister Yogi Adityanath should resign, taking moral responsibility for the stampede tragedy at the Maha Kumbh in Prayagraj.

There is so much of "event baazi" and only banners of PM Modi and Adityanath are seen at the Kumbh, he claimed.

At least 30 persons died and 60 others were injured in the pre-dawn stampede on Wednesday in Sangam area of the Maha Kumbh at Prayagraj in Uttar Pradesh, as millions of pilgrims jostled for space to take a holy dip on the occasion of 'Mauni Amavasya'.

The Maha Kumbh kicked

off on January 13 and will continue till February 26. Talking to PTI Videos, Patole claimed, "Both Yogi

Adityanath and PM Modi have turned Kumbh into an event. You will see only their posters and banners every-

where. They must take responsibility of the tragedy.' He further claimed that death toll in the stampede was higher than the official

figure. 'Both Yogi and Modi must step down from their posts. If you see Kumbh, there is so much of 'event baazi'

that you will see only their banners across Kumbh. They have to take responsibility for this incident."

A day after the stampede, the Uttar Pradesh government ramped up efforts to ensure crowd management and safety of devotees who continued to flock the Mahakumbh Nagar in large numbers for the religious gathering.

The area would remain a no-vehicle zone until the crowd disperses completely, Superintendent of Police (Traffic) Anshuman Mishra said.

Essential services such as police administration vehicles, ambulances and suction machines would be allowed entry as they are crucial for the smooth management of the Maha Kumbh, Mishra said.

Modi govt is marching India into 'middle income trap': Cong

PTI, NEW DELHI: Ahead of the Union Budget, the Congress on Thursday came out with a 'Real State of the Economy' report claiming that the Modi government is marching India forward into the middle income trap, which will make the country uncompetitive, underproductive and unequal.

The opposition party also said that India's GDP growth for 2024-25, as per government data, is expected to be 6.4% but this rate of growth is not a cause for celebration as India needs a sustained GDP growth of 8 per cent

if it wants to encash its historic demographic dividend.

AICC Research Department chairperson Professor M V Rajeev Gowda and his team have compiled the report, which was released by senior Congress leader and former finance minister P Chidambaram at the party's AICC office at 24, Akbar Road here on Thursday.

India has over the last few years consistently failed to achieve targets, the report said, claiming that the Modi government is marching India forward into the middle

income trap, "which will make us uncompetitive, underproductive and unequal".

"GDP growth in the 6% range is insufficient to create jobs for our growing youth population, especially when rapid technological change is disrupting the future of jobs. It will keep India stuck in a state of high inequality, where two-thirds of our population remain dependent on free grains from the government, while the Prime Minister's favoured few accumulate wealth rapidly," said the report titled 'What happened to growth'.

Crowd control tightens as pilgrims flock to Maha Kumbh

PTI, MAHAKUMBH NAGAR: A day after a stampede at the Maha Kumbh left 30 people dead, the Uttar Pradesh government ramped up efforts to ensure crowd management and safety of devotees who continued to flock here in millions for the religious gathering.

The devotees were undeterred by the pre-dawn chill and reduced visibility due to the dense fog in their bid to take a dip in the Sangam and at other ghats here on Thursday seeking 'moksha' or salvation.

Shelve Waqf Amendment Bill, AIADMK tells Centre

PTI, CHENNAI: The Opposition AIADMK in Tamil Nadu on Thursday urged the Centre to shelve the Waqf Amendment Bill, respecting the sentiments of the minorities.

The quick approval of the draft by the Joint Parliamentary Committee on the Waqf Amendment Bill after rejecting the recommendations made by various parties was 'unacceptable,' AIADMK general secretary Edappadi K Palaniswami said.

Waqf properties across India, including those in Tamil Nadu, were governed by the Waqf Act 1995, he said. Against this backdrop, the proposed Amendment by the BJP government was likely to deprive Muslims of their rights over the Waqf properties and facilitate encroachment.

PTI, NEW DELHI: The Opposition expressed strong protests at an all-party meeting against the functioning of the joint parliamentary committee on the Waqf Amendment Bill, Congress leader Jairam Ramesh said on Thursday, claiming that such panels have been reduced to a "farce".

On Thursday, the government convened a meeting of floor leaders of all political parties ahead of the Budget session of Parliament.

"In the traditional pre-session All-Party

meeting this morning, all Opposition leaders have expressed their strongest protest on how the JPC on the Waqf Amendment Bill was made to function," Ramesh said in a post on X. "It has made a complete mockery of all parliamentary traditions and practices. Such committees used to be a force to be reckoned with - now they have been reduced to be a farce to be reckoned with," the Congress general secretary in-charge communications said.

Kumbh stampede: Some reunited, many still missing

PTI, MAHAKUMBH NAGAR: More than 36 hours have passed since the stampede at Maha Kumbh, but Jitendra Sahu has not caught a wink and has been frantically searching for his 70-year-old aunt Shakuntala Devi, who has been missing since. Shakuntala Devi had arrived at the Maha Kumbh from Gwalior with a group of 15 devotees.

"We have had no contact with my aunt since the incident. She has an identity card around her neck. Her phone is unreachable and she has not contacted anyone. We don't know what to do," he told PTI in a choked voice.
