Maharashtra village passes ballot paper voting resolution

PUNE: A gram panchayat in Maharashtra's Sangli district has passed a resolution supporting the use of ballot papers instead of EVMs in future elections to "protect the Constitution," a gram sabha member has said. Bahe village in Walva tehsil of Sangli district is perhaps the second village in western Maharashtra to pass a resolution discarding EVMs for ballot papers. In December, the gram sabha of Kolewadi village in Karad (south) constituency in Satara district resolved to cast votes in future polls on ballot papers. "The gram sabha in Bahe village passed a resolution recently supporting the use of ballot papers in all future elections instead of Electronic Voting Machines. We also appeal to other villages and their respective gram panchayats to pass similar resolutions to safeguard and protect the Constitution and democracy," said a Bahe gram sabha member.

TMC slams UP govt over 'rape-murder'

of Dalit woman in Ayodhya KOLKATA: The TMC on Monday criticised the Uttar Pradesh government after the recovery of a 22-year-old Dalit woman's mutilated body in Ayodhya, alleging that the northern state under the BJP rule is a "land of fear, atrocities and injustice". The party questioned Chief Minister Yogi Adityanath's claims of maintaining law and order. "Uttar Pradesh under @BJP4India's rule is a land of fear, atrocities, and injustice. A 22-year-old Dalit woman's mutilated, unclothed body was found in a canal in Ayodhya - her eyes gouged out, her body bearing deep wounds and fractures. Her family alleges gang rape and murder, yet the BJP government remains silent. No arrests. No accountability," the TMC claimed on X.

Drone found in border area of **Puniab's Amritsar**

CHANDIGARH: A drone was seized from a field near the India-Pakistan international border in Punjab's Amritsar district, a BSF official said on Monday. Acting on specific information, the Border Security Force (BSF) troops conducted a search operation in the border area of Amritsar on Sunday and a drone was seized from a field near Khanwal village, said the official. The BSF troops have thwarted yet another intrusion of a drone from across the border, said the official.

Man arrested for opening fire during land dispute in Jammu

JAMMU: A man was arrested for firing shots during a land dispute that escalated on the outskirts of Jammu on Monday, officials said. The police action followed after a video of the incident, which occurred in the Lale Da Bagh area under the limits of Domana police station, went viral on social media. The dispute arose on Saturday over 21.5 marlas of land between Rekha Devi and Brij Raj Singh, the brother of the land's previous owner Brij Bhushan Singh Jamwal, police said. During the confrontation, Brij Raj Singh allegedly fired three shots though no one was injured in the firing, they said. Police have arrested Brij Raj Singh and booked him under the Arms Act, while two others are expected to be apprehended soon, the officials said.

Student found dead in college hostel room in Kerala

KOCHI: A 21-year-old college student was found dead in her hostel room in Perumbavoor on Monday morning, police said. The deceased has been identified as Aneeta Binoy, a native of Parampuzha in Kottayam district. She was a final-year degree student at Rajagiri Viswajyothi College of Arts and Applied Sciences. According to the police, Aneeta was found hanging from the window panes at around 7 am. A note addressed to her parents was recovered from her room. Preliminary investigations suggest that it is a case of suspected suicide Kuruppampady police have registered a case and initiated an investigation.

Kumbh stampede: SC refuses to hear PIL, asks petitioner to move Allahabad HC

PTI, NEW DELHI: Terming as unfortunate the January 29 stampede at Maha Kumbh where at least 30 people were killed, the Supreme Court on Monday refused to hear a PIL for guidelines over safety of devotees and asked the petitioner to move the Allahabad High Court instead.

A bench comprising Chief Justice Sanjiv Khanna and Justice Sanjay Kumar said, "It is an unfortunate incident, something which is of concern. But you go to the Allahabad High Court." The stampede took place on the occasion of Mauni Amavasya, one of the most auspicious days of the Hindu calendar. in which at least 30 people lost their lives and 60 were injured in a pre-dawn stampede at Sangam area in Prayagraj.

The bathing ritual assumed special significance as it came days after a stampede during the previous 'Amrit Snan' on Mauni Amavasya (January 29) killed at least 30 people and left 60 others iniured. HC grants Sengar bail for surgery

PTI, NEW DELHI: The Delhi High Court on Monday granted interim bail to expelled BJP leader and Unnao rape case convict Kuldeep Singh Sengar to undergo an eye surgery on Feb 4.

A bench of Justices Yashwant Varma and Harish Vaidyanathan Shankar suspended Sengar's sentence of life imprisonment and directed him to surrender before the jail authorities on Feb 5. In view of the reprieve giv-

en by the division bench, single judge Justice Vikas Mahajan extended the same relief to Sengar in the case over the

custodial death of the survivor's father and temporarily suspended the 10-year jail term in this matter.

NAGPUR: A teacher of a school in Maharashtra's Nagpur district was arrested for allegedly secretly filming women using a toilet, police said on Monday. The police arrested the accused, Mangesh Khapre (38), a resident of Itwari, in connection with the incident that took place at a cultural centre at Sitaburdi on January 31, an official said. He said one of the women caught Khapre secretly filming women from the window of the toilet and raised an alarm, and people at the scene apprehended him. Police found 20 objectionable videos on the accused's mobile phone, the official said. He said Khapre had been involved in a similar incident at an event last year.

> sult of poor visibility due to dense fog, officials said. At least six flights scheduled to arrive at the Netaii Subhas Chandra Bose International (NSCBI) Airport and the departure of 16 flights to other destinations were delayed, they said.

> According to an Airports Authority of India spokesperson, Low Visibility Procedures (LVP) were implemented due to the fog from 1.21 am to 8.45 am. The air traffic control (ATC) declares LVP when visibility falls below 800 metres, after which 'follow-me' vehicles guide aircraft to their stands, he said.

The LVP is also activated when the cloud ceiling is below 200 feet.

Gandhi claimed that the difference between the Lok Sabha polls in June and the state polls in November was that almost 70 lakh voters suddenly arriving.

"More voters were added in Maharashtra in five months between the Lok Sabha and assembly polls than in five years," the former Congress president said.
