Govt to hold next round of talks with Punjab farmers on Feb 14

PTI, NEW DELHI: The Centre on Tuesday informed Parliament that the sixth round of discussions with agitating farmers in Punjab and Haryana will be held on February 14.

In the previous round held last month, the government had proposed a five-year plan for the procurement of certain crops at Minimum Support Prices (MSP), but did not reach a consensus on the farmers' broader demands, including a legal guarantee for MSP.

Minister of State for Agriculture Ramnath Thakur, in his written reply to the Lok Sabha, said: "Next round of discussion with the farmers is scheduled on 14th February, 2025".

The issues related to ag-



itating farmers and their demands are also sub-judice in the Supreme Court and a committee has also been formed by the apex court, he noted.

The Centre had initiated discussions with farmers on their agitation on February 8, 2024. Subsequently, discussions were held on 12th, 15th, 18th February 2024 and January 18, 2025, he added.

So far, the central government has engaged in five rounds of discussions with the agitating farmers since the protests reignited on February 13, 2024.

Delhi Police busts cross-border cyber fraud network, 3 arrested

PTI, NEW DELHI: Delhi Police has busted a cross-border cyber fraud network and arrested three people operating from Uttar Pradesh and Haryana, officials said on Tuesday.

The accused were involved in large-scale digital arrest and investment frauds in collaboration with cyber criminals based in Cambodia, Thailand, Canada, and other countries, police said.

As part of the crackdown, police also dismantled Session Initiation Protocol (SIP) numbers and terminals used to route fraudulent calls, officials added.

Deputy Commissioner of Police (DCP) (Outer North) Nidhin Valsan said the breakthrough came after a complaint was filed on the National Cyber Crime Reporting Portal (NCRP) regarding a financial fraud of Rs 94,000.

The complainant received a call on December 19, 2024 from a number impersonating officials from the Central Bureau of Investigation (CBI) and the Telecom Regulatory Authority of India (TRAI), the officer said.

The scammers falsely claimed that her mobile number was being misused for illegal activities and threatened her with arrests unless she made payments.

9 militants arrested in Manipur

PTI, IMPHAL: Security forces arrested nine militants belonging to different banned outfits from Imphal East, Imphal West, Kakching and Thoubal districts, police said on Tuesday.

Five members of the Kangleipak Communist Party (City Meitei) were arrested from Mantripukhri Thakurbari area of Imphal East district on Monday, they said.

One 9mm pistol, a magazine, 11 live rounds of ammunition, two hand grenades, and three mobile phones, were seized from their possession.

A member of the banned Kangleipak Communist Party (MC) Progressive involved in extortion activities was arrested from Singjamei Thokchom Leikai in Imphal West district on Monday, police said.

A member of the banned United People's Party of Kangleipak (UPPK) also involved in extortion activity was arrested from Irengband Hawairou area in Kakching district on Monday.

Manipur Police arrested one active cadre of PREPAK (Pro) from Yairipok Bazar in Thoubal district on Monday.

This Authority has not received any application from any license holder to undertake a survey in respect of underground or overground telecommunication or cable network nor received any application regarding application for establishment of underground or overground telecommunication/cable network.

It is seen that structural stability certificate of the pole herein called as "Furniture" for laying and maintenance of the telecommunication and cable network is not obtained and the stringing of the overground cables and OFC is without permission and without following safety measures in an up-hazard manner.

Now, I Shri Kashinath Jairam Shetye, Nodal Officer For Land Acquisition and Property Management Under section Section (18) Right to seek removal of the Telecommunications (Right of Way) Rules, 2024 by the facility providers, have been put to notice to remove all illegal cables and infrastructure from the electricity poles and other electricity "Furniture" within 10 days from the date of this notice.

From the expiry of 10 days the JE/AE/EE of Electricity Department having jurisdiction over the area will clear all such illegal cables and infrastructure from the electricity Poles as its against Public interest and in safety of public at large.

Vide Reply dated 28.01.2025, the said co-owners through their Power of Attorney had rejected the offer of the undersigned for not accepting the said offer as "one package deal" to which the undersigned sent Reply dated 01.02.2025 reiterating the offered purchase of two properties bearing Survey No. 7/2 and Survey No. 57 of Village Pallem and calling upon to restrain them from selling the said two properties to any third parties. The undersigned has reasons to believe that attempts are being made by the said co-owners to
