AAP rejects exit polls

Says its performance in Delhi has been underestimated

PTI, NEW DELHI: The AAP rejected the exit poll results for the Delhi Assembly election on Wednesday, saying the pollsters have "historically" underestimated its performance, while the BJP termed the predictions an assertion of people's urge for change.

DELHI ELECTIONS

As voting for the 70-member Delhi Assembly concluded at 6 pm on Wednesday, most exit polls predicted an edge to the BJP over the ruling Aam Aadmi Party (AAP).

AAP's national spokesperson Reena Gupta told PTI that exit polls have historically underestimated the Arvind Kejriwal-led party but in actual results, the party gains several times more than these projections.

"You look at any exit poll - whether in 2013, 2015 or 2020 - the AAP was always shown getting a smaller number of seats. But it got a greater number of seats in the actual results," Gupta said.

She claimed that the people of Delhi have voted for the AAP in large numbers and asserted that the party is going to register a "historic" victory, with Kejriwal becoming the chief minister for a fourth time.

The poll results are scheduled to be declared on Saturday.

Exit polls are projections made by election-survey agencies, based on interviews of voters as they come out of polling booths after casting their votes. These may vary widely from the actual results.

Delhi BJP president Virendra Sachdeva said the party respects the exit poll predictions. "I believe the people of Delhi made up their minds long ago that they wanted change," he added.

Over 65% voting in Milkipur bypoll, surpasses 2022 turnout

PTI, AYODHYA (UP): More than 65 per cent of the total 3.70 lakh voters exercised their franchise in the bypoll in the Milkipur Assembly constituency of Uttar Pradesh on Wednesday, surpassing the turnout recorded in the 2022 assembly polls.

The voting began at 7 am and continued till 5 pm, officials said, adding those who queued up outside poll booths before that will be allowed to vote.

Samajwadi Party president Akhilesh Yadav alleged "fake voting" and rigging by officials, but senior police officers rejected the charge and said voting is going on peacefully at all polling stations.

According to the Election Commission (EC), 65.35 per cent votes were cast till the completion of voting. The final poll percentage can go up as the data is compiled from all the 414 polling stations.

The turnout is more than that recorded in the 2022 assembly polls when it was 60.23 per cent.

The Milkipur bypoll has turned into a prestige battle between the Samajwadi Party and the Bharatiya Janata Party as the seat is part of the politically significant Ayodhya district.

SP chief Yadav alleged that presiding officers are "fulfilling the target of fake voting" in the constituency asked the Election Commission and the Supreme Court to take cognisance of the "enemies of democracy".

Yadav posted on social media platform X an audio clip from a purported sting and said, "This is a sting operation of the truth of presiding officers who are fulfilling the tar-

get of fake voting for the ruling party."

He alleged that police are checking identity cards of voters to "create fear" in them.

In another post on X, Yadav said, "The Election Commission should immediately take cognisance of pictures related to the news that Ayodhya Police -- senior police officers included -- is checking the ID cards of voters in Milkipur."

"This is a murder of democracy by indirectly influencing voting by creating fear among voters. Such people should be removed immediately and punitive action should be taken," he said attaching a picture with his post.

However, Ayodhya Senior Superintendent of Police Raj Karan Nayyar categorically refuted the accusations.

The SSP said the photo in question depicted police personnel verifying the identification credentials of a polling agent, and emphasised that law enforcement officers are not conducting any verification of voters' identification documents.

Talking to reporters, Samajwadi Party leader and Faizabad MP Awadhesh Prasad alleged the BJP wanted to win the election by creating pressure on

officers to influence voting.

Over 450 take ill in Kolhapur

PTI, KOLHAPUR: More than 450 persons fell ill due to suspected food poisoning after attending a village fair in western Maharashtra's Kolhapur district, police said on Wednesday. About 50 persons were undergoing treatment at hospital at present and the condition of all of them was said to be stable, said an official of Kurundwad police station.

A fair had been organised at Shivanakwadi village where 'kheer' was served as 'prasad', he said.

"People started complaining of diarrhoea, nausea and fever since this morning. So far, 450 people have fallen sick due to suspected food poisoning. Most of them are claiming that they had 'kheer' at the fair. But there were food stalls too," the police official said.

6 Opposition-ruled states demand roll back of UGC draft rules

PTI, NEW DELHI: Hitting out at the Centre over the draft University Grants Commission (UGC) regulations, the Congress on Wednesday said the justification that the rules have been updated for compliance with the National Education Policy does not withstand scrutiny and must be rolled back.

Congress general secretary in-charge communications Jairam Ramesh said the State Higher Education Ministers Conclave was hosted in Bengaluru by Karnataka minister M C Sudhakar with six ministers or their representatives from Karnataka, Telangana, Kerala, Tamil Nadu, Himachal Pradesh and Jharkhand (all-opposition ruled states) adopting

a 15-point resolution on the UGC's "draconian" draft Regulations, 2025.

"The constitutional principle of federalism is sacrosanct and the quality of higher education should be one of the ultimate endeavours of the Ministry of Education. The National Education Policy (NEP) 2020 does not prevail over either the and the justification that the rules have been updated for compliance with the NEP 2020 does not withstand scrutiny," he said.

These draft regulations must be rolled back immediately, Ramesh asserted.

The Conclave discussed the various provisions of the draft University Grants Appointment and Promotion of Teachers and Academic Staff in Univer-

sities and Colleges and Measures for the Maintenance of Standards in Higher Education Regulations, 2025 and Grading of Higher Education Institutions based on implementation of NEP 2020.

In a joint statement, they said the state governments must be given a pivotal role in the appointment of vice chancellors to state public universities. They asserted that the draft UGC regulations do not envisage

any role for the state governments in the appointment of the vice chancellors of public universities established under state Acts and thus, impinge on the legitimate rights of the state in a federal setup.
