PANJIM: The shoddy Smart City works continue to plague to city as water and power supply was disrupted due to digging near Café Bhonsle.

Woes of the people are likely to continue as the work is far from complete while, the Mala jatra and closure of old Mandovi bridge from Saturday will further choke the city.

The road from the Ram Mandir and Masjid up to the St Francis Xavier Chapel at Portais, has been closed for vehicular traffic. The motorists regularly travelling on this road were now using the Mala road but this route will be shut on Friday due to Hanuman Jatra at Shri Maruti Temple, Mala-Panjim. The PWD has also or-

dered closure of the Old Mandovi bridge for all types of vehicular traffic from February 8 to 23 to carry out work such as milling of the existing wearing course, laving mastic asphalt and bituminous concrete.

Reacting to the traffic mess in the city, former CCP Mayor and councillor Uday Madkaikar said that Smart City works were undertaken without proper planning. "There was no plan-





Builder directed to refund Rs 47 lakh for failing to provide possession of flat

PANJIM: The Goa Real Estate Regulatory Authority (RERA) has ordered Alchemy India to refund Rs 47.40 lakh to Jatinder Na-rang within 60 days and also to pay him an interest at the rate of 11.10 per cent per annum for delay in delivering the possession of a studio at Pernem.

Narang had sought a refund of Rs 47.50 lakh along with interest calculated at the rate of 24 per cent from the Studio apartment which was supposed to be handed over on May 31, 2017.

Goa RERA Member Vincent D'Silva has also directed Alchemy India to pay Narang costs of Rs one lakh within 60 days of the order, failing which it will carry interest in terms of Rule 18 of the Goa Real Estate (Regulation and Development) (Registration of Real Estate Projects, Registration of Real Estate Agents, Rate

of Interest and Disclosures on Website) Rule 2017 till payment.

The Alchemy India has also been directed to pay Rs two lakh as penalty under Section 61 of the Act for violation of Section 11(4)(a) and (f) read with Section 18 of the Act and file compliance report of the order in the form of an affidavit within 60 days.

As per the complaint, Alchemy India had induced Narang to invest in a Studio apartment in a building project known as 'The project Sagrados' located in Pernem.

Congress flays govt over 'deteriorating' law and order

PANJIM: The Goa Pradesh Committee Congress (GPCC) has strongly criticised the Bharatiya Janata Party (BJP)-led government in Goa, alleging that it has completely lost control over law and order in the state. The Congress questioned whether incidents such as the Bicholim police cash misappropriation case, the Colvale jail controversy, and a recent murder at a beach do not indicate the failure of the Home Department.

Referring to the misappropriation of cash at Bicholim police station, the Congress accused the government of losing its grip on law enforcement and policing in the state. Congress MLA Carlos Ferreira alleged that there was an attempt to cover up the incident by asking the accused to return the money.

"I want the police to come clean on this. There were attempts to shield her. Even after the case was known, she was only suspended today," Ferreira said. He further asserted that the involvement of a

lady police constable (LPC) in such a case was a clear sign of corruption and that she was unfit to serve in the police force.

Ouestioning the integrity of the police, Ferreira remarked, "The accused police personnel are unfit to be in the force. I want the government to come clean on this, and this is an answer that must be provided by the Chief Minister, who is also the Home Minister. This is a clear sign of corruption and dishonesty in the system."

He further demanded stronger action against those responsible. "These are the people who should be sent home and not suspended," he merely stated.

Commenting on reports that the accused LPC had returned Rs 17 lakh of the swindled money, Ferreira raised concerns about the role of tax authorities. "How is the Income Tax Department unaware of this? How can someone amass so much cash without attracting scrutiny? I will take this up with the Income Tax authorities," he declared.

National Association for the Blind Goa branch marks 42 yrs Seeks financial support to carry on with its vision for visually impaired

PANJIM: As the Goa branch of the National Association for the Blind (NAB) celebrates 42 years of dedicated service, the organisation continues to grapple with the challenge of securing financial sup-

port to sustain its work for the visually impaired. The NAB Goa State Branch, located in Santa Cruz, is commemorating its 42nd anniversary with an alumni meet under the "Vision Beyond Sight." The event aims to highlight the capabilities of the visually impaired

can achieve just as much as their sighted counter-

parts, aided by advancements in technology that go beyond Braille. As part of the celebra-

tions, NAB will felicitate over 50 alumni who have secured employment, regardless of the scale of their jobs. Employers who have demonstrated inclusivity by offering opportunities to the visually impaired will also be honoured. Additionally, assistive aids, appliances, and the latest technology designed to enhance education for visually impaired students will be

and demonstrate that they showcased at the event. Mahadev Sawant, an

ex-student of the NAB branch in Santa Cruz and an Executive Member of the organisation, emphasised NAB's role in promoting inclusivity. "NAB is the only NGO that works for inclusivity. Here, students are integrated into regular schools so that sighted students can learn about visual impairment, while visually impaired students experience mainstream education," he said.

Currently, the NAB branch in Santa Cruz provides training for 30 students with partial or full

visual impairment. However, funding remains a major challenge. Rozendo Mendonca, Vice-President of NAB Goa, spoke about the financial constraints the organisation faces. "Securing funds is an ongoing struggle. The government does provide some assistance. We currently operate from a renovated old government school, which has been taken on a long lease. However, most of our funding comes from personal donations and support," he explained.

Mendonca further elaborated on the financial needs of the institution, into mainstream schools,

stating, "We receive some Sawant remarked, "Most funding through the Social Welfare Department, but our monthly expenses amount to Rs 5 lakh. NAB is the only boarding facility for the visually impaired in Goa." He also outlined the organisation's ambitious expansion plans, which include a new facility estimated to cost nearly Rs 12 crore. "We are in the process of securing the necessary government approvals. Our goal is to accommodate 100 children," he added. Speaking on the challenges of integrating visually impaired students

of our students study at the Santa Cruz school, but when we approach new educational institutes, we often encounter hesitation and uncertainty. We are working to support these schools by providing the necessary curriculum and apparatus required for our students' education."

Despite financial constraints, NAB Goa remains committed to its mission of empowering the visually impaired, ensuring they receive the education, skills, and opportunities they need to lead independent and fulfilling lives.
