## CM admits water deficit. Why are huge housing projects okayed then?

MLAs grill Sawant on water scarcity; CM says providing 24x7 supply not possible but aims for 4 hours a day by 2026; Lobo calls for halt of building licences in parched Calangute

**PORVORIM:** At a time when the Goa government is approving mega residential projects and allowing largescale conversion of forests, orchards, and hillsides into settlement zones, Chief Minister Pramod Sawant admitted on Friday that providing 24x7 water supply to residents is not feasible.

Responding to a calling attention motion tabled by Bicholim MLA Chandrakant Shetye, Sawant told the State Assembly that the government's goal is to ensure every household receives water for just four hours a day by the end of 2026.

"I admit that it is not possible to provide water 24x7, but the government has

I admit that it is not possible to provide water 24x7 but the government has plans to provide water for four hours to every household in the State and infrastructure for the same is being developed. It will be done before the end of

PORVORIM: Pushing for the issue of construction licences in the Calangute constituency to be suspended, MLA Michael Lobo highlighted the severe water crisis in the tourist hotspot, where residents receive water for just 30 minutes every two days. "The North coastal belt is turning into a concrete jungle, yet we don't have enough water for existing residents. There needs to be a serious discussion on this issue. If the government cannot ensure adequate water supply, then construction licences should be revoked—otherwise, we will face a severe crisis in the future," Lobo warned.

also in progress to improve water supply across the State. Additionally, PWD is implementing smart monitoring systems to detect leaks, optimise distribution, and improve efficiency, with the long-term vision of achieving 24x7 supply," he said. Earlier, Shetye raised concerns over the persistent water shortages in North Goa, particularly in Bicholim and Mayem.

# 'Railway projects decided by Centre; but no coal hub planned at any new rly station'

PORVORIM: Chief Minister Pramod Sawant on Friday assured the Legislative Assembly that no coal hub would come up at any of the proposed new railway stations in Goa.

Responding to a calling attention motion by Velim MLA Cruz Silva, Sawant said, "If new stations are announced in other States, people welcome them. Here, there are objections. Those objecting should submit their concerns in writing. We will conduct a proper study and forward the objections to the Centre. However, we welcome the proposed station at Mayem—Bicholim taluka needs a station."

Earlier, Sawant acknowledged that railway projects fall under the jurisdiction of the Central government,

limiting the State's role in decision-making.

The discussion in the Assembly followed an uproar over concerns that these new stations—proposed at Sarzora, Neura, and Mayem—could be used for coal handling.

Silva, in his calling attention motion, pointed out that the newly announced railway stations at Mayem, São José de Areal, and Neura are unnecessary for passenger convenience, given the proximity of existing stations.

'Villagers fear these stations are being developed to facilitate coal and other polluting industries, with possible port connectivity that could severely impact local communities and farmers," he said.

He urged the State government to hold discussions with the Konkan Railway Corporation and the Union government and provide transparency on the matter.

"No licences, permissions, or approvals should be granted for these projects until all concerns are addressed and stakeholders are taken into confi-

dence," Silva asserted. During the Zero Hour session, Sant Andre MLA Viresh Borkar raised similar concerns, stating that villagers of Neura, Agassaim, and Dongrim fear environmental severe damage if a railway station is developed in Neura's

khazan lands. "The proposed site falls in an ecologically sensitive cultivable area. Largescale landfilling will lead to irreversible destruction," Borkar warned, adding that the existing Karmali railway station, just six kilometres away, already serves the area

#### Govt to complete salt pan survey in 6 months, moots conservation policy

Of the hundreds of salt pans that existed across Goa, only 20 remain operational, Sawant says salt consumption has declined in the State

**PORVORIM:** The Goa government will complete its ongoing survey of all salt pans across the State within the next six months and formulate a policy for their conservation and support. Additionally, all salt pans will be officially notified, Chief Minister Pramod Sawant informed the Legislative Assembly on Friday.

Replying to a starred question by Sant Andre MLA Viresh Borkar, Sawant said the survey, conducted through the Goa State Biodiversity Board (GSBB), has onboarded experts from Goa University. Sawant emphasised that notifying all salt pans would aid in conservation while exploring industrial uses, as traditional consumption of Goan salt has declined significantly. He also assured the introduction of a scheme to support salt farmers.

Borkar pointed out that from the hundreds of salt pans that once functioned in Goa, only 20 remain operational, according to the government's list. He also noted that several salt pans in his constituency had not been surveyed. In response, the Chief Minister assured that the GSBB would involve local Biodiversity Management Committees (BMCs) in the survey process.

The government also admitted that no salt pan producers in Goa had availed benefits under the Government of India's Modified Namak Mazdoor Awas Yojana (MNMAY), a scheme for constructing dwelling units for salt workers. The scheme has since been transferred to the Goa Handicrafts, Rural, and Small Scale Industries Development Corporation A preliminary survey in August last year identified operational salt pans in Pernem, Nerul, Ribandar, Merces, Batim, and Quelossim, with Nerul producing the highest daily output of 5,000 kg of salt

Raising a strong appeal for the revival of Goa's traditional salt-making industry, Fatorda MLA Vijai Sardesai urged the government to declare salt pans as protected areas and provide incentives to salt makers to sustain this centuries-old occupa-

Supporting Borkar's proposal to make Batim a model village for traditional salt production, Sardesai highlighted the cultural and historical significance of Goan salt. Citing Japan's premium bamboo salt, which sells for \$100 per 250 grams, he stressed that Goan salt has immense potential if properly branded and marketed.

However, Sardesai raised concerns over the rapid disappearance of salt pans, particularly in places like Arpora, where they have been converted into land for starred hotels. He demanded a firm assurance that salt pans would be declared protected areas and safeguarded in the Regional Plan.

Highlighting the role of dykes in protecting Goa's salt pans and low-lying areas, Sardesai called for a 30-year long-term plan to safeguard them, drawing lessons from the Netherlands' expertise in dyke management.
