Rahul: More voters than adults in Maha, will move court if EC fails to act

Congress leader Rahul Gandhi on Friday claimed there were more registered voters than the entire state's adult population, and that more voters were added in five months between the Lok Sabha and state polls than in the five years before that.

Addressing a joint press conference with Shiv Sena (UBT)'s Sanjay Raut and NCP (SP)'s Supriya Sule, Gandhi also alleged that names of many voters have been deleted or transferred ahead of the assembly polls and most of these were from Dalit, tribal and minority communities.

PTI, NEW DELHI: Counting of votes for the Delhi assembly polls will take place on Saturday to decide whether the AAP comes to power for a fourth term or the BJP forms a government in the national capital after 27 years.

The Congress is also looking for some gains after drawing a blank in the last two elections.

Several exit polls have given the BJP an edge over the

AAP, which has been ruling in Delhi since 2015. The counting process will begin at 8 am with early trends likely to start coming in from initial hours. According to the Election Commission, 60.54 per cent votes were polled on Wednesday.

Delhi BJP president Virendra Sachdeva has claimed his party will win nearly 50 seats. The AAP has rejected the exit poll predictions, asserting it will form the government again with its convener Arvind Kejriwal becoming chief minister for the fourth time.

Delhi's Chief Electoral Officer (CEO) Alice Vaz said that a total of 5,000 personnel, including counting supervisors, counting assistants, micro-observers, and supporting staff trained for the process, will be deployed on Saturday for the counting of votes.

Fire at camp in Maha Kumbh Mela, third incident

PTI. MAHAKUMBH NA-GAR: A fire broke out at the ISKCON camp in Mahakumbh Nagar on Friday and quickly spread to over a dozen nearby camps, leaving them gutted, officials said.

No casualties have been reported.

Chief Fire Officer Pramod Sharma told PTI that the blaze was reported at 10.35 am after which around a dozen water tenders were rushed to the spot.

"Upon receiving information about the fire at the ISKCON camp in Sector 18, fire tenders were immediately dispatched. The fire was contained fully in half an hour," he said.

The fire spread to over a dozen nearby camps, causing significant damages. Officials said the cause of the fire and the damage incurred due to it were being ascertained.

DIG (Maha Kumbh) Vaibhav Krishna said the fire incident has "completely been controlled" by the fire brigades.

Number of Indian prisoners in foreign jails at present is 10,152: Govt tells Parl

PTI, NEW DELHI: As per the information available with the Ministry of External Affairs, the number of Indian prisoners, including undertrials, in foreign jails at present is 10,152, the government informed Parliament on Friday.

Minister of State for External Affairs Kirti Vardhan Singh in a written response to a query in the Lok Sabha shared country-wise data on such prisoners.

The data shared under the head 'total number of Indians under trail and convicted in foreign jails at present' included for 86 countries, including Saudi Arabia, Kuwait, the UAE, Qatar, Nepal, Pakistan, the US, Sri Lanka, Spain, Russia, Israel, China, Bangladesh and Argentina.

While 2,633 Indian prisoners are in jails in Saudi Arabia and 2,518 such prisoners are in jails in the UAE, as per the data shared in his response.

Also, 1,317 Indian prisoners are in jails in Nepal, while the corresponding

numbers in Pakistan and Sri Lanka stand at 266 and 98 respectively, according to the data.

"As per the information
