INDIA bloc loses steam as BJP in driver's seat after Delhi poll results

PTI, NEW DELHI: Just eight months after its good showing in the Lok Sabha polls, the INDIA bloc seems to be running out of steam with internal bickering and conflicting ambitions resulting in diminishing electoral returns that have once again put the BJP in the driver's seat in national politics.

With the defeat of the Aam Aadmi Party (AAP) government in Delhi, the number of INDIA bloc governments in the country has come down to eight -- Karnataka, Jammu and Kashmir, Telangana, Kerala, Tamil Nadu, Himachal Pradesh, Jharkhand and West Bengal.

The INDIA bloc was formed in the run-up to the Lok Sabha polls with parties, often at loggerheads with each other in states, coming together with the sole objective of defeating the BJP that seemed primed to better its previ-

ous tallies in the 2014 and 2019 Lok Sabha polls.

They may have not managed to stop the BJP from coming to power but preventing the saffron party from getting a majority on its own was no mean feat.

The INDIA bloc parties had repeatedly insisted that the alliance was for national polls and later it would be on a state-by-state basis. However, it had

not envisioned that the electoral fights in the states could get nasty, leading to cracks in the overall alliance. The Delhi polls have been a case in point.

The Congress, the largest constituent of the INDIA bloc, ran a high-decibel campaign against AAP, leading to a lot of bad blood between the two parties.

AAP DROWNED DUE TO LIQUOR POLICY, FOCUS ON MONEY: ANNA HAZARE

PTI, MUMBAI: As the BJP on Saturday headed to capture the Delhi seat of power after more than 26 years, activist Anna Hazare, once a mentor to Arvind Kejriwal, said the AAP "drowned" due to the liquor policy and its focus on money. In a jibe at Kejriwal, the anti-graft activist further said a candidate's character should be clean and he should know the virtues of sacrifice. The Aam Aadmi Party, born from Hazare's anti-corruption crusade, is trailing behind the Bharatiya Janata Party as votes are being counted for the 70-member Delhi assembly polls held earlier this week. Trends and results on the Election Commission website showed the BJP ahead in 48 seats and the AAP in 22.

Two national parties get less vote share than NOTA in Delhi polls

PTI, NEW DELHI: Voters in Delhi preferred the 'none of the above' option over two national parties, BSP and CPI(M), emerging election results data shows.

As votes for the Delhi assembly polls were counted on Saturday, latest data of the Election Commission showed that NOTA option got 0.57 per cent vote share as compared to 0.55 per cent of the Bahujan Samaj Party and 0.01 per cent of Communist Party of India (Marxist).

Both BSP and CPI(M) are recognised nation parties.

Congress, BJP, AAP and National People's Party are the other recognised national parties.

According to the data, CPI and JD(U) managed 0.01 per cent and 0.53 per cent vote share respectively.

The Delhi Assembly elections saw a voter turnout of 60.54 per cent, with 94,51,997 people casting their votes on Wednesday. Over 1.55 crore people are in the voters list.

PTI, IMPHAL: Manipur Chief Minister N Biren Singh on Saturday said his government has been making all efforts to restore peace in the strife-torn northeastern state and to ensure that people live together as before.

"The state government has been making all possible efforts to restore peace and to ensure that people live together peacefully as before," the chief minister said. More than 250 people have been killed and thousands rendered homeless since ethnic violence broke out in Manipur in May 2023.

HUGE CACHE OF ARMS, AMMUNITION SEIZED IN MANIPUR

PTI, IMPHAL: Security forces seized a huge cache of arms and ammunition from Manipur's Bishnupur district, police said on Saturday. The arms and ammunition were seized during a search operation in the Aigejang area of the district on Friday, they said. The seized arms and ammunition include one .303 rifle, one bolt action rifle, one .22 pistol with magazine, a 9 mm pistol, two SBBL rifle, the police said. Five hand grenades, one Chinese hand grenade, four 40 mm Lethod grenades, one long-range modified mortar shell, two 2-inch mortar shells with carrier, two tear gas grenades and one smoke grenade was also seized, the police added.

Sharpshooter of Lawrence Bishnoi gang held in Delhi

PTI, NEW DELHI: Delhi Police has arrested a sharpshooter associated with the Lawrence Bishnoi gang and claimed to have prevented a planned shooting for extortion in the city, an official said on Saturday.

Harish (21) was apprehended in Rohini's Sector 24 with a semi-automatic pistol and five live cartridges, the official said.

According to police, on February 7 they got information that Harish, a close associate of gangster Ankit Shehrsha, would be meeting his accomplices near Ganda Nala road.

"A trap was laid at the location and at 9.50 pm, Harish was spotted arriving from Rithala. He was apprehended," the officer said. "During interrogation, the sharpshooter revealed that he was drawn into the Lawrence Bishnoi gang through Ankit Shehrsha, who was involved in Punjabi singer Sidhu Moosewala's murder. Harish came into contact with Shehrsha via social media and was influenced to join the gang," he said.

SC to hear PIL seeking right to passive euthanasia for rabies patients on Monday

PTI, NEW DELHI: The Supreme Court is slated to hear on Monday a PIL seeking the right to passive euthanasia for persons afflicted with rabies.

A bench of Justices B R Gavai and K Vinod Chandran agreed to take up the petition filed by NGO All Creatures Great and Small on February 10 after the matter was mentioned for listing.

In 2020, the top court issued notice to the Centre and sought responses from ministries of health and environment on the petition that was filed in 2019.

In its plea, the NGO prayed that a procedure



In its plea, the NGO prayed that a procedure should be laid down for rabies patients to allow them or their guardians to opt for the assistance of physicians for assisted dying or passive euthanasia

should be laid down for rabies patients to allow them or their guardians to opt for the assistance of physi-

cians for assisted dying or passive euthanasia.

On March 9, 2018, a five-judge Constitution bench of the SC held that right to life includes right to die and legalised passive euthanasia by allowing the creation of a 'living will' that could provide terminally ill patients or those in persistent vegetative state (PVS) with no hope of recovery a dignified exit by refusing medical treatment or life support system.

The NGO, represented by senior advocate Sonia and advocate Noor Rampal, seeks to carve out an exception for rabies patients within the apex court

judgement.

It has said in its petition that rabies has a 100 per cent fatality rate and can be "more torturous and harrowing to succumb to than other forms of ailments".

"These unique symptoms of rabies make it an exceptional case where the patients have to be tied and shackled to their beds reducing their personal freedom, movement dignity and integrity," it said.

The court should consider the "exceptional/violent nature of the disease and the absence of a cure thereof that makes it a separate class".
