Smart City blunder in Bhatlem, gas leak disaster averted

Pipeline damage during sewerage works disrupts supply to 4,000 houses; Smart City officials conspicuous by their absence

PANJIM: The Smart City works in the State's capital continue to be carried out in the most haphazard manner. Barely a week after a main water pipeline burst at Bhatlem, causing severe flooding in the area, a major disaster was averted on Sunday after a

gas pipeline belonging to Goa Natural Gas Pvt Limited was allegedly damaged by the workers, while carrying out sewerage works near a temple in the area, disrupting gas supply to 4,000 houses. The incident took place at

around 4.30 pm when sewerage work was underway using earthmoving machinery. According to locals, the

workers had no idea that there was a gas pipeline passing through. Officials of Panjim Police and Fire Station visited the spot.

4.67 lakh foreigners visited Goa in 2024: Minister

AGENCIES, PANJIM: The number of international travellers to Goa is on the rise, with 4.67 lakh foreigners arriving in the coastal State last year against 4.52 lakh in 2023.

This was stated by Tourism Minister Rohan Khaunte in a written reply tabled in the State Assembly during its winter session held recently.

During the year 2020, a total of 3,00,193 international tourists arrived in Goa, but the number dropped to 22.128 in 2021, he said.

The year 2022 saw Goa again attracting foreign travellers with 1.69 lakh

tourists arriving in the State, followed by a major surge in 2023 when 4.52 lakh international tourists visited Goa, he said.

Last year, 4.67 lakh international tourists visited the coastal State, Khaunte said responding to a question by Goa Forward party MLA Vijai Sardesai.

The foreign tourists arrived in Goa through chartered flights, international scheduled flights, cruises and domestic flights too, the minister added.

The two-day winter session of the State assembly was held on February 6 and 7.

South Collector halts illegal land filling in Velsao

Primeiro Vaddo residents term stop work order as temporary relief

MARGAO: In a significant relief for Velsao locals, the South Goa Collector issued a stop work order halting the illegal land filling and dumping of construction materials at Primeiro Vaddo, Velsao.

The order, signed by South Goa Deputy Collector Velton Tellis, was issued after the Flying Squad received complaints about unapproved land filling in the area. A site inspection confirmed that large-scale dumping was taking place adjacent to survey numbers 60/2, 60/4, 59/1-A, 58/8-A, 58/10, and 58/11 without the necessary approvals or permissions. The order also mentioned that no notice board displaying authorisation from the Town and Country Planning Department (TCP) was found at the site, nor were any permits made available during the inspection, making the activity a prima facie violation of Section 17(A) of the TCP Act, 1974. The order further directed the Verna Police Inspector to stop the illegal activity immediately and instructs the Deputy Collector of Mormugao to ensure that no further violations occur. The Town Planner, Mormugao, has also been asked to take immediate action and report compliance to the authorities.

With the order in place, work at the site has temporarily stopped, bringing some relief to the affected residents. However, locals remain on edge, fearing that railway authorities

RAILWAYS REJECTS VELSAO PANCHAYAT'S STOP WORK ORDER

MARGAO: The Railways has firmly rejected the stop work order issued by the Velsao Panchayat against ongoing construction on the traditional access path, stating that local bodies have no legal authority to halt railway

In a letter addressed to the Velsao-Pale-Issorcim Panchayat, Rail Vikas Nigam Limited (RVNL) clarified that, under Section 11 of the Railways Act, 1989, Indian Railways, as a Central government entity, does not require permission from panchayats or local bodies to execute infrastructure projects. Consequently, they argued that the stop work order issued on January 29 has no legal standing. The letter further referenced a Railway Board notification from January 30, 2020, stating that it pertains to the commercial use of railway land and does not restrict the Railways' ability to carry out infrastructure projects of national importance, such as double-tracking.

Pope reminds armed forces only to act for defence, respect international laws

AP, VATICAN CITY: Pope Francis on Sunday told soldiers, police and other law enforcement officials from around the world that armed forces can only be used for legitimate defence and must always respect international law.

The pontiff reappeared in public for the first time since he was diagnosed with bronchitis on Thursday to celebrate an outdoor Jubilee Mass for the armed forces, police and security personnel. However, after a few words, he handed off his homily to an aide to read, saving he was having

difficulty with his breath. "I would like to recall the teaching of the Church in this regard: The Second Vatican Council says that those who exercise their profession in

"This armed service must be exercised only for legitimate defence, never to impose dominion over other nations, and always observing international conventions regarding conflicts," he added.

The pontiff launched a new appeal for peace, citing conflicts around the world, including Ukraine, the Middle East, Myanmar and Sudan.

"Let the weapons be silenced everywhere and let the cry of the people asking for peace be heard," Francis said. The Pope was diagnosed with bronchitis on Thursday.

"We had permission to busk, hence us playing in that exact spot, was planned out before, it wasn't just us randomly turn-



ing up. All good though. See ya at the show tonight x (sic)" Sheeran wrote on his Instagram Story hours ahead of his second show in Bengaluru.
