PONDA: The issue of crematoriums for Scheduled Tribes (ST) communities residing near forest areas dominated the discussions at Curti-Khandepar Gram

Heated arguments ensued which prompted the Sarpanch Abhijeet Gaude to step in and advise the members to discuss the matters in detail and submit proposals for identifying suitable land for the crematoriums.

While discussing the OPA-Khandepar crematorium, Gaude informed the sabha that two years ago, the ST community was pro-

hibited from performing final rites at the existing Following crematorium. this, some local residents approached the ST and SC Commissioner, who visited the site. The Commissioner instructed the community to propose a 2000-square-metre plot of land for final rites. The Sarpanch called on all ST communities at OPA-Wada to meet with stakeholders and select an appropriate location for the crematorium. The decision on the crema-

Sarpanch Gaude stated that notices had been issued to the encroachers, but no responses or documents had been that the Directorate of Settlement & Land Records would conduct a demarcation of the land, after which a final decision would be

At the start of the session, the appointment of the VDC (Village Development Committee) Convenor was brought up. Panchayat member Bhika Kerkar stressed the importance of the VDC in development works and suggested that the Gram Sabha make a suitable decision. The Sarpanch responded that the VDC Convenor issue would be revisited at the next Gram Sabha meeting.

PANJIM: Imagine Panaji Smart City Development es Road- From Alfran Plaza Ltd (IPSCDL) on Sunday to DB Road Junction (200 road closures in Central Panjim (Phase 3) as part of ongoing infrastructure development under the Smart City Mission.

According to a statement, key road stretches in the capital city will remain closed for vehicular traffic from February 9 to February 28, to facilitate essential roadwork.

The roads cover a total length of 1,415 metres, including General Bernardo Guedes Road- From Geeta Bakery to INOX (535 me-

tres). MG Road- From UCO Bank to Vinanti Restaurant (380 meters), Costa Alvartemporary metres), Road from Tom's Liquor Shop to DB Road Junction (200 metres) and two internal lanes between Costa Alvares Road (100 metres).

The IPSCDL has advised commuters using General Bernardo Guedes Road to take Swami Vivekananda Road and MG Road via Don Bosco School to reach DB Road and those traveling on MG Road can use Swami Vivekananda Road to reach MG Road near Woodland Showroom before proceeding further.


