Agriculture policy proposes ban on field conversions

Vision document encourages cultivation of mango, cashew with subsidies to support farmers

PANJIM: The Goa government on Tuesday unveiled the 'Goa State Amritkal Agriculture Policy 2025' with a proposal of a ban on the conversion of all fields designated as 'rice', 'morad', 'kher' and 'khazan', and focus on revolutionising agriculture through organic farming, hydroponics, aeroponics, aquaponics, urban agriculture, and vertical farming.

Speaking to media persons after launching the policy at Mantralaya at Porvorim, Chief Minister Pramod Sawant said the policy has laid focus on promoting organic farming, hydroponics, aeroponics, vertical farming, and urban agriculture and encouraged the cultivation of cash crops such as mango, cashew, and exotic fruits like avocado, rambutan, pomelo, and grapefruit, with subsidies to support farmers in adopting these

It has also proposed enacting the New Goa Farmers Welfare Act to provide guaranteed livelihood security and sustainable farming practices. startups, and innovations. The focus is on protecting Goa's valuable agricultural heritage while combining it with modern farming techniques to boost productivity and sustainability.

The cultivation of khazan lands will be planned by building bunds and creating soil patterns that are better suited for farming. The policy also talks of a commitment to climate-resilient farming practices to protect agriculture in Goa from the effects of climate change, ensuring its long-term sustainability.

The policy has outlined restoration of degraded agricultural landscapes to healthy ecosystems and focus on managing water resources carefully by using water efficiently and conserving it through methods like rainwater harvesting and restoring traditional water systems.

policy promoting agro-tourism will allow farmers with at least 4,000 square metres of land to participate and strict zoning rules will be put in place to designate specific areas for agro-tourism.

As per the policy, farmer field schools will be given priority, and demonstration farms will be established throughout Goa and in addition to cashew, mango, arecanut, support the cultivation of new cash crops like avocado, rambutan, grapefruit and pomelo.

Mormugao council bldg restored to

VASCO: The renovated Mormugao Municipal Council building was inaugurated on Tuesday evening by Panchayats Minister Mauvin Godinho in the presence of Vasco MLA Krishna 'Daii' Salkar, Mormugao Chairperson Girish Borker, councillors, and other

dignitaries. The nearly century-old building has been restored under a major renovation project executed by the Goa State Urban Development Agency (GSUDA) through a contractor. The work, costing an estimated Rs 15.41 crore, was funded by the Mormugao Municipal Council using grants received under the Fourteenth

Finance Commission. Godinho highlighted Vasco's transformation. stating that while it was once the best-planned town, it lost its charm over time. "In the last five years, things started changing, and the government invested significantly in renovating this historic municipal building, bringing it back to its old glory," he said. He also assured that the Vasco bus stand project would be taken up soon.

Salkar emphasised the need for renovation, given the building's age. "The initial cost was Rs 10 crore. but it later escalated to Rs 15 crore due to additional works. However, the government continued to support the project," he noted.

He said that soon the Deputy Collector's office, Mamlatdar's office, other government offices and the Comunidade office will shift back in the renovated building offering convenience to citizens.





Electronics:

In line with our 'Make in India' policy, and to rectify the inverted duty structure, the Basic Customs Duty on Interactive Flat Panel Display (IFPD) is increased from 10% to 20%. Also duty on open cells and other components used in the manufacture of interactive flat panel display module is reduced to 5%. Further, for the manufacture of open cells of LED/LCD TVs, Basic Customs Duty on parts of open cells has been reduced to zero.



Shipping:

Basic Customs Duty exemption on raw materials, components, and consumables for ship manufacturing extended for another decade, including for shipbreaking.

Telecommunication:

Basic Customs Duty reduced from 20% to 10% on carrier grade Ethernet switches to make it at par with non carrier grade Ethernet switches in order to prevent classification disputes.

Lithium-Ion Batteries:

35 additional capital goods for manufacture of lithium ion battery of electrically operated vehicles and 28 additional capital goods for manufacture of lithium ion battery of mobile phones exempted from Basic Customs Duty. This exemption will aid in enhancing domestic manufacturing capacity and support the green energy transition.
