

## My second viral video was 'fake', recorded at gunpoint: Siddiqui

The land grab accused alleges on court premises that police are trying to eliminate him; claims he was given electric shock by a PI

**PANJIM:** The Goa Police personnel have been left red-faced once again, with the prime accused in the land grabbing cases Siddiqui alias Suleman Khan on Wednesday reiterating his claim that his second viral video was "fake" and recorded at gunpoint following his re-arrest in Kerala in December last year.

Claiming that there was threat to his life, Suleman lifted his hand and showed the wound to the media persons, alleging that police were trying to eliminate him.

"Yes, my second video was fake. It was taken at gunpoint. I was given an electric shock by a PI. My first video (accusing the police) was real," Suleman told mediapersons outside the Court of Principal District Judge and Sessions Judge, North Goa premises at Altinho, Panjim court as the police whisked him for a hearing.

## Outrage in Velsao as Collector revokes Railways stop work order

Railways resumes construction work under police protection despite locals furnishing documents asserting the matter is sub-judice

**MARGAO:** In a dramatic turn of events, South Goa District Collector withdrew its previous stop work order against the alleged illegal land filling at Velsao, prompting the Railways to resume the construction work in the village with police protection, despite ongoing legal disputes and opposition from the locals.

While withdrawing its order, the Collector cited that the respondent was initially unknown, even though the withdrawal order simultaneously referenced Rail Vikas Nigam Limited's (RVNL) response to the notice.

The disputed work site at Primeiro Vaddo, Velsao, adjoining the heritage homes of several residents, has become a flashpoint of tension as railway work has blocked the traditional right of way that villagers have used for over 200 years.

### David versus Goliath: Velsao VP firm on Railways stop work order

**MARGAO:** The Velsao-Pale-Issorcim Village Panchayat has firmly rejected Railways' request to withdraw the stop work order on the ongoing railway construction, asserting its authority to issue such notices and highlighting violations of human rights due to blocked access to villagers' homes.

In a detailed response to RVNL, Sarpanch Maria Diana Gouveia maintained that the stop work notice remains in force, outlining several critical grounds for the decision.

The panchayat's primary concern centres on the railway works blocking motorable access to villagers' houses, effectively leaving them landlocked - a situation the panchayat has deemed as violation of human rights.

The panchayat has also challenged the Railways' invocation of Section 11 of The Railways Act, 1989, arguing that this provision only applies to lands where Railways has acquired clear title.

RVNL, in its response to the Collector, maintained that the South Western Railway's (SWR) Hospet-Vasco da Gama double tracking project was being undertaken in compliance with the Railways Act, 1989, and that no illegal activities were being carried

out in the specified areas. Orville Dourado Rodrigues, founder of Goencho Ekvott, questioned the basis of withdrawing the stop work order, noting that it was originally issued based on the Flying Squad's report.

**PTI, NEW DELHI:** On political parties promising "freebies" ahead of polls, the Supreme Court on Wednesday said instead of bringing people into the mainstream for national development "are we not creating a class of parasites?"

A bench of Justices B R Gavai and Augustine George Masih said it would be better to make people a part of

the society's mainstream and contribute towards national development.

"Rather than promoting them to be a part of the mainstream of the society by contributing to the development of the nation, are we not creating a class of parasites?" it asked.

Justice Gavai went on to add, "Unfortunately, because of these freebies, which just

### Sancoale Comunidade chief dismissed for 'illegal' land holding

**PANJIM:** Revenue Minister Atanasio alias Babush Monserrate has disqualified and dismissed Sancoale Comunidade President Pratap Mardolkar with immediate effect.

A fine of Rs one lakh has also been imposed on Mardolkar for "illegally" holding and possessing the Comunidade No. 115/1 of Sancoale for over 20 years for commercial use. The penalty shall be deposited in the office of Administrator of Comunidade South Zone within 60 days from the date of order, failing which the Administrator of Comunidade South Zone shall recover the amount as arrears of Land Revenue under the provisions of Goa Land Revenue Code 1968.

The action has been taken based on the proposal of the Administrator of Comunidades, South Zone, who submitted that Mardolkar had encroached upon the comunidade land and constructed illegal structures and used it for commercial purposes.
