Mamledar leaves behind his wife Shanti and two daughters.

#### US plane with **116** deportees lands in Amritsar

PTI, AMRITSAR: A plane carrying 116 illegal Indian immigrants from the US, among them two Goans, landed at the Amritsar International Airport late on Saturday night, official sources said.

This is the second such batch of Indians to be deported by the Donald Trump administration as part of its promised crackdown on illegal immi-

### Allahbadia apologises, says family getting death threats



Allahbadia, one of the most influential podcasters with over 16 million followers across social media platforms, landed in a major controversy over his comment on parents and sex at Samay Raina's comedy show "India's Got Latent" last Monday.

He apologised the next day but the controversy refused to die down with police complaints filed

PANJIM: Congress has accused a senior Cabinet Minister in the ruling Bharatiya Janata Party (BJP)-led government in Goa of being involved in a mining scam in Karnataka and dared Chief Minister Pramod Sawant to comment on the issue. According to the Con-

gress, a Special Court is expected to deliver its final verdict on February 24 and the party will wait till the

charges. The prosecution claims the scam caused a loss of over Rs 1.5 crore to the government and facilitated illegal profits for the accused.

The accused face charges under multiple sections of the Indian Penal Code (IPC) and the Mines and Minerals (Regulation and Development) Act, along with violations of the Karnataka Forest Rules, 1969. Of the 16 accused, three have reportedly died while the trial remains pending.

#### Four injured in New Delhi rly station stampede

PTI, NEW DELHI: At least four women were reportedly injured and rushed to hospitals after a stampede-like situation broke out at the New Delhi Railway Station late on Saturday evening, triggering a chaos on platform numbers 14 and 15, officials said.

Several passengers also claimed that at least four women were rushed to nearby hospitals after they reportedly fainted due to suffocation.

In an official statement, the deputy commissioner of police (railway) said many people were present on platform number 14 when the Prayagraj Express train was standing at the platform.

The officer further said the Swatantrata Senani Express and Bhubaneshwar Rajdhani Express were delayed.

AP, SAN FRANCISCO: OpenAI says its board of directors has unanimously rejected a \$97.4 billion takeover bid by Elon Musk.

"OpenAI is not for sale, and the board has unanimously rejected Musk's latest attempt to disrupt his competition," said a statement Friday from Bret Taylor, chair of OpenAI's board.

OpenAI attorney William Savitt in a letter to Musk's attorney Friday said the proposal "is not in the best interests of OAI's mission and is rejected."

Musk, an early OpenAI investor, began a legal offensive against the ChatGPT-maker nearly a year ago, suing for breach of contract over what he said was the betrayal of
