# Power Dept imposes Rs 12 cr penalty for hanging cables on electricity poles

## Internet service providers and cable operators given 15 days to respond to notices

PANJIM: The Electricity Department has issued demand notices to Internet Service Providers (ISPs) and cable operators, requiring them to pay a hefty sum of Rs 12.60 crore in penalties and infrastructure usage charges.

The department issued show cause notices to five ISPs and cable operators, ordering them to pay the penalty over and above their regular rental charges for using electricity poles to string cables. The



notices also state that the operators must pay compensation for the unlawful installation of cables without the necessary permissions or clearances.

of the cables, with the most recent one being on February 3. The department had given the ISPs and cable operators 10 days to remove the unauthorised cables, but despite these repeated requests, the cables remained in place, prompting the imposition of penalties.

The Nodal Officer for Land Acquisition and Property Management, operating under the provisions of Section 18 of the Telecommunications (Right of Way) Rules, 2024, had also put instructing them to remove all illegal cables and infrastructure from electricity poles and other electricity "furniture" within 10 days of the notice.

Despite these clear instructions, the Electricity Department stated that they had not received a single application for permission to install cables, further complicating the situation. The department has now initiated the process of recovering outstanding rents and penalties from

**GERMAN NATIONAL ARRESTED FOR CARRYING** PROHIBITED GPS DEVICE AT MOPA AIRPORT

PANJIM: The Mopa Airport Police have registered a First Information Report (FIR) against Thomas Richter, a German national, under the Indian Wireless Telegraphy Act, 1933, for allegedly carrying a prohibited GPS device without a valid licence. The incident occurred on Sunday morning during a security screening at Manohar International Airport, Mopa. The Garmin GPS device was discovered in Richter's handbag before he boarded his Air India flight to Delhi. The case is currently under investigation by Police Sub-Inspector (PSI) Sagar Vazarkar.

#### **DUO BOOKED FOR ORGANISING BULLFIGHT IN MANDREM**

PANJIM: An FIR has been registered against Rigved Naik, 24, from Pernem and Arif Mulla, 28, from Calangute, under the Prevention of Cruelty to Animals Act for allegedly organising a bullfight in Naikwada, Mandrem. According to police reports, the event involved ten bulls, with bets running into lakhs placed on the outcome. However, both individuals were later released on bail. The investigation is being led by Head Constable Satish Shetye.

#### RAIA YOUTH DIES IN TWO-WHEELER **SELF-ACCIDENT**

MARGAO: Alrie Alexio Fernandes, 29, from Sonarwado, Raia, Salcete, succumbed to his injuries at the South Goa District Hospital after a motorbike accident. The Maina Curtorim Police were informed by the hospital that Fernandes had died in the casualty ward while undergoing treatment for his injuries, which he sustained in a self-accident. According to police, Fernandes was riding his scooter from Arlem to Raia when the accident occurred near Livrament Church, Arlem. The body has been preserved at the hospital for medico-legal procedures, and an inquest panchnama was conducted.

#### COLLEM POLICE REGISTER CASE OF ILLEGAL SAND MINING AT DHARBANDORA

MARGAO: Collem Police have registered an offence against unknown individuals for illegally extracting sand from the Khandepar River in Davkond, Dharbandora. Suraj Kalgutkar, Junior Geologist at the Directorate of Mines and Geology, filed the complaint, stating that around 3 cubic metres of sand, valued at approximately Rs 3,900, was taken without prior permission from the Mines Department. The offence was registered under Section 303(2) BNS and Section 4(1) of the Mines and Minerals (Development and Regulation) Act. PSI Viraj Korgaonkar of Collem Police Station is investigating the case.

#### **COLVA POLICE BOOK FIVE FOR MOLESTING** WOMAN AND ASSAULTING BOYFRIEND

MARGAO: Colva Police have registered an offence against five individuals, including Akshay Talwar and Sunil Bilavai of Borda, Margao and three other unidentified men, for allegedly outraging the modesty of a woman and assaulting her partner in a public place.

Mozart Da Costa of Orlim, Salcete, reported that at around 3:20 am on 10 December 2024, the accused men passed a comment on his girlfriend's appearance outside a hotel in Varca, Salcete. The situation escalated when the accused men verbally abused Da Costa, assaulted him, and threatened him with an iron rod. Following the investigation, Sunil Bilavai was arrested and remanded to five days of police custody. The investigation is ongoing, led by Head Constable Sandesh Gadkar.

### TREE FALL, WILDFIRE KEEP FIREFIGHTERS ON THEIR TOES IN SALCETE AND CANACONA

MARGAO: A house located near Jhaved Garage in Benaulim, Salcete, was damaged after a tree fell onto it. Firefight ers from the Margao Fire Station were promptly deployed to the site after receiving the report.

Gil Souza, Station Fire Officer (SFO) from Margao, informed that the tree's branches were cut, and the damage was estimated at approximately Rs 2,000. However, firefighters successfully managed to save property worth Rs 50,000. Senior firefighter SR Naik, along with other personnel, carried out the operation.

In another incident, dry grass caught fire near the power substation at Char Rasta, Canacona. UG Gaonkar, Sub Officer, and the duty crew attended to the fire, bringing it under control.

## Fire breaks out in generator room at Ashvem resort

PERNEM: Panic gripped Ashvem, Mandrem, after a fire broke out in the generator room of a resort situated near Ajoba Devasthan at Ashvem beach. The loss is estimated to be approximately Rs 23 lakh. However, no injuries were reported.

The fire broke out at around 9:30 am. Two generators and a shed were destroyed in the fire, while a solid waste treatment plant was partly damaged. The cause of the fire is suspected to

be a short circuit. Upon receiving the information, personnel from the Pernem fire station rushed to the scene and extinguished the blaze, while resort workers used their fire extinguishers to help contain the fire.

The fire was first noticed by taxi drivers, who

immediately informed the resort staff. There were initial fears that the fire had spread to the beach shacks, as thick smoke was visible, but no such incident was reported.

According to the Pernem fire station, only one fire tender was used to bring the fire under control. The fire was quickly doused using foam, with assistance from the resort staff, who had also used fire ex-

The Mandrem police also rushed to the scene to monitor the operation and coordinated with the Pernem Station Fire Officer (SFO) Namdev H. Parwar to control the fire.

SFO Parwar stated that after the power failure, the resort staff started the generator. However, when the power was restored, they failed to switch over to the main supply, which

## Mining firm has failed to compensate farmers since 2013, say Mayem villagers

**BICHOLIM**: The villagers of Mavem on Sunday alleged that M/s Vedanta mining company had neglected to compensate farmers whose fields had been affected by mining activities and coal

transportation since 2013. They demanded that the company compensate the farmers promptly, warning that they would begin an agitation if their demands

were not met.

The farmers have united under the banner of the All India Kisan Sabha, Krishna Gadekar, a villager, told reporters that the compensation amount had been pending since 2013. He added that the fight against mining activities began in 2007, and after an inspection, it was found that fields and other plantations had

been affected by the mining

Mamlatdar had also ordered the mining company to provide compensation to the affected farmers,"

In response to the Mayem villagers' demands, the company clarified that relating to stakeholders, pertained to Sesa Mining Corporation Ltd (SMCL). According to the company,

"The Bicholim taluka these dues were fully paid to the Mayem farmers, and there were no pending dues against SMCL, as mining operations had ceased in 2013.

The company further stated that Vedanta Ltd commenced operations at the Bicholim Mining Block-I compensation dues for the in April 2024. It confirmed period from 2010 to 2013, that no mining-related compensation dues were outstanding for Mayem farmers under its current operations.

## Baga river is turning into sewage swamp, say fishermen

**CALANGUTE**: Fishermen at Sauntavaddo, Calangute, who dock their boats at Baga jetty, have raised serious concerns over illegal sewage discharge from more than 15 food stalls at the Goa Tourism Development Corporation (GTDC) food court, claiming it poses health hazards and pollution risks to the nearby Baga river.

According to the fishermen, unauthorised sewage tanks from the food court are overflowing and waste is being dumped near their boats, affecting their daily operations and have appealed to the local MLA, the Calangute panchayat, and the tourism department to take immediate action.

The matter was also discussed at the Calangute panchayat gram sabha on Sunday. Calangute

sarpanch Joseph Sequeira highlighted another pressing issue, stating that wastewater from tourism department-managed pay-toilets at Calangute and Baga beaches is flowing onto the roads, worsening the sanitation crisis.

Sequeira pointed out that since the pay-toilets and pay-parking facilities are managed by contractors appointed by the tourism department, the village panchayat cannot intervene in the issue.

"The tourism department is not bothered about Calangute," he remarked, criticising the lack of response from the authorities.

Fishermen and local residents are now urging the government to take swift action to curb the pollution and prevent further environmental damage to the Baga river and its sur-
