DYSP CHODANKAR TRANSFERRED TO POLICE HQ
PANJIM: The Goa Police have transferred Mapusa SDPO Sandesh Chodankar to Police Headquarters (PHQ). In his place, Pernem SDPO Ashish Shirodkar has been given additional charge of the Mapusa sub-division.

SINDHUDURG YOUTH HELD FOR KILLING BIKE RIDER FROM BICHOLIM
PANJIM: The Mandrem Police have arrested Sourabh Prasad Gudekar, 21, from Sindhudurg, Maharashtra, for allegedly driving negligently and causing the death of Raj Ratnakar Pednekar, 22, a two wheeler rider from Bicholim. The accident occurred on February 18, near the Indian Oil Petrol Pump in Tuem, Pernem. According to police, Saurabh, who was proceeding from Tuem to Pernem, stopped the car suddenly on the road which caused Raj to hit the four wheeler from behind. As a result, Raj was thrown on the road and sustained serious injuries. He was rushed to the Community Health Centre (CHC), Tuem, where he was declared dead by the doctors. An FIR has been registered and further investigation is in progress, police added.

POLICE INTENSIFY DRIVE AGAINST DRUNK-DRIVING IN SOUTH GOA
MARGAO: Police stations across South Goa, in collaboration with traffic cells, have launched a campaign targeting motorists driving under the influence of alcohol and other traffic violators. The Margao Traffic Cell booked eight individuals for drunk-driving offences. Following reports of vehicles operating without number plates, Curchorem Police Station, along with the Curchorem Traffic Cell, conducted a joint operation and detained five two-wheelers. Curchorem PI Tukaram Chavan confirmed that the inquiry into the detained vehicles is underway. He assured that similar drives will continue to enforce traffic regulations and enhance road safety.

BODY OF MISSING DISTRIBUTOR DISCOVERED IN CANACONA DRAINAGE
MARGAO: The body of Yadu, also known as Damu Gavade, 49 and a resident of Chaudi Canacona, originally from Chapali, Uttara Kannada, Karnataka, was found in a drainage near the Mamlatdar Office, Canacona. The Canacona Police received an anonymous call alerting them to the discovery. Fire brigade personnel assisted in retrieving the body, which was subsequently transported to CHC Canacona via a 108 ambulance, where medical staff pronounced him dead on arrival. Investigations revealed that Gavade, employed as a distributor in Chaudi Canacona, had been missing since 9 pm on February 18, from his rented accommodation near CHC Hospital. The police conducted a scene of unnatural death (UD) occurrence panchanama and inquest. The body is preserved at South Goa District Hospital Morgue pending post-mortem results. PSI Babu D. Dessai is leading the investigation.

FIREFIGHTERS RESCUE DOG FROM WELL IN BETALBATIM
MARGAO: Margao firefighters successfully rescued a dog that accidentally fell into a well in Betalbatim, completing the operation within an hour. Local residents praised the firefighters' swift and compassionate response. Gil Souza, Fire Station Officer at Margao, stated that upon receiving the distress call, personnel equipped with necessary gear rushed to the scene. Leading firefighter D.N. Khotarker led the rescue with the assistance of his team, utilising life-saving techniques commonly employed during animal rescues.

CUNCOLIM POLICE ARREST MAN FOR SEXUAL ASSAULT ON MINOR GIRL
MARGAO: Cuncolim Police have arrested Sushan Nayak, 21, a waiter at a South Goa hotel and resident of Sarzora, Salcete, originally from Simdega, Jharkhand, on charges of sexually assaulting a minor girl. Police reports indicate that Nayak befriended the 14-year-old victim, a native of Chhattisgarh, via Facebook. Between 2 January and 14 February 2025, he allegedly took her to Jharkhand without parental consent and later brought her to his rented room in Salcete, where repeated sexual assaults occurred, resulting in the girl becoming pregnant. The accused was apprehended at 10:45 pm on 18 February 2025 and is set to be presented in court for remand. Medical examinations for both the accused and the victim will be conducted at Goa Medical College, Bambolim.

WAITER FLEES WITH RS 30,000 FROM COLVA CAFE
MARGAO: Colva Police have registered a theft case against Gaurav Shinde, a waiter at Torrados Café and Loonage, Colva, for allegedly stealing approximately Rs 30,040 and absconding. Shinde, a resident of Vanelim, Colva, originally from Andheri East, Mumbai, reportedly committed the theft at around 11:45 pm on February 15. Complainant Rohan Kammar of Velim, Salcete, lodged the complaint. Police have disseminated alerts across Goa and Mumbai in an effort to locate the suspect.

POLICE UNIFORM SYMBOLISES RESPECT, SAYS RETIRED SP VISHNUDAS VERNEKAR
MARGAO: Retired Superintendent of Police Vishnudas Vernekar emphasised the importance of maintaining the dignity associated with the police uniform, urging officers to preserve its integrity. Reflecting on his career, Vernekar credited his disciplined upbringing, influenced by his strict father, as pivotal to his professional journey. CALANGUTE: Residents of Candolim, Calangute and other nearby coastal areas thronged in large numbers to attend a public awareness meeting on Wednesday evening at St Lawrence Church on Sinquerim Hill and resolved to oppose any commercial development including a proposed starred hotel by a prominent hotel group and a bungalow being built by celebrity in the CRZ no-development zone. During the meeting, members of the Calangute Constituency Forum (CCF) presented a video showcasing the ongoing construc-



tions on the Sinquerim plateau and hillside. The CCF has spearheaded the campaign against the development of Sinquerim Hill. Residents also formed a human chain by linking hands in solidarity. A resolution was adopted stating that no government or private agency should be

allowed to survey the land in Survey No. 96/0. "We have unanimously resolved to oppose this project for as long as we are here," the assembly declared. Another resolution called for the filing of a petition against the construction in the CRZ no-development zone at Sinquerim by a Bollywood

superstar. The video presentation, made by CCF President Premanand Divkar, highlighted several construction projects where orchard land has been converted into settlement areas. Various documents were also displayed during the presentation. Divkar also pointed out

Borim college students taken on a field trip to Zambaulim gaushala

MARGAO: The Department of Commerce and Environment Studies at Swami Vidyaprasarak Mandal College of Commerce, Borim, organised a field trip to the Dhyan Foundation Gaushala in Zambaulim. Margao regularisation drive under RUCA on March 1

The initiative was announced by Environment Minister Aleixo Sequeira following a recent meeting at the District Collectorate. "The South Goa Collectorate will conduct a special drive to expedite the disposal of applications for regularization under the RUCA Act. All deputy collector offices in the South district will remain open on Saturday, March 1, exclusively to handle these cases," Sequeira said. A similar drive was held on January 25 to fast-track pending applications under the RUCA Act. The initiative aims to streamline the process by bringing applicants and key department representatives under one roof.

Alcoholics Anonymous to hold national convention celebrating golden jubilee in Goa

PANJIM: Alcoholics Anonymous (AA) Goa is organising a convention at Ravindra Bhavan, Margao, to mark the golden jubilee of the organisation in the State. According to AA Goa, the four-day national convention, scheduled from February 21 to February 24, will attract over a thousand delegates from across the country to participate in the festival of "Sober Living." The primary aim of the "Goa AA Convention 2025" is to encourage female alcoholics to come forward and seek help, while also generating awareness that alcoholism is not a disgrace, but rather a disease. The AA fellowship in Goa, India, and worldwide focuses on removing the stigma surrounding alcoholism through continuous awareness programmes. Highlighting the alarm-

ing rise in alcoholism, particularly among women, AA has pointed out that the increase is especially prominent in leisure activities, year-round events, celebrations, and party venues in the tourist-friendly state of Goa. AA has also raised concern over the high incidence of accidents and fatalities due to 'driving under the influence of alcohol,' and pointed out that Goa's roads are being labelled as some of the deadliest in the country. "As the prevalence of alcohol misuse continues to be a significant concern in Goa, AA Goa recognises the vital role that mental health professionals and community support play in the journey to recovery. Through this partnership, we aim to create a more holistic approach to treatment that addresses not only physical dependency but also the underlying psychological and social factors," AA stated. Representatives from AA also said that the Goa AA Convention 2025 is a once-in-a-decade opportunity for people to learn more about alcoholism and its treatment. They emphasised that free treatment and recovery resources are available through AA Goa, which conducts 60 meetings across various villages and towns in both North and South Goa. AA Goa has established strong partnerships with mental health professionals, including psychologists, counsellors, and psychiatrists, to provide integrated care for individuals battling alcoholism. These experts offer therapeutic interventions that complement AA's 12-step programme, ensuring a comprehensive treatment plan. Local communities in Goa have shown remarkable solidarity in supporting AA's mission. Community members, volunteers, and organisations have joined forces to create a network of support that extends beyond the confines of AA meetings. This network provides a safe and encouraging environment for individuals to share their experiences and find strength in unity.
