## Almost killed by a 21-year-old behind the wheel of a Mercedes, bedridden Judith holds on to hope and love

### Heartbroken husband accuses Anjuna police of siding with the accused's family while harassing the victim's relatives

KARASWADA, MAPUSA: Prajay Simepurshkar felt the music fade from his life as he held his nearly lifeless wife, Judith Fernandes, who had been knocked down by a Mercedes driven by reckless 21-year-old Anchit Sangelkar.

Just minutes before the accident, Judith, a music teacher at a private school in Sangolda, had called her husband, telling him she would be home soon. "We were supposed to go shopping afterward," recalls Prajay, who had married Judith barely three months earlier. Life seemed like a bed of roses.

Not long after, she lay on a hospital bed—a bed of thorns.

A life-altering tragedy was imminent. Sangelkar, driving a Mercedes reportedly borrowed from a neighbour, with a female friend beside him, struck

Judith and fled the scene.

According to her doctors, Judith suffered a tailbone fracture, multiple pelvic fractures, and several other injuries. The road to recovery would take months.

months to recover from this mental ordeal. Like any married couple, we dreamed of having a child. That was our immediate plan. Now, I don't know what the future holds," says Prajay, ready to bear any burden to see his wife smile again.

"Soon after her call, I received a phone call from a friend informing me that she had been hit by a car

and was lying on the roadside. I reached the spot within two minutes and held her in my arms," says an emotional Prajay after helping a nurse change his wife's dressings.

At this point, Prajay gazed into the abyss, wrecked with memories he wished he could erase. Covering his eyes, he let his emotions flow. "It is over," she had whispered to me,"

he recalled, tears rolling down his face.

But there was another numbing pain for Prajay and his family—the apparent negligence of the Anjuna Police.

"I was called to the Anjuna Police Station the afternoon after the accident and was made to stand outside while the parents of the boy who had run over my wife were allowed to sit with the PI in his cabin," recalls Judith's husband, Prajay Simepurshkar, who owns a security agency.

"All I kept asking was, 'Where is the boy (the accused, Anchit Sangelkar)? Where is the car?' They kept telling me the boy would arrive and that the car would be brought in. Meanwhile, one of my friends found the accused sitting inside a tinted car in the police station compound," says a disheartened husband.

## Delhi tourist 'runs over' Mandrem woman after argument

PERNEM: It started with a disagreement about dogs and ended in death. A bizarre and tragic chain of events unfolded in Mandrem on Friday night when a tourist from Delhi ran over a woman selling coconuts on the road after an argument.

The woman, identified as Maria Joao Fernandes from Junaswada, Mandrem, had been involved in several verbal face-offs with 23-year-old Deepan Rajeev Batra, a tourist from Delhi who was staying at nearby Sawantwada. According to police, Batra would bring his dogs for a walk near Maria's house and coconut stall, something she had objected to since she herself had dogs, who would start barking on seeing Deepan's pets.

On Friday Maria and Batra fought again and Batra's mother also came out and fought with Maria, at one point holding her by the hair and throwing her to the ground. Maria had just got up from the road and was telling her neighbour about the incident when Batra allegedly sped up his car and knocked Maria down, dragging her for almost 10 metres under the wheels and killing her instantly.

to find Maria's lifeless body. They rushed her to the Community Health Centre, Tuem, where she was declared brought dead.

Batra drove straight to the Mandrem Police Station and surrendered soon afterwards. He has been

arrested under Section 103 (murder) and 281 (rash driving endangering human life) of BNS. Mandrem PI Sherif Jacques is conducting further investigations. The accused has been remanded in 14 days judicial custody.

## Shivraj slams Air India over 'broken seat'

### Carrier orders probe; Civil Aviation Min seeks action

PTI, BHOPAL/MUMBAI: Union Minister Shivraj Singh Chouhan on Saturday slammed Tata Group-owned Air India for allotting him a "broken and sunk" seat, prompting his ministerial colleague K Rammoohan Naidu to instruct the airline to take "necessary action".

Separately, Air India apologised for the incident and ordered a "thorough probe" while the DGCA sought a report from the airline in the matter.

Later in the day, Chouhan, the Union Minister for Agriculture, said he

spoke about his experience so that the airline's management comes to know about it and other passengers do not face such problem again.

Describing the incident as an "unethical" practice wherein the airline charges passengers full fare and then makes them occupy defective seats, Chouhan in a post on X said he had boarded the Delhi-bound Air India flight AI436 from Bhopal for Delhi to inaugurate a farmers' fair in Pusa.

The Minister claimed several seats on the flight were in a similar condition.

## Four months on, Anjuna residents continue to bear the brunt of water scarcity

### Residents of Vazarwada forced to hire tankers; suspect water is being diverted to commercial establishments



ANJUNA: Water scarcity has hit most parts of the coastal State, with residents bearing the brunt. The situation in Anjuna's Vazarwada has turned from bad to worse, with the residents experiencing acute water scarcity for the past four months, which has forced them to hire tankers to meet their daily requirements.

The residents complained that since October last year, they are not receiving water supply even as earlier they used to receive water supply on alternate days.

They said that they were told that water supply would be normalised from January this year after laying the new pipeline. The villagers are not sure when this pipeline would be ready and suspect that the water is being diverted to commercial establishments.

Whenever I enquire, my ward member taunts me saying 'it is because some people are talking to media'. My only fault was that I had aired my grievances to the media and this is how I am punished"**

**"For the last three months there has been no water supply in the area. We were told that the pipeline will be replaced and water supply will be restored by February this year and till date nothing has materialised. Most hotels and commercial establishments in the area are supplied with water. We have to rely on private water tankers. Water is released early in the morning, but the pressure is so low that we could fill only four-six buckets before supply stops. For that too we have to stay awake at night."**
