Vijay Mallya pursues annulment of UK bankruptcy over 'unreal quality'

PTI, LONDON: Embattled ment, to be handed down at businessman Vijay Mallya has instructed his lawyers in the UK to pursue an annulment application against his bankruptcy order, with his legal team set to argue that Union Finance Minister Nirmala Sitharaman's statement in Parliament in December last year gives the order an "unreal quality".

It comes after Justice Anthony Mann reserved judga later date, after hearings of three interlinked appeals related to Mallya's bankruptcy order concluded at the High Court in London this week.

The judge heard a set of complicated arguments involving a consortium of banks led by the State Bank of India (SBI) seeking repayment of an estimated judgment debt of around GBP 1.05 billion owed by

nessman's now-defunct Kingfisher Airlines. Mallya is wanted in India on fraud and money laundering charges.

"From Mallya's perspective, these English bankruptcy proceedings have an unreal quality," Leigh Crestohl, Managing Partner of Zaiwalla and Co-Mallya's new
