डिबोली, दि. २४ : मुल्लावयथील विस्मृतीत गावकरवाडा येथील विस्मृतीत गेल्या श्री रामनाथ देवस्थानाच्या जवळ असलेल्या जांभ्या दाडात कोरलेले शिल्प हे सुमारे हजार वर्षे जुन असल्याचे इतिहास प्रेमी राजेंद्र केकरकर यांनी सांगितले. राजेंद्र केकरकर यांनी सोमवारी या ठिकाणी भेट

देऊन इथे असलेल्या शिवलिंग सदृश्य, जांभ्या दाडावर कोरलेल्या शिल्याची पाहणी केली. केकरकर यांच्या मते शिल्प हे हिंदू धर्मीयांचे शिवलिंग आहे की, बौद्ध धर्मीयांचे शिल्प हे स्पष्ट नसत नाही. मात्र या जुन असल्याचे इतिहास प्रेमी राजेंद्र केकरकर यांनी सांगितले. राजेंद्र केकरकर यांनी सोमवारी या ठिकाणी भेट



आहे. जवळच असलेल्या लामग्राम किंवा लामावा येथे पांढऱ्याच होव्यां भिक्कांच्या गुंफाशी साम्य दिसते. गोवा मुक्तीनंतर खरे म्हणजे सरकारने म्हणून प्रसिद्ध असलेल्या बौद्ध आरा वरसा स्थळांचे पुराभिलेख

खाल्यामार्फत संवर्धन करण्यासाठी प्रयत्न करायला हवे होते. परंतु सध्यास्थितीत गोव्याची सांस्कृतिक वंश असलेली सदर ऐतिहासिक वास्तू लोह खनिजांच्या व्यवसायामुळे मातीमाल होण्याच्या मार्गावर असल्याची खंत त्यांनी व्यक्त केली. जेव्हा एखादा व्यवसाय गावच्या अस्तित्वाला सुरुंग लावतो त्यावेळी स्थानिक लोक महत्त्वाची की खाण कंपनी हा विचार सरकारने करायला हवा असेही ते पुढे म्हणाले.

रामनाथ तळी बद्दल सांगताना खाण व्यवसाय सुरू होण्या अगोदर सुजलाम सुफलाम असलेला हा गाव पूर्वी जलसमृद्ध असल्याने इथल्या लोकांनी उकळू जलसिंचन व्यवस्थेने गावची भरभराट केली होती. मात्र आता परिस्थिती खूप विकट असल्याचे त्यांनी सांगितले.
