Ukraine rupture grows as US sides with Russia at UN

AFP, UNITED NATIONS: The United States sided with Russia twice Monday at the United Nations, as they sought to avoid any condemnation of Moscow's invasion of its neighbor three years ago.

The two votes highlighted a seismic shift in the balance of power at the UN, where Washington had steadfastly voted for resolutions that favored Ukraine and condemned Russia, until the abrupt rupture with Kyiv. As US Pres-

"We acknowledge the constructive changes in the United States position when it comes to the Ukrainian conflict," said Russia's UN envoy Vassily Nebenzya following the vote.

Relations between Washington and Kyiv have rapidly deteriorated following Trump's return to the White House, with the US president claiming Zelensky is highly unpopular and a "dictator.'

Trump's growing rupture with Ukraine has caused panic on a continent that has relied on US security assurance for 80 years.

The International Crisis Group's Richard Gowan said the EU won a "moral victory" in the General Assembly, but warned European diplomats will "worry that Russia and the US will route more resolutions on Ukraine through the Security Council - potentially including asking for an endorsement of whatever deal Trump and Putin cook up."

Ahead of the Security Council vote, there was speculation on whether France or Britain would be prepared to wield their first vetoes in more than 30 years.

UK boosts defence budget

AFP. LONDON: British Prime Minister Keir Starmer pledged Tuesday to boost defence spending to 2.5% of the economy by 2027, as uncertainty reigns over US President Donald Trump's commitment to European security.

Starmer expressed an intent to eventually reach 3%, a rise of 0.7% from current spending that would mark the biggest increase since the end of the Cold War.

His announcement comes ahead of key talks on Ukraine with Trump in Washington on Thursday.

It will be seen as an attempt to appease the US president who has demanded that European powers pay more for their own security. The UK spent 2.3% of GDP on defence in 2023/24.

Starmer's Labour government had previously committed to increasing defence spending to 2.5%, but had not set a timeline.

The prime minister told parliament the increase would be funded by cutting overseas development aid from 0.5% of gross national income (GNI) to 0.3%.

CABLES CUT, INTERNET BLACKOUT SPARKS MAJOR DISRUPTION IN CAPITAL

On Tuesday, several key institutions, including the Panjim Head Post Office, State Bank of India (SBI), and prominent schools in the city, were left without internet. WANGCHUK URGES PM TO PRESERVE HIMALAYAN GLACIERS

"India needs to take a lead in glacier preservation as we have the Himalayas, and our sacred rivers such as the Ganga and Yamuna come out of them," Wangchuk said.

Stating that he is an admirer of the environment initiatives taken by Prime Minister Modi, especially the 'Mission LiFE' campaign, Wangchuk in his letter urged Modi to set up a commission to assess the state of Himalayan glaciers.

"As we all know, the glaciers of the Himalayas are melting very fast and if this and the accompanying deforestation continues at the current rate, in few decades our sacred rivers like Ganga, Bhramputra and Indus might become seasonal rivers. This may also mean that the next Maha Kumbh might only happen on the sandy remains of the sacred river," Wangchuk said.

STANDING TALL FOR 200 YRS, BANYAN TREE HAS TO MOVE

When asked about the Khapreshwar Temple, which is located near the banyan tree, Pangam clarified that it was not part of the issue under consideration. He noted that decisions regarding the temple's relocation were for the PWD and contractor to determine.

In response to the decision, landscape designer Daniel D'Souza urged caution, emphasising the importance of learning from past mistakes. "Banvan tree cannot be planted in low-lying areas. I suggest that the tree be cut in two parts, which will make it more easy to translocate it. Since summer is approaching, we have to make sure that the trees has a proper canopy," D'Souza said. He also highlighted the importance of following a scientific approach to ensure the banyan tree's survival as summer approaches.

Parag Mody's expert report had recommended that future tree translocations involve qualified professionals with experience in arboriculture and ecological restoration. He also advised that trees should be gradually pruned to reduce stress and maintain an adequate canopy to support regrowth.

VERDICT IN HIGH-PROFILE K'TAKA MINING 'SCAM' ON FRIDAY

The accused also pointed to admissions made by a witness during cross-examination, asserting that the transaction involving the supply of 5,051 metric tonnes (MT) of iron ore was legitimate.

A further submission was made by another defendant on similar grounds. In response, the special public prosecutor representing the Special Investigation Team (SIT) of the Karnataka Lokayukta requested additional time to clarify details concerning the permit obtained by M/s Adarsh Enterprises, which had been used to transport the iron ore. On Tuesday, the court heard the prosecutor's arguments and ultimately dismissed the submissions made by the two accused.

The mining scam centers on the illegal transportation of nearly 17 metric tonnes (MT) of iron ore from the lease area of M/s S B Minerals, Vyasanakere plot, and other mines. The accused allegedly transported the ore to Belekeri Port without the necessary permits from the Department of Mines and Geology. The iron ore was then sold to M/s Eagle Traders and Logistics, circumventing legal royalty payments, tax collection at source (TCS), and forest way charges.

The prosecution claims that the illegal operation resulted in a financial loss of over Rs 1.5 crore to the government, while the accused reportedly made illegal profits from the scheme. The case continues to attract attention, particularly due to the involvement of a Goa Minister and his family in the alleged conspiracy.

FATE OF MOLLEM FOREST TRACT TO BE **DECIDED TODAY**

However, the government's push comes amid strong opposition from scientists, environmentalists, and activists who are urging the REC to reject the proposal and uphold the recommendations of the Supreme Court-appointed Central Empowered Committee (CEC). The CEC has opposed the project, stating that it poses a severe threat to the biodiversity of the Western Ghats, a globally recognized hotspot for wildlife. The committee has argued that the project would disrupt critical wildlife corridors within the Bhagwan Mahavir Wildlife Sanctuary and Mollem National Park, with minimal benefits to railway capacity.

In a letter to the REC, a group of scientists and researchers warned of the irreversible ecological damage that the project could cause, including habitat fragmentation, deforestation, and increased wildlife mortality due to train collisions. "This project threatens not only the fragile ecosystems of the Western Ghats but also the livelihoods and well-being of local communities that depend on these ecosystems," said Dr. Anushka Rege, a scientist specializing in landscape ecology. "Upholding the CEC's recommendation is essential for protecting both the ecological integrity and societal welfare of the region."

Dr. Sinead D'Silva, a researcher from the University of Leeds, pointed out that the project has faced consistent opposition from the people of Goa, who are deeply concerned about its environmental impacts. "If the people of Goa understand the dangers, why is the government pushing forward with it?" she questioned.

The CEC has also questioned its economic justification, pointing to the steep gradient of the existing railway line, which is considered one of the most inefficient in the country. Critics argue that the primary aim of the double-tracking is to facilitate coal transportation, despite the country's shift away from coal imports. Environmental groups also note that Goa's expanding highway network and the new Mopa airport already address the region's transport

needs, rendering the railway expansion unnecessary. As the REC prepares to make its decision, all eyes are on whether it will uphold the CEC's findings and protect the Western Ghats ecosystem or allow the forest land diversion to proceed, advancing the contentious railway

narian Wayne Pereira. **CBSE RECOMMENDS CLASS 10 BOARD EXAMS** TWICE A YEAR

"The first and second editions of the board exams will also act as supplementary exams, and no special exams will be conducted in any circumstances," the official added.

The new National Education Policy (NEP) recommended that to eliminate the "high stakes" aspect of the board exams, all students will be allowed to take the exams on up to two occasions during any given school year.

The Board has clarified that no separate supplementary exams will be conducted under this system. Instead, the second session of the Board examination will serve as the supplementary exam for those who wish to improve their

scores. "The list of candidates (LOC) will be finalised in September of the preceding year. This means that for the February 2026 exam, the list will be finalised by September 2025. No new candidates will be allowed to register for the May 2026 exam if they were not part of the September

2025 list," the official said. "Once the LOC is finalised, candidates will not be permitted to change their subjects. However, there is some flexibility in subject selection. If a candidate wishes to modify their subject choices, they can skip a subject in the first examination (February-March) and opt for a different subject in the second examination (May). However, if a candidate completes all subjects in the first exam, they will have to take the same set of subjects in the second exam if they choose to reappear," the official added.
