प्रत्यक्षात जमिनीवर उभे राहून त्याचा विरोध करतील. आम्ही न्यायालयीन मार्गाचा अवलंब करत असलो तरी, गरज पडल्यास आम्ही आमच्या शेतजमिनीसाठी प्रत्यक्ष कुती करू. जर अधिकाऱ्यांनी आमच्या जमिनीवर बेकायदा जमीन, तर आम्ही त्याचा विरोध करू आणि आवश्यक ती पावले उचलू, असे त्यांनी स्पष्ट केले. शेतकऱ्यांनी असेही स्पष्ट केले की, शासनाचे स्वतःच लागू केलेल्या पर्यावरणीय नियमांचे पालन न केल्यास, कायदावरचा लोकांचा विश्वास उडेल. एनजीटीने या प्रकल्पाची पुढील सुनावणी एप्रिल २०२५ पर्यंत पुढे ढकलली आहे. न्यायाधिकरणाच्या वेळापत्रकातील मर्यादांमुळे हा विलंब झाला आहे, मात्र, शेतकऱ्यांनी तातडीने सुनावणी घेण्याची मागणी केली आहे. दरम्यान, केंद्रीय पर्यावरण, वन आणि हवामान बदल मंत्रालय अद्याप पर्यावरण मंजूरी आवश्यक ठरेल. शेतकऱ्यांच्या संघर्ष हा केवळ त्यांच्या जमिनीपुरता मर्यादित नसून, हा पर्यावरण संदर्भित आणि पारंपरिक शैलीच्या अस्तित्वाचा लढा आहे. पुढील काही महिने या संघर्षाच्या दिशेसाठी निर्णायक ठरणार आहेत.

हेलिकॉप्टरच्या माध्यमातून पॅराशूटने सोडण्यात येईल, असे म्हणाले. उत्तराखंडचे मुख्यमंत्री पुष्कर सिंह धामी यांनी ट्विटद्वारे म्हटले आहे की, हिमस्खलनामुळे अनेक मजूर गाड्याची दुःखद बातमी मिळाली. आयटीबीपी, बीआरवो आणि इतर टीम मदत आणि बचाव कार्यात गुंतलेली आहेत. मी सर्व कामगार बांधवांच्या सुरक्षेसाठी भगवान ब्रदी विशालकडे प्रार्थना करतो. मुख्यमंत्री धामी यांनी मदत आणि बचाव कार्यसंदर्भात त्वरित उच्चस्तरीय बैठक घेत सर्व कामगाराना सुखरूप बाहेर काढण्याची सूचना केली आहे. केंद्रीय गृहमंत्री अमित शहा यांनी उत्तराखंडचे मुख्यमंत्री पुष्कर सिंह धामी, आयटीबीपी आणि एनडीआरफोचे डीजी यांच्याशी या घटनेबाबत चर्चा केली. दुर्घटनेत अडकलेल्या लोकांना बाहेर काढण्यास आमचे प्राधान्य आहे. स्थानिक प्रशासन पूर्णपणे बचाव कार्यात गुंतले आहे. एनडीआरफोच्या दोन तुकड्याही घटनास्थळी पोहोचणार आहेत, असे सांगितले. आपत्ती व्यवस्थापन विभागाने दिलेल्या माहितीनुसार हिमस्खलनात अडकलेल्या लोकांना बाहेर काढण्यासाठी मदत आणि बचाव कार्य युद्धपातळीवर सुरू असून शुक्रवारी सायंकाळी ५ वाजेपर्यंत ३२ जणांना सुखरूप बाहेर काढण्यात यश आले आहे. सतत पाऊस आणि बर्फवृष्टी होत आहे, त्यामुळे बचाव कार्यात अडचणी येत आहेत आणि त्यामुळे हेलिकॉप्टर सेवा वापरली जात नाही. हालतात करणे अवघड आहे. तेव्हा सेंट्रलाइट ड्रोन किंवा इतर उपकरणे उपलब्ध नसल्यामुळे आम्हाला त्या लोकांशी संपर्क साधता येत नाही. आतापर्यंत आम्हाला कोणत्याही जीवितहानीबद्दल कोणतीही माहिती नाही.
