MARGAO: Various Konkani organizations in Goa came together to condemn the recent incident where renowned Konkani writer Uday Bhembre was intimidated by Bajrang Dal members late on Friday night.

Addressing the media at the Konkani Bhasha Mandal (KBM) premises on Saturday evening, KBM President Ratnamala Divkar questioned the lack of action by the police or the government in filing a case against those involved or taking measures to ensure Bhembre's safe-ty. She added that they had planned to hold a protest at Lohia Maidan, given its symbolic significance to Goa's freedom struggle and other historical events, emphasizing that Bhembre had played a pivotal role in shaping Goa, be it through his contributions to the Opinion Poll or the Konkani language movement.

Due to Carnival festivities around Lohia Maidan, the group said they would hold a protest meet at the Chowgule College Junction,

Furthermore, the organizations defended SI Bhembre's recent video this on the history of Shivaji, stating that all his fund remarks were based on historical references pha and documents that are widely recognized and available in the public D domain. com

He said that when the Railway Ministry made the announcement, they referred to a new station that will come up at Sarzora. At the same time, there is talk by the Railways about constructing the station at Sao Jose De Areal.

He added that there appears to be a lack of clarity about the exact site for the new station. Nonetheless, he referred to the signature campaign carried out by the Sarzora villagers and the gram sabha held by the Sao Jose De Areal village panchayat and said he would take up these issues with the government and also ask for more information on the proposed new station plan, including all that will come up at this station. sponsible if dengue and malaria spread due to gutters overflowing with sewage on the road from residential buildings?" He stated that it is the responsibility of the Ponda Municipal Council (PMC) and local politicians to address the health hazards emerging in Jofilnagar, Ponda.

It may be recalled that the PMC had previously warned some residential buildings in Daag, Ponda, to disconnect their water connections if the sewage issue was not resolved.

According to sewerage officials, there has been a lukewarm

to obtain sewage connections to prevent action from the authorities and to help maintain cleanliness in the city. He stated that the PMC and its buildings are already connected to the sewage network, along with some hospitals. He further stressed that residential buildings should also comply and apply for sewage connections.

'Consult schools, parents before imposing National Edu Policy'

GRLA calls for conference with all stakeholders to discuss the NEP's full implementation; urges schools to offer Romi script education if they comply with NEP's mandatory mother tongue rule

MARGAO: Repeated Global Romi Lipi Abhiyan (GRLA) has voiced its support for parents in Goa regarding concerns over school timing changes and other policy shifts introduced by the State's education department under the National Education Policy (NEP). The organisation, however, argues that these adjustments are superficial and that the department must engage in broader consultations before implementing changes.

GRLA President Kennedy Afonso emphasised that the NEP grants autonomy to schools in setting their curriculum, syllabus, pedagogy, and assessment methods within the framework of the National Curriculum Framework (NCF). He asserted that the education department should not impose decisions unilaterally but instead

engage with key stakeholders, including school managements and parents.

"The NEP provides flexibility and innovation in education, allowing schools the freedom to design their own academic approach," Afonso said. "It is time for school managements to assert their autonomy and not succumb to diktats from the education department." He urged schools to demand an immediate conference with all stakeholders to discuss the NEP's full implementation and its implications for Goa's education system.

One key aspect of the NEP is its emphasis on education in the mother tongue or local dialect up to the fifth standard. GRLA has therefore called on the education department to introduce Roman script Konkani as an optional subject

alongside Devanagari, stating that the policy allows schools to make such decisions independently. Afonso also urged diocesan school authorities to take the initiative in offering Roman script Konkani, as the education department has no authority to prevent it.

The organisation highlighted that the NEP promotes a flexible learning environment where students can explore multiple subjects based on their interests. "It is essential that students are given the opportunity to learn in the script of their choice, ensuring linguistic inclusivity in Goa's education system," Afonso said.

GRLA has reiterated its demand for a comprehensive review of the NEP's implementation in the state, stressing that policies should be framed only after thorough discussions with all stakeholders.
