

Tension in Porvorim, sacred banyan tree cut 'mercilessly'

Residents force authorities to stall the removal & relocation of Lord Khapreshwar's idol; fear translocation exercise could damage the temple adjacent to the tree; commotion leads to traffic congestion

PANJIM: Tension rent the air at Vodakade, Porvorim, as the authorities "mercilessly" chopped the 200-year-old sacred banyan tree on Sunday to go ahead with six lane elevated corridor work, with the residents forcing the government to take a back seat and stall the removal and relocation of the Lord Khapreshwar's idol.

As per the court order when the officials of Public Works Department (PWD) officials and police arrived to commence the translocation of the tree, activists and local residents gathered at the site, as they feared the exercise could damage the Khapreshwar Temple adjacent to the tree.

Social activist Swapnesh Sherlekar confronted the PWD officials and police, warning them of grave consequences if the temple's dome was harmed.

He asked: "How can workers remove the idol in the absence of mamlatdar when the order for razing

POOJA BEFORE RELOCATION

Emotions ran high among Porvorim residents as later in the evening, the 'pooja' of Lord Khapreshwar also known as the Rakhandar (protector) was performed before relocating the idol to another location.

According to the temple priest, the idol will be relocated near a four-wheeler showroom.

Four more bodies recovered from U'khand avalanche site

PTI, DEHRADUN: The bodies of the last four of the trapped labourers were pulled out from the site of the avalanche-hit Border Roads Organisation (BRO) camp in Chamoli on Sunday, taking the death toll to eight as authorities ended the nearly 60-hour rescue operation.

Army doctors said 46 workers who were rescued on Saturday have been brought to the military hospital in Jyotirmath. Two of them have been referred to AIIMS, Rishikesh. Three of the workers are in critical condition, Lt Col DS Malhdya said.

The body of the last missing worker has also been retrieved. The recovery marks the culmination of the Mana Village Rescue operation, Defence Public Relations Officer (PRO) Lt Col Manish Shrivastava said.

Court orders FIR against ex-SEBI chief Madhabi Buch, 5 others

Judge says there is prima facie evidence of regulatory lapses & collusion, requiring a fair probe

PTI, MUMBAI: A special court here has directed the Anti-Corruption Bureau (ACB) to register an FIR against former Securities and Exchange Board of India (SEBI) chairperson **Madhabi Puri Buch** and five other officials in connection with alleged stock market fraud and regulatory violations.

There is prima facie evidence of regulatory lapses and collusion, requiring a fair and impartial probe, the special ACB court judge, Shashikant Eknathrao Bangar, said in the order passed on Saturday. The court said it will monitor the probe and sought a status report within 30 days.

The SEBI in a statement said it "would be initiating appropriate legal steps to challenge this order and remains committed to ensuring due regulatory compliance in all matters".

The SEBI said the application, which sought directions to the police to register an FIR and investigate alleged irregularities in granting listing permission to a company on the Bombay Stock Exchange in 1994, was allowed by the court "even though these officials were not holding their respective positions at the relevant point of time".

Smart City works blow up dust, leave Sao Tome houses red
