# Nepal's FM assures justice for student's death in India

PTI, KATHMANDU: Nep-Prakriti, a third-year B Tech (Computer Science) student alese Foreign Minister at Kalinga Institute of Industrial Technology (KIIT) in Arzu Rana Deuba Monday Odisha, was found dead in her hostel room last month, met the parents of Prakriti Lamsal and assured them that the government is making every possible ef-

fort to ensure justice. Prakriti, a third-year B Tech (Computer Science) student at Kalinga Institute of Industrial Technology (KIIT) in Odisha, was found dead in her hostel room last month, leading to unrest on the campus.

She allegedly died by suicide under circumstances that her family and authorities are currently scrutinising. Around 1,000 Nepalese

KIIT, Odisha. Foreign Minister Deuba and Home Minister Ramesh Lekhak visited the home of the parents of Prakriti in Bhairahawa to extend condolences, according to the Foreign Minister's secre-

Rana assured Prakriti's family that the Nepali government is making every possible effort to ensure

She said that her minis-

try took the diplomatic initiative to find out the facts relating to the death of Prakriti and to punish the

culprits. Prakriti will get justice, the minister added.

She also recalled her conversation with Odisha Chief Minister Mohan Charan Majh. She urged him to punish the culprit by finding the facts and resumption of studies of the Nepalese students studying at KIIT.

Odisha's chief minister has said that they have taken the matter seriously and works have started to find the truth about the incident and to provide justice to Prakriti, she said.

The Foreign Ministry is working by keeping close contact with the Odisha government, the University administration and the Indian security agency regarding the matter, she reminded.

Following the incident, Nepalese students studying in the college organised a protest rally, demanding a probe into the incident.

#### Mexico makes case to avoid US tariffs as it awaits Trump's decision

AP, MEXICO CITY: Mexico President Claudia Sheinbaum said Monday that her administration is waiting to see if US President Donald Trump makes good on his threat to impose 25% tariffs on Mexican imports.

Her Cabinet secretaries for security and trade among others have been in constant communication with their US counterparts and she said there was still the possibility she and Trump would speak Monday.

Trump had threatened to impose tariffs in February before suspending them at the last minute, when Mexico sent 10,000 National Guard troops to their shared border to crack down on drug trafficking and illegal immigration.

"It's a decision that depends on the United States government, on the United States president," Sheinbaum said. "So whatever his decision is, we will make our decisions and there is a plan

and there is unity in Mexico." Mexico believes it has made a strong case. The number of migrants arriving at the US border is the

lowest it has been in years. Last week, Mexico sent 29 drug cartel figures, including the man involved in the 1985 killing of a DEA agent, to the United States.

Security forces have dismantled more than 100 synthetic drug labs in Sinaloa, and systematically weakened the two main factions of the cartel by the same name.

### Bangladesh's top court upholds Khaleda Zia's acquittal

Zia, 79, was convicted in

PTI, DHAKA: Bangladesh's Supreme Court on Monday upheld a High Court ruling that acquitted former premier and BNP chairperson Khaleda Zia in a corruption case in which she was sentenced to seven years in jail by a lower court.

A three-member Appellate Division bench headed by Justice Md Ashfaqul Islam passed the order, dismissing the plea filed by the state and the Anti-Corruption Commission challenging the High Court verdict that acquitted Zia and others, the state-run BSS news agency reported.

Zia, 79, was convicted in the Zia Charitable Trust corruption case in 2018 by a Dhaka court. The court sentenced her to seven years imprisonment and fined her Taka 1 million.

On November 27 last year, the High Court allowed two separate appeals filed by Zia and two other convicts, Ziaul Islam and Monirul Islam Khan, challenging the the Zia Charitable Trust corruption case in 2018 by a Dhaka court. The state and the ACC filed the plea, challenging the High Court ruling.

That matter came to the Appellate Division's regular bench for hearing and the apex court passed its order on Monday, the news agency reported. The graft case filed in

2011 by the Anti-Corrup-Commission with tion Tejgaon Police Station accused Zia and three others of abusing power to raise funds for the trust from unknown sources.

Zia now stands acquitted in both the Zia Orphanage Trust and Zia Charitable Trust cases, in which

she had previously been convicted and sentenced, Maksud Ullah, a lawyer for the BNP chairperson, was quoted as saying by The Daily Star newspaper.

The Bangladesh Nationalist Party (BNP) chairperson was lodged in the Old Dhaka Central Jail on February 8, 2018, after the Dhaka court sentenced her in the Zia Orphanage Trust corruption case.

During the COVID-19 outbreak, the Sheikh Hasina-led Awami League government temporarily released Zia from jail after 776 days through an executive order, suspending her sentence on March 25, 2020, with conditions that she would stay in her house and not leave the country.

#### **EU** condems Hamas's refusal to accept ceasefire

AFP, BRUSSELS: The European Union said Sunday it condemned what it called Hamas's refusal to accept the extension of the first phase of a Gaza ceasefire agreeadding Israel's subsequent aid blockade "risked humanitarian consequences".

"The EU calls for a rapid resumption of negotiations on the second phase of the ceasefire, and expresses its strong support to the mediators," Anouar El Anouni, the spokesperson for EU foreign affairs and security policy, said in a statement.

"A permanent ceasefire would contribute to the release of all remaining Israeli hostages while ensuring the necessary conditions for recovery and reconstruction in Gaza to begin," El Anouni said, adding "all parties have a political responsibility to make this a

#### **J&K Assembly resolution** on special status not rejected: CM Abdullah

PTI, JAMMU: The resolution on special status passed by the Jammu and Kashmir Assembly in its first sitting last year has not been rejected by the Central government which is a big thing, Chief Minister Omar Abdullah said on Monday and asserted that there was no need to bring any other resolution on Article 370, which was abrogated in August 2019.

The chief minister said all legislators need to work together to help the government to fulfill its priorities for public welfare.

What we have to do was done in the first (assembly) session (in November, 2024). The resolution is still holding after passed by the House. The PDP and others helped us in passing the resolution and it is still holding is a big thing, Abdullah told reporters outside the assembly here while responding to a question that some members are planning to bring a fresh resolution to condemn abrogation of Ar-

The 40-day Budget Session of the Jammu and Kashmir Assembly, having a total of 22 sittings, began on Monday with Lieutenant Governor Manoj Sinha's address. The chief minister said some people were thinking that any resolution on special status will get outrightly rejected by the Central government.

The resolution was not rejected and the fact of the matter is that it is still holding so there is no need to talk further on this, he said.

The Jammu and Kashmir Assembly passed a resolution on November 6, asking the Centre to work out a constitutional mechanism for restoring special status of the erstwhile state.

Abdullah said the National Conference will not repeat what it had already done.

The chief minister said the House will meet on Tuesday to discuss the lieutenant governor's address and the members are free to raise their issues in the House.
