## **MISSING 11-YEAR-OLD FOUND AT CALANGUTE BEACH**

CALANGUTE: An 11-year-old boy from Punjab who went missing in the crowd at Calangute beach was successfully located by lifesavers. After an extensive search operation, the child was found and safely reunited with his family following proper identification. In a separate incident, a 29-year-old man from Ahmednagar panicked after being struck by a wave while swimming at Calangute beach. Lifesavers swiftly rescued him using a rescue tube.

## **DHAVALIM HILL BURNS, CASHEW** AND OTHER TREES GUTTED

PONDA: Cashew and other trees were reduced to ashes following a major fire atop a hill at Dhavalim on Wednesday. The locals commuting along the Dhavalim four-lane highway noticed the hill opposite the Bhagawati temple on fire and immediately contacted the fire brigade. A team rushed to the spot



at 5 pm, but could not control the blaze as there was no access to the hill.

The local complained that the trees atop the hill were felled and suspected that they were set ablaze by vested interest. They said these wild animals have been left with no shelter and now have no option but to stray into the town and residential areas.

The locals later recorded a video which later went viral on social media.

Constant digging of Gogol roads causes inconvenience to locals

MARGAO: Just as residents of Gogol Housing Board and Vidhyanagar were recovering from the chaos caused by road digging for sewerage pipelines, a fresh round of excavation has begun-this time for the installation of underground pipelines to supply piped natural gas to households.

Residents allege that these continuous developments have led to an increase in civic issues, including frequent disruptions in electricity and water supply, as well as severe traffic congestion.

"It has become extremely difficult to step out of the house due to this never-ending development work, first for sewerage pipelines and now for piped natural gas," a resident complained. "The dust pollution has worsened, forcing us to keep our doors and windows closed."

Mahesh Naik, a resident, expressed frustration over the slow pace of work.

"The ongoing pipeline installation has led to significant dust pollution and traffic congestion and frequent power and wa-

Naik and added that on Tuesday, there was no water supply throughout the day at the Housing Board, causing immense hardship for residents.

Another resident, Mangal Das Raiker, noted that the sewage pipeline work began last year but remains incomplete, with road digging still ongoing

as. "Traffic jams have become cles," he said.

He further added that roads have been cut in the middle and filled with mud instead of being properly covered with cement. 'We pay road tax, yet roads in several parts of Salcete village have deteriorated due to constant digging and cutting. This issue needs urgent attention," he emphasised.

Senior citizen Laximan Naik expressed concerns over severe traffic congestion, particularly during peak hours, as buses and other vehicles struggle to navigate the narrowed roads. "Commuters are not only facing dangerous driving conditions but also dealing with delays that affect their daily work," he remarked.

Meanwhile, residents have urged authorities to carry out road digging in phases, ensuring that roads are restored patch by patch wherever excavation takes place. They have also suggested widening the roads, as the continuous digging has reduced their width, further worsening traffic conditions. Additionally, residents have called for proper deployment of traffic police to manage vehicle movement and prevent further chaos.

This is not the first time Siddiqui has exposed weaknesses in the system. On a previous occasion, while in judicial custody, he managed to speak directly to a news channel from his mobile phone, alleging police brutality.

The Goa Police and prison administration faced backlash for failing to prevent the security breach. Despite these past failures, Wednesday's event demonstrated that serious lapses continue to plague law enforcement in the State.

During his court appearance in Altinho, Siddiqui openly handed over documents to the media, claiming they were addressed to the judge. Senior police officials were left scrambling after the letter's contents – containing serious accusations against Chief Minister Pramod Sawant, Deputy Speaker Joshua D'Souza, and senior police officers – began circulating in the public domain.

The letter also reiterated his demand for the CBI to take over his case, alleging bias and misconduct by Goa authorities.

Defending the police's reaction, SP Kaushal argued that any official communication should have been directly submitted to the court. not the media.

"If Siddiqui wanted to submit documents, he should have handed them over through legal channels. If he gave them to the media, it was their responsibility to ensure they reached the authorities," said SP Kaushal.

However, the fact that an accused with a history of security breaches was able to outmanoeuvre law enforcement yet again underscores the lack of discipline and protocol enforcement within the Goa Police.

The incident raises serious doubts about the State's ability to handle sensitive cases and safeguard judicial procedures from external influence and manipulation.

With allegations against top officials now in the spotlight, the question remains: Will this latest embarrassment prompt real reform, or will it fade into vet another example of lax governance and law enforcement failure in Goa?

## **POLITICAL SLUGFEST AFTER MAD-KAIKAR'S BRIBERY CHARGE ON STATE MINISTER**

"Former minister Pandurang Madkaikar was called by BJP National General Secretary B L Santosh. After the meeting, Madkaikar claimed that ministers of the BJP government were taking money and he himself had to pay Rs 20 lakh for clearing a file. An FIR should have been filed immediately either by Panjim Police or Crime Branch. Why was it not done?" he said.

Palekar added that after Pandurang's statement, "the Vigilance Department or Anti Corruption Bureau (ACB) should have been activated to find out who the minister is and an FIR should have been filed under Prevention of Corruption Act. His statement should have been recorded immediately to know who the minister is."

AAP leader Francis Coelho alleged that the BJP uses the law to suppress dissent, creating a message that anyone joining the party can act with impunity.

The Goa Pradesh Congress Committee leadership echoed these concerns, calling the current government the most corrupt in the state's history and questioning whether Madkaikar, as a former minister, was unaware that giving bribes is a crime and demanded that he reveal the name of the minister involved.

In response, Transport Minister Mauvin Godinho challenged Madkaikar to name the minister who allegedly demanded the bribe. "If he has the guts, Madkaikar should file a police complaint. He is an ex-minister and he should behave responsibly. Those who live in glass houses shouldn't throw stones on others," Godinho said.

## ATTACKED BY PATIENT IN US, **INDIAN-ORIGIN NURSE COULD TURN BLIND**

WPTV said it received a video from a viewer that showed the suspect walking shirtless on a nearby prominent road with what looked to be ECG leads still attached to his chest, and it also showed hospital staff and law enforcement following the man onto the busy highway before the deputies took him into custody.

The probable cause affidavit filed by law enforcement described Lal's injury as "critical" and said, "Essentially every bone in the victim's face is broken and the victim is likely to lose the use of both eyes.

Because of the extent of the victim's injuries, she was unable to provide a statement to investigators, the WPTV said.

Another WPTV report about the court proceedings on February 27 said that witnesses from the hospital, as well as responding deputies, took the stand and revealed that video from inside the hospital showed the victim was attacked in a roughly one to two-minute time frame.

"Following the attack, Palm Beach County Deputy Sgt Beth Newcomb testified that she observed Scantlebury saying, 'Indians are bad' and 'I just beat the (expletive) out of an Indian doctor'," it added.

## **TRUMP WARNS OF RECIPROCAL TARIFFS ON INDIA FROM APRIL 2**

Both sides made firm commitment to boost the overall trade and India hopes that a mutually-beneficial outcome will emerge on the issue of tariffs, the people cited above said as New Delhi looks at navigating the trade landscape with the Trump administration.

Commerce Minister Piyush Goyal is in Washington this week to hold talks with his American counterpart, Howard Lutnick, and US Trade Representative Jamieson Greer on the proposed deal.

There is an expectation in New Delhi that it may escape the reciprocal tariffs being imposed by the Trump administration on February 2.

## **ACTOR HELD WITH GOLD WORTH** RS 12.56 CR AT B'LURU AIRPORT: DRI

"Acting on specific intelligence, DRI officers intercepted an Indian woman, aged around 33, who had arrived from Dubai to Bengaluru on an Emirates flight on March 3. Upon examination, gold bars weighing 14.2 kg were found ingeniously concealed on her person." the statement read.

The DRI operates under the Ministry of Finance.

According to the Ministry, the contraband, valued at Rs 12.56 crore, was seized under the provisions of the Customs Act, 1962.

"Following the interception, DRI officers searched her residence on Lavelle Road, Bengaluru, where she lives with her husband. The search led to the seizure of gold jewellery worth Rs 2.06 crore and Indian currency amounting to Rs 2.67 crore," the statement added.

The Ministry further stated that the woman had been arrested under the relevant provisions of the Customs Act, 1962, and remanded to judicial custody.
