EC to resolve decades-long duplicate voter ID issue in 3 months

PTI, NEW DELHI: Amid allegations of a cover-up over duplicate voter identity card numbers, the Election Commission (EC) on Friday said it will address the "decades-long" matter in the next three months.

The Trinamool Congress (TMC) MP Saket Gokhale said the Election Commission has finally admitted and accepted their guilt that duplicate Electoral Photo Identity Card (EPIC) numbers have been allotted to multiple people.

"This is a scam and answers must be given," he

posted on X.

In a statement, the poll authority said India's electoral rolls are the biggest database of electors across the globe with over 99 crore registered voters.

"As regards the issue of duplicate Electoral Photo Identity Card numbers, the Commission has already taken cognisance of the matter. Irrespective of an EPIC number, an elector who is linked to the electoral roll of a particular polling station can cast his vote at that polling station only and nowhere else," it asserted.

The poll authority said it has now decided to resolve this "long-pending issue" after detailed discussions within the

technical teams and concerned state chief electoral officers in the next three months by ensuring a "unique national EPIC number" to the existing electors having a duplicate EPIC number. The new system will be applicable for future electors as well, it added.

Explaining the procedure related to the updation of electoral rolls, the EC said at every booth, political parties also have the right to appoint booth-level agents (BLAs) who have a right to verify the electoral roll of the concerned booth and raise a complaint for the anomaly, if any.

If any person has any objection, he has the option to file the first appeal

to the district magistrate or district election officer under section 24(a) of the Representation of the People (RP) Act, 1950.

If the person is not satisfied with the decision of the first appellate authority, a second appeal to the Chief Electoral Officer of the concerned state or Union Territory (UT) under section 24(b) of the RP Act can be filed.

Data shared by the poll authority showed that across the country, 89 first-level appeals and one second-level appeal were made in Maharashtra and no other state.

EC functionaries pointed out that no appeals were filed in West Bengal.

India demands action against those involved in Jaishankar's security breach in London

PTI, NEW DELHI: India on Friday pressed the UK to take action against the pro-Khalistan elements involved in the breach of External Affairs Minister S Jaishankar's security in London and said the incident showed the "licence" accorded to such forces as well as "indifference" to their "intimidation and threats".

A pro-Khalistani protest attempted to break barricades while some others were shouting anti-India slogans as Jaishankar was leaving the Chatham

House after concluding an interactive session at the institute on Wednesday evening.

External Affairs Minister spokesperson Randhir

Jaiswal suggested that the sincerity of the British authorities over the incident would be measured on the action they take against the culprits involved.

Telangana CM slams BJP for revenge politics, seeks all-party meet on delimitation

PTI, NEW DELHI: The BJP is pursuing "revenge politics" against the southern states through the proposed delimitation exercise, Telangana Chief Minister Revanth Reddy alleged on Friday and urged the Centre to convene an all-party meeting to discuss the issue.

Speaking at the India Today Conclave in the national capital, he claimed that the BJP wanted to reduce south India's parliamentary representation through the delimitation of parliamentary seats, which would adjust constituencies based on population

tion. The BJP wants to finish the south through this exercise that will benefit only the northern states," the Congress leader said.

Calling it a political issue requiring broader consultation, Reddy said, "An all-party meeting should be called to discuss the matter in detail. Not only the southern states but others like Punjab can express their views."

He argued that the southern states should not be penalised for successfully implementing population control meas-

ures, adding that the delimitation exercise would disproportionately benefit states such as Bihar and Uttar Pradesh.

Echoing his Tamil Nadu counterpart MK Stalin, the Telangana chief minister said the delimitation exercise should be based on the 1971 Census.

"Family planning implementation was the Centre's plan. What it said, we implemented. Let the Centre freeze delimitation for the next 30 years and see the growth in population of the southern states,"

Reddy said.

He explained that if Uttar Pradesh's parliamentary seats were increased on a pro-rata basis by 50 per cent, it would have 120 seats. "For Tamil Nadu, the number of seats will stand to be 60 if increased on a pro-rata basis. The difference will be 60 seats."

Uttar Pradesh currently has 80 seats in the Lok Sabha while Tamil Nadu has 39.

Reddy's remarks come at a time Stalin has ramped up his criticism of the Centre on the proposed exercise.

On Friday, Stalin wrote to chief ministers of seven states, including Reddy, to form a joint action committee against the delimitation exercise.

IFS officer battling depression ends life by jumping from building in Delhi

PTI, NEW DELHI: A 2011-batch Indian Foreign Services officer ended his life by jumping from the fourth floor of a residential building in the Chanakyapuri area here on Friday, and no foul play is suspected, police said.

According to police, the officer -- Jitendra Rawat, 42 -- is survived by his wife, two sons, aged eight and 13 years, mother and father. He was a director at the Overseas Employments and Protectorate General of Emigrants in the Ministry of External Affairs, they said. He has also served at the Indian embassies in Belgium, Myanmar and Japan.

A senior police officer said Rawat, a native of Dehradun in Uttarakhand, was

undergoing treatment for depression. His 70-year-old mother was staying with him in his house at the MEA Residential Complex near the Bangladesh High Commission.

"He was staying on the first floor. At around 6 am on Friday, he went to the fourth floor of the building and jumped. We have not recovered any suicide note from the spot," the officer said.

Police received a PCR

call about the incident at 6.20 am from the security guard of the residential complex. The officer was taken to a hospital, where he was declared dead.

Police said they would talk to Rawat's family members and neighbours to ascertain the reason that forced him to take such an extreme step.

Rawat got married in 2009, and his wife and children are staying in Dehradun, police said.

"Rawat's body was handed over to the family at 4.30 pm after the postmortem at the RML Hospital," another police officer said, adding that the family members were living in Dehradun because his children were studying there.

"The officer had no family dispute and had been battling depression since he came back from his posting in Belgium 10 months ago. Rawat has been residing in Delhi since then," the officer said.

Rawat's father is a retired government official and was staying with his daughter-in-law and grandchildren in Dehradun.

Police also said that when Rawat was posted in Belgium, his wife was with him there.

A witness said he was outside the building complex when he heard a loud noise. "We rushed inside and saw the officer's body lying on the ground," he said.
